ADVOCACY - THE LEAGUE ADVOCATES INDEPENDENTLY AND WORKS IN COALITION WITH OTHER ADVOCACY ORGANIZATIONS ON BALLOT MEASURES AND LEGISLATION. FROM JULY 2022 TO JUNE 2023, 2 OF THE BILLS WE SUPPORTED WERE CHAPTERED INTO LAW; 32 BILLS WE SUPPORTED EITHER DIED OR WERE MADE INTO TWO-YEAR BILLS. WE OPPOSED 2 BILLS; ALL OF WHICH EITHER DIED OR WERE MADE INTO TWO-YEAR BILLS. FOR A FULL REPORT ON OUR LEGISLATIVE ADVOCACY, SEE BIT.LY/BSRLIST. IN NOVEMBER 2022, THE LEAGUE ADVOCATED IN SUPPORT OF 2 MEASURES ON THE BALLOT, BOTH OF WHICH PASSED. SOME OF THE LEGISLATION WE SUPPORTED INCLUDED: AB 256 (KALRA, 2022) TO MAKE THE PROVISIONS OF AB 2542 RETROACTIVE; AB 2841 (LOW, 2022), WHICH BUILT SAFEGUARDS TO PREVENT ERRONEOUS VOTER REGISTRATION PURGES AND PROTECT THE VOTING RIGHTS OF PEOPLE WITH DISABILITIES UNDER CONSERVATORSHIP; ACA 4 (BRYAN), A CONSTITUTIONAL AMENDMENT TO RESTORE VOTING RIGHTS TO PEOPLE WHO ARE CURRENTLY INCARCERATED.
