## WOMEN MARCH, ACT, VOTE

Members came to the League office to make posters for the Jan. 19 St. Louis Women's March. The League sponsored the march to let women of all races and religions know about the League's work to educate and empower voters. Louise Wilkerson staffed a table at the Action Fair and Kathy Kane carried the banner.

Attendees also filled out postcards to send to their Missouri legislators asking them to Respect Missouri Voters and uphold all the legislative reforms in Amendment 1. Come by the office to pick up post cards. Contact info for elected officials is available at www.lwvstl.org.

The new year is certainly underway, coming in like a lion. As we look ahead and prepare for the upcoming months, I am reminded of two things: First, things will change and second, things will never go exactly the way we wish. With the legislative session underway, we are seeing old issues revisited, new issues appear and issues we thought were settled become unsettled. Our priorities never change as they keep reappearing! So, our issue committees are continuing their studies and advocacy. The Policing Committee has two new co-chairs, so they will be setting up a meeting date and time soon. Health Care, Education,

Environmental Quality, Early Voting and National Popular Vote are studying, planning and advocating for their issues. They would all welcome new members.

Our Amendment 1 task force is starting the push back to the Missouri legislature and governor for their non-acceptance of the Amendment 1 election results. Last Friday in the office, members and guests created signs to carry in the St Louis Women's March 2019 and they wrote postcards to legislators requesting respect for the decision of the voters. In every senatorial district in Missouri, the majority of voters approved Amendment 1 to clean up the Missouri Legislature. And yet, during the first week of the 100<sup>th</sup> Legislature, the Missouri House of Representatives voted to exempt themselves from the Sunshine Law requirements of Amendment 1. We need to be reminding them of the votes of their constituents and reminding the voters of what their legislators think of their opinions. If you would like to write a postcard or ten, call the office to make sure we have copies ready and then drop by to write some or pick them up. Take them with you to other groups: your committee, your units, your friends; I'm taking them to

Another big effort is preparations for this Centennial Year. See the flyer on Page 8 for details. The 100 Club for 100 Years is growing in membership at 55+ right now. Join us and show your support for the Centennial. Events begin with the important fundraiser Trivia Night on February 15 and continue through August 2020.

Several coalitions of organizations committed to protecting voter rights, expanding accessibility to the voting process and working toward restoring the 1965 Voting Rights Act are meeting in the next month to plan events and strategies. We will keep you posted.

During the winter months, local Leagues gather input and identify which issues should be included in the new program for 2019-2020 at the local level and 2019-2021 at the state level. In the Metro league, Kirkwood/Webster Groves, Creve Coeur/Chesterfield, South County, North County units and a small group from University City/Clayton met and discussed their recommendations. It is hoped that a larger group from U. City/Clayton and the St. Louis City unit will be able to add their voices to the discussion before the board meets to make the final recommendations for the membership to consider in April for Metro and May for Missouri.

Nomination committees for the board of directors for Missouri and Metro are also finalizing the slate for elections at the meetings in April and May. The committees' recommendations will go to the existing boards for approval before being placed before the membership.

## LET US RAISE UP A LEAGUE OF WOMEN VOTERS

Carrie Lane grew up in Wisconsin and graduated from Iowa State College (now University). She was a high school principal in Mason City for two years before becoming superintendent of schools, one of the first women to hold such a position. Her first marriage to Leo Chapman, an editor, ended with his untimely death in 1886. From 1887 to 1890 she organized the Iowa Woman Suffrage Association. In 1890 she was an Iowa delegate to the National American Woman Suffrage Association (NAWSA). That was the first meeting after the merger of the National Woman Suffrage Association and the American Woman Suffrage Association. That same year, she married George W. Catt with a prenuptial agreement providing her with four months of free time each year to work exclusively for woman suffrage. George Catt encouraged and supported his wife's dedication until his death in 1905, at which time he left her financially independent to devote the rest of her life to reform activities.

NAWSA used her vibrant voice and forceful ideas as an organizer and leader. Presidential candidate Woodrow Wilson did not endorse the

federal suffrage amendment, but accepted Catt's invitation to the 1916 convention and told the delegates the suffrage movement "has not only come to stay, but has come with conquering power." At the time, women in 12 states had at least presidential suffrage.

At NAWSA's 50<sup>th</sup> Anniversary Jubilee Convention in St. Louis in 1919, she suggested to fellow suffragists, "Let us then raise up a league of women voters." She challenged the women to stay on the battlefield as an army of citizens to "finish the fight" for needed changes in customs, laws and education.

A year later, at the 1920 Victory Convention in Chicago, NAWSA voted to reconstitute NAWSA as the League of Women Voters, an ongoing organization to secure political education and improved legislation.

Retiring after passage of the 19th amendment, Catt served as honorary president until her death in 1947.

#### **GIVE OUR NATIVE POLLINATORS A HELPING HAND**

When you hear the word pollinator, the honey bee is probably what first comes to mind, but the honey bee, an introduced species to the U.S., is largely managed by commercial and hobbyist beekeepers today. On the other hand, there are over 470 native species of bees found within Missouri alone, including leaf-cutter, mason and bumble bees. Honey bees pollinate crops, but our native pollinators not only have a role in agriculture, they also are important pollinators of our gardens and natural habitats. Some studies have shown that native pollinators are better at the job than honey bees. The solitary bees do not make honey, so they predominantly collect pollen and not nectar to take back to their nest.

Native pollinators are also susceptible to decline and die-out due to pesticides, lack of habitat and nutritional sources, and disease, and they are not managed to mitigate those losses, as honey bees are, for example, by splitting hives and breeding hardier queens.



We can help our native pollinators by planting gardens with plants and trees that bloom throughout the growing season and that vary in size and shape, since native pollinators tend to be "specialists" visiting only certain kinds of blossoms. Also, we can provide nesting habitats for bees, such as bare ground for digger and sweat bees and wood and dried plant stems for leaf-cutter and carpenter bees. Some four to seven species of native pollinators do not make their own nests, but instead rely on found holes. You can purchase a bee habitat to provide appropriate nesting holes to attract them. They can be found in hardware stores and seed-and-feed stores. I've purchased <u>Bee Barns</u> from <u>www.isabees.com</u>. Put them out when the forsythia blooms and store them in your unheated garage when the temperatures drop. For the most part, native bees are solitary and do not share their nests (or holes). Because they do not have a large hive to defend, they are not aggressive and will not sting if you approach their nesting site.

#### **DID YOU KNOW?**

LWV Metro STL has joined several coalitions working on regional environmental issues. The League is one of 15 groups that comprise the MSD Rate Commission that makes recommendations to the Metropolitan Sewer District (MSD) Board of Trustees regarding all proposed changes in wastewater rates, storm water rates and tax rates or the change in the structure of any of the foregoing rate. Mickey Croyle is the League delegate. Watch for upcoming information on the Proposition S for the April 2 ballot in the March ILR. At the January meeting, the LWV Metro STL board voted to support Proposition S using our Natural Resource Positions on waste management, water quality and sewer.

The League is an active member of the Missouri Clean Energy Coalition with two recent successes: Energy Efficient Building Codes for the City of St Louis and a St. Louis City pledge to become 100% Clean Energy. Working with Missouri Coalition for the Environment and other groups, the League testified to the EPA on the West Lake Landfill.

Mary Archer serves on the St. Louis County's Commission on Solid Waste Management and Missouri Recycling Association (MORA). Many League members are active with the Sierra Club. Several EQ members serve on environmental and recycling committees for their churches.

## SUPPORT EARLY VOTING

The League's Early Voting Committee discussed several ways to make it easier for Missouri citizens to vote. Members agreed to advocate for no-excuse absentee voting.

Rep. Peter Merideth (D-80) is sponsoring HJR5 to create an early voting period and add satellite voting sites. Voting could be in- person or by mail starting the sixth Tuesday prior to election day. His bill would also allow automatic voter registration.

#### **VOTER PLEDGE CARDS WELL RECEIVED**

League volunteers have very recently begun asking newly registered voters to fill out "Pledge to Vote" cards on which they give us either their email or a phone number. They agree to have the League of Women Voters send them three reminders before an election.

The correspondences will direct new voters how to go about checking their voter registration in time to re-register if needed. Closer to election time, reminders will provide access to vote411 and encourage them to vote.

After the last two naturalization ceremonies, over 75% of the newly registered citizens filled out our new cards.

### JOIN THE LEAGUE'S 100 CLUB

To celebrate the League's centennial and kick off the next century, the League would like to invite you to join the Hundredth Anniversary Hundred Dollar Club. Club membership is a \$100 taxdeductible donation to the League. Members get a special reduced rate at two upcoming events: a March 24 tea and a May 2 Suffragist Tour of Bellefontaine Cemetery.

The guest speaker at the Centennial Tea at the St. Louis Woman's Club is former First Lady and U.S. Senator Jean Carnahan who will reflect on the changing role of women in Missouri politics. Cost is \$30 or \$15 for Club members.

Cemetery Guide Mary Ellen Vander Linden will give a presentation dressed as Edna Fischel Gellhorn, the first president of LWVMO and three-term president of the St. Louis League. Other suffragists buried at Bellefontaine Cemetery in North County include Virginia Minor (the first president of Missouri's Woman Suffragette Association), Rebecca Naylor Hazard (an abolitionist and part of the Women's Congress) and Phoebe Couzins (an electrifying speaker who traveled across the country with Susan B. Anthony to promote women's suffrage). There will be two one-hour tours as well as refreshments. Cost is \$20 or \$10 for Club members.

The Centennial Committee is also working to display our life-size suffragist cut-out in several area libraries with educational bookmarks on the battle for women's suffrage. Other Centennial events include a costume parade by the Repertory Theatre of St. Louis during the LWVMO state convention May 3-4 and a banquet in November to honor past League leaders.

Illinois became the 37th state to ratify the Equal Rights Amendment in 2018. The Virginia Senate recently approved ERA legislation, but it's not expected to pass the House. Various groups around Missouri are

actively working on ratification of the ERA, including the *Springfield Missouri Feminists*.

Rep. Judy Morgan from Kansas City (D-HD24) introduced HCR12 which "establishes Missouri's ratification of the Equal Rights Amendment to the United States Constitution." The bill had a Second Reading, and awaits a Committee Assignment.

Senator Jill Schupp (D-SD24) again introduced ERA legislation. SCR 7 was referred to the Rules Committee which held a hearing last year. SCR7 could move quickly.



"Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex."

Ask your legislators to cosponsor and support these resolutions. As U.S. Supreme Court Justice Ruth Bader Ginsburg explains, "The Equal Rights Amendment means that women are people of equal stature before the law. I think we have achieved that through legislation but legislation can be repealed, altered. That principle belongs in our Constitution. It is in every Constitution written since World War II."

Suffragist Alice Paul wrote the language and ERA resolutions were introduced in every session of Congress beginning in 1923. The ERA finally passed the House by a bi-partisan vote of 354 to 23 in 1971, and a bi-partisan vote in the Senate of 84 to 8 in 1972. Three-fourths of the states (38) are needed to ratify.

#### **DEATH PENALTY LEGISLATIVE REPORT**

Two anti-death penalty bills have been introduced in this session of the Missouri legislature. Senate Bill 32 was introduced by Senator Paul Wieland (R-22) and House Bill 64 by Representative Sarah Unsicker (D-91). The bills will abolish the death penalty with a maximum sentence of life imprisonment without parole. Anyone sentenced before August 18th may not be sentenced to death. These bills have been assigned to committee. Similar bills have been introduced annually for many years. Unfortunately they never made it to the floor, but got pretty close one year.

#### **ED REFLECTIONS**

2019 is looking to be an exciting year as we celebrate the 100<sup>th</sup> Anniversary of both the Metro St. Louis League and LWV of Missouri. League history includes many great stories we hope to share with the public. I've had a brief peek at the League archives stored at the University of Missouri-St. Louis and hope to update those archives with files from the last few decades.

We're also looking to modernize for the League's second century using the \$10,000 grant from the Roblee Foundation. The first step was purchasing 10 iPads to use for voter registration. Next we're looking at possible updates for the phone and email systems as well as improving the League's web sites.

The biggest change to the office will come at the end of February when Julie Behrens retires. She truly is a Jill -of-all-trades who has been a great asset to the League.
