PROPOSED LWVSC POSITIONS ON VOTING MACHINES

The following consensus questions will be considered by each local league, with responses due back to Shiela Haney by February I. A document intended to provide a starting point for discussion will be mailed from State Board very soon after Christmas.

- I. Do you agree that random testing of voting machines should be conducted during every election?
- Do you agree that new and replacement voting machines that are purchased by the state of

South Carolina should have a paper ballot, for the purpose of allowing the voter to verify her/his vote, and, also for use whenever a vote recount is required?

- Do you agree that the iVotronic voting machine, even with an add-on voterverified paper trail, is not secure?
- 4. Should the LWVSC change position (8-1-f) under Electoral Democracy to read "Implementing automated systems of voting from a statewide list approved by SCSEC_to standardize voting procedures, lessen voter confusion and

- increase the accuracy of the count. Approved voting machines should meet LWVUS standards for security, accuracy, recountability and accessibility?"
- 5. Do you agree that source code should be open for inspection?




BOOK DISCUSSION & POTLUCK

This is the first time for our LWVCA to hold a book discussion. The idea came from a new board member, Bea Bailey and promises to be a fun and educational event. The book is "THE BROKEN BRANCH: How Congress is Failing America and How to Get It Back on Track" by Thomas E. Mann and Norman H. Ornstein. Comments on this book come from Newt Gingrich, former Speaker of the House and U.S. Senator John McCain among others. From Gingrich, "The Constitution makes the legislative branch Article I. It precedes the presidency and the judiciary by design. Today the legislative branch is too weak, too dysfunctional, and too out of touch with modern times to fulfill its constitutional duties. Mann and Ornstein understand well the glaring gap between the framers' design and today's reality. The Broken Branch is a serious step toward strengthening the Congress and moving America back toward a more stable and safer system". From McCain, "Tom Mann and Norm Ornstein have few peers as Congress watchers, but their affection for this very human institution drives their analyses in The Broken Branch as much as their experience. You don't have to agree with every point in their criticism to feel renewed respect for their lifetime of devotion to helping make the people's branch of government a better functioning and more constructive tribune of the public interest". We have combined this program with a potluck luncheon. Bring a salad to share and come to a lively discussion of paramount concern.

Personal Reflection

SC Education Oversight Committee Meeting

I was invited, as a representative of LWVCA, to attend the SC Education Oversight Committee (EOC) meeting on October 30, 2006 at the Hamilton Career Center. The EOC is an independent, non-profit agency made up of eighteen members. It was created through the passage of the 1998 Education Accountability Act and has established a goal in which SC student achievement would be ranked in the top half of the states by 2010.

Alex Martin, a member of the Committee, said that SC Schools earn an "A" in Science Standards for 2005 and was one of only nine states that saw improvement. He also said that SC showed an eleven point increase in SAT scores since 2001 and that is the fourth highest increase in the nation since 2000. But, he added that the state's Reading Scores "have been pretty flat and this identified reading as a critical need." There is an EOC initiative, called "Parents and Adults Inspired Reading Success" (PAIRS) which began in 2005 to inspire students to learn to read.

Also there is an achievement gap between White and African-American students, White and Hispanic students and between those who pay for lunch and free and reduced lunch groups. Some experts see the achievement gap as one of the most persistent challenges in the United States. We must raise the achievement of low scoring students while raising over-

all standards. Another concern is the low graduation rate in South Carolina.


Jo Anne Anderson, EOC Executive Director, said that there is one way to clear the obstacles that often block students' chances for academic success and that is through the establishment of "Common Ground" - an initiative developed through some fifty people from both sides of the political spectrum whose goal is to see SC students succeed. The group defined five responsibilities to be fulfilled:

- I. Demand that pre-K through College be dedicated to every child succeeding.
- 2. Place the individual student at the center of education.
- 3. Respect and foster the role of families.
- 4. Recruit, develop, reward and retain educators who can guide learning.
- 5. Provide facilities and technology capabilities that serve the entire community and affirm that education is the cornerstone of the community's strength.

The meeting broke into group sessions. The first task was to name what is taking place in Oconee County to address academic performance. The groups identified Long Range Building Plans, Partnerships with Higher Education, Placement of a Reading Strategies Teachers at each school and Improvement of Teacher Quality. The second task was to address the types of barriers there are for

reaching their goals. The barriers were identified as follows: resistance to change, low percentage of male involvement, marketing of the school district, single parent families, and the difficulty of serving all at-risk pre-schoolers. The final task was to name what the community and individuals could do to address the responsibilities of "Common Ground". The issues included: parent education, increase the number of volunteers, become more flexible and creative, improve communication, the need for more school programs and to support and value diversity. Those present were educators and community leaders that encompassed diverse areas.

Another Personal Reflection

On Poll Watching

With a small contingent of poll watchers (Joni and Les Grady, Eleanor Hare, Ellen Magee, Frances Plotnik and Aleta Robinson) and using questions supplied by the Verified Voting Foundation, we observed poll closing after absentee voting at Pickens on November 2, 3, and 6 and poll closing on Election Day at #103 (at East Clemson Baptist Church), Craters Creek II, and Albert R. Lewis precincts.

Tootsie Hayes and Lisa Swords were very helpful to the poll watchers at Pickens, carefully showing us everything they did and answering all our questions. There were two iVotronics set up in the hall outside the elections office. As people presented their ID and signed the voting roster, Lisa Swords entered their names in the computer as having voted and printed a sticker for their sign-in sheet with their name and precinct number. Tootsie Hayes escorted each voter to a computer and entered the correct precinct number. When the polls closed, the number of total votes cast on the iVotronics that day was compared with the number on the sign-in sheet and the Personal Electronic Ballots (PEBs) locked up. The voting machines were left in the hall overnight. (The poll watchers had some concerns about the overnight

LWVCA Newsletter January 2007 security of the voting machines left in the hall, even behind locked doors.)

Those of us who observed at Pickens thought that the Elections Office needed more staff. If a disabled person needed an iVotronic brought to the curbside, there would be only one person left with the machines. In our opinion, there should always be at least two people staying with the voting machines or they should be closed down. Elections workers also need to be able to eat lunch and take an occasional break. The phone also rang frequently. In our opinion, additional people were needed, both to answer the phone and to allow the other workers at least an occasional break.

On Election Day we encountered problems closing down the machines. At Albert R. Lewis precinct, the machines would not close normally. With help from Pickens and a special "trick" override password, they finally convinced the machines to close. At Prater Creek II the poll workers also couldn't close down the machines. They tried many times and, even with phone help from Pickens, could not close the machines. The "trick" override password didn't work this time. Finally, they physically closed the cases and returned the still (electronically) unclosed machines to Pickens. There were no problems at the third precinct observed.
