Important Program Update! Your Response Needed!

In the June issue of the VOTER, I reported on the passage at our annual meeting of the three positions reviewed in 2023 and added the following information about this year's Annual Meeting Kit:

“A bit of confusion ensued that turned out to be just an error in the formatting of the position on Funding for Services for Survivors of Domestic Violence and Elder Abuse. The first statement in that position was accidentally rendered as if it was being deleted when it was, in fact, a wholly new sentence that should have been highlighted, not struck through. Because the position was passed as presented, the board will address this discrepancy at our next meeting on June 6.”

So that you can see the problem, here is the incorrectly struck through sentence:

1. Support all methods of on-going and consistent funding of services for survivors of domestic violence and elder abuse.

The sentence is essential to the robustness of the revised position. At our June 6 board meeting, we did indeed discuss the resolution of this error. Our intention is to get the corrected position approved as quickly as possible.

First, we verified that the strike through was simply human error. The original document, as presented to the compilers of the Annual Meeting Kit, show the sentence highlighted in blue to indicate a new sentence. Somewhere in the process of compiling the kit, that sentence was erroneously rendered as struck through for removal. Simple human error. The board moved to ask the membership to authorize the correction.

Then, we had to figure out how to get a membership vote on this change without calling everyone to a meeting. Here is where your help is essential. The board is requesting every member email their yea or nay to LWVHC as soon as you receive this.

A yea means you approve the restoration of this sentence to the Domestic Violence/Elder Abuse position:

1. Support all methods of on-going and consistent funding of services for survivors of domestic violence and elder abuse.

A nay means you do not approve.

Over the last 30+ years, I have maintained a home-based, one-woman architectural practice, completing approximately 240 projects, mostly residential, in Humboldt County and beyond. I am in the process of retiring and look forward to more time for volunteer opportunities in our community. I served for a number of years as a Court Appointed Special Advocate for CASA of Humboldt, and I currently serve on the McKinleyville Municipal Advisory Committee (a volunteer, appointed position).

In our spare time, Dale and I enjoy hiking, kayaking, and learning in our beautiful surroundings here in Humboldt County and in our travels beyond.

Peggy Syvertson

I am new to the LWVHC board and this is why I joined the board. The ability to vote is essential for a vibrant democracy. I would like to be a part of an organization that facilitates this important right.

Maggie Fleming

Maggie Fleming joined League of Women Voters shortly after moving to Humboldt County in 1994. She has served as League secretary as well as volunteering on the State of the Community Luncheon. She has also served on the KEET-TV and the Humboldt Library Foundation boards.

Maggie recently retired after completing two terms as the Humboldt County District Attorney. As a career prosecutor, Maggie served as a Board Member and officer for the California District Attorneys Association (CDAA) and as the co-Chair for the CDAA Domestic Violence Committee.

Throughout her career she worked to help form the Child Abuse Services Team (CAST), a multi-disciplinary team that assists children who are victims of abuse, and she partnered with other agencies to form a multi-disciplinary team to address elder abuse.

As district attorney, she collaborated with tribal court judges to allow for tribal members to have their cases addressed in tribal court to promote restorative justice. She also worked with school boards, the Office of Education, and the court to establish a School Attendance Court to address truancy and drop-out in Humboldt County. Since it began in 2017, the program has reduced truancy by 70-80 percent.
