If you want to help people in underserved communities, join the NAACP and Reclaim Our Vote to reach African Americans who are being removed from the voting registers in Texas, North Carolina, etc. I know that this is calling for work outside of our little Arlington home. However, considering the extraordinary times, and our inability to "mobilize mobily" (yeah, I just made that up) – I am offering you these options. This is not an official League project – but both these groups are non-partisan and we are a partner with the NAACP.

This is NOT an official NAACP Arlington event so we can't use their material.

If you want to write postcards to these people in other states, we will have to print the postcards and purchase our stamps. So please sign up on the Sign-up Genius Link. You can either donate money, write postcards or do both. I will report back if we got enough money to get materials.

Centennial Corner – Mid-April 2020

Centennial Corner is a regular feature of the **League in Action** e-newsletter to celebrate *three* **centennial anniversaries in 2020**: the ratification of the 19th Amendment, the creation of the League of Women Voters, and the naming of our county as Arlington County. Centennial Corner will:

- Highlight important moments and leaders in these three histories;
- List **upcoming events** relevant to the anniversaries; and

An Early Quandary: Where to Focus?

From the start, the League faced internal disagreements about how narrowly, or broadly, to focus its work. Some leaders advocated for building a civically educated army of members capable of exercising political clout. Others thought the League should supplement this goal with a wide-ranging legislative agenda. Carving out a middle ground, the national League's founder, Carrie Chapman Catt, advocated for a focus on what historian Barbara Stuhler termed "improvements in governmental organization and operations." In so doing, Catt laid the groundwork for much of the League's work in ensuing decades and foreshadowed the organization's adoption of its Democracy Agenda in 2004.

While good government reforms were critical to the League from the outset, its policy agenda was also quite encompassing. At the 1921 Convention, for example, the delegates adopted a program that included **women's equality** (e.g., non-discrimination in federal hiring, property rights in marriage, access to jury service, direct citizenship for married women, and help for women "held in harems in the Near East"), **child welfare** (e.g., federal funding for child health, physical education in schools, creation of a federal Children's Bureau, and enforcement of child labor and school-attendance laws), **public health** (e.g., funding for a federal "social hygiene" board and regulation of the meat-packing industry), and **government operations** (e.g., development of a merit-based civil service, retention of state primary laws, and creation of a federal Department of Public Welfare with a woman as its director).

Especially relevant for this Centennial Corner, the League also called for August 26, the date that the 19th Amendment was ratified, to be designated a **national holiday**.
