I sent this email to the County Board to remind them of our commitment to Ranked Choice and urging them to conduct this test in upcoming elections.

What is the LWVUS Volunteer Lobby Corps team?

The League of Women Voters of the United States volunteer Lobby Corps team is a group of approximately 20 League members who live in or near the nation's Capital who lobby the entire United States Senate and House of Representatives.

They ---

Attend briefings by League professional advocacy/lobbying staff monthly at LWVUS national headquarters in Washington, DC

Familiarize themselves with LWVUS priority issues for presentation to legislators

Make appointments on Capitol Hill one or two days per month to present our priorities and positions to Congressmembers

Record and Report on meetings to LWVUS

Report to LWV Presidents across the nation to update on lobbying visits to their representatives

What are the topics discussed in these appointments?

Lobby Corps team members are briefed each time on one particular bill which is receiving attention on Capitol Hill, the subject of which is a member-chosen priority for that year based on member-studied positions.

Some topics have been the Affordable Care Act, public funding of campaigns, climate change, energy, the Help America Vote Act, civil liberties, SCHIP, DC Voting Rights, the New STARTreaty, Title X, the Keystone XL Pipeline, air toxin emissions, Super PACs, gun control, immigration reform, DISCLOSE, the VRAA, EPA regs., etc.

Training?

Indeed, LWVUS volunteer Lobby Corps team members are thoroughly trained about how to gather last-minute information, how to make appointments, how to write the reports and follow-ups, and a mentor takes trainees along on appointments so that the trainee can witness first- hand what he or she will experience.

1. Arlington County Restorative Justice Program

2. The Arlington County Civic Federation Civil Rights Working Group

The ACCF Legislation Committee has created a Civil Rights Working Group to take a broad look at civil rights in Arlington County.

The **priorities** include:

- Review injuries and deaths associated with publicly reported use of force by Arlington law enforcement 2000-2020.
- Identify publicly reported allegations of civil rights violations made against Arlington County government agencies, officials, or their agents from 2000-2020
- Research what role sovereign immunity and qualified immunity plays when civil rights violations by the government, government officials, or its agents are asserted
- Review current law associated with the role of police officers at public schools in Arlington
- Identify risks associated with breaches of data privacy and data security and the need to address data discrimination relating to law enforcement practices in Arlington


The new LWV-VA Advocacy Challenge starts now

 - -> Convenient drop off of absentee ballots
 - -> Removing witness requirement for absentee ballots
 - -> Letting absentee voters correct procedural errors
- *State level preclearance* of practices restricted under the federal Voting Rights Act
- 100% Right to Vote Constitutional Amendment -- protecting the right to vote so it is not taken away upon incarceration
- Campaign Finance Reform



Reclaim the Vote Georgia Phone Banks Are Open!

Reclaim the Vote is continuing their efforts to reach disenfranchised voters before the Georgia run offs. **They have lists** of BIPOC voters who have been "unregistered" by Georgia officials in response to the decimation of the Voting Rights Act.

This is a nonpartisan effort to register disenfranchised voters.

Applications for Redistricting Commission

After the successful passage of the Redistricting Commission Amendment, the work to organize the committee must begin.

The 16 member committee will include eight citizens and eight legislators. The citizens must reflect the racial, ethnic, geographic, and gender diversity of the Commonwealth. Lobbyists are also excluded.

Applications for the eight citizens will be available beginning Monday, November 30th.

We all know legislative progress doesn't happen overnight, and when we achieve





Spotlight: LWV-Arlington's 20 Year History Celebration December 6, 1964

Fixty-six years ago – almost to the day – the LWV of Arlington Celebrated its 20th Anniversary. During the afternoon reception, the League concentrated on its past presidents, of which there were 13 (including founder **Ellen Bozman**). The Board and past presidents offered important words of wisdom about the functioning of our League, many of which are still applicable today.

For example, using a flower/bee analogy, Board member **Deryl Petrullo** made an observation about how the membership and the president work together:

Each president is limited in what can be accomplished while she is in office by the enthusiasm and dedication of the membership. But the president is the Queen Bee. Without her not a one of us--not a fighter nor a drone nor a worker--could get out to our first flower. Petrullo continued with her flower analogy in the context of the League's yearly activities:

Many League activities are annuals rather than perennials. No matter how many times they have been done, no matter how well they have been performed, they remain to be done each year: the finance drive, the care and murture of new members, the selection of new program items, sessions of the nominating committee to make decisions on the next League team.

Some League activities are more like hardy perennials. Onee done they continue from year to year with only slight attention now and then.

Many League activities are annuals rather than perennials. No matter how many times they have been done, no matter how well they have been performed, they remain to be done each year: the finance drive, the care and nurture of new members, the selection of new program items, sessions of the nominating committee to make decisions on the next League team.

Petrullo also touched on the League's willingness to tackle controversial activities head-on, citing member **Theda Henle'**s leadership:

Some bees are irresistibly attracted by the sweet smell of a flower known as controversy. When, during the McCarthy era, the League had a national program item on individual liberties it was Theda Henle who chaired the local committee, and when Arlington County and the state of Virginia and the courts were embroiled in the issue of when and how and whether white and Negro children should go to the same school, Theda knew right away which side she was on. Theda?

Some bees are irresistibly attracted by the sweet smell of a flower known as controversy. When, during the McCarthy era, the League had a national program item on individual liberties it was **Theda Henle** who chaired the local committee, and when Arlington County and the state of Virginia and the courts were embroiled in the issue of when and how and whether white and Negro children should go to the same school, Theda knew right away which side she was on.

To close out the presentation, **Petrullo** offered thoughts about the League's nonpartisanship policy—still a bedrock principle of today's League:

The most difficult concept to explain about the League of Women Voters is nonpartisanship: how can the League be political but not partisan? Nationwide, nonpartisanship is fairly easy to maintain. At the national level, the League can support or oppose political issues with all the fervor at its command and rarely be accused of favoring one party or one candidate over another. But on the local scene it is more difficult. There is no question here of whether it is more noble for an organization or an individual to be partisan or nonpartisan. The point is that the League was founded as a nonpartisan organization and its by-laws on every level require that the League neither support nor oppose any party or candidate. Our integrity as an organization and as individuals acting in the name of the organization require that we respect this. I am sure you know that this is not meant to hamper or inhibit any League member in the pursuit of any political activity she wants to engage in so long as she can keep the lines clear between herself and the League. The need for intelligent and sustained political education and political different ways and in different intensities: we admire and respect them all and we thank them and you for coming to celebrate our two decades of Arlington League history. If you want to, it would be appropriate now to saw so.

Applause

The women you have met this afternoon are all leading "political" lives in different ways and in different intensities: we admire and respect them all and we thank them and you for coming to celebrate our two decades of Arlington League history.


