## All Things Ranked Choice Voting (RCV)

We have been monitoring the use of RCV in Arlington County and speaking with all 5 members of the County Board about RCV. We are also in communication with **Liz White** of UpVoteVirginia and other RCV supporters.

As you may know, Arlington used RCV in the June 2023 Democratic primary election for County Board. (There was no Republican primary). In December 2023, the Board agreed, on a 4-0 vote, that RCV would be used in all future primary elections for County Board, as allowed by the General Assembly. Therefore, RCV will be used in the primary election in June 2024.

On February 24<sup>th</sup>, the County Board will consider an ordinance to use RCV for the **2024 County Board General Election**, which will fill one (1) vacant seat on the County Board. (*Note Board member Libby Garvey is not running for reelection*)

After talking with the five County Board members, we believe that all are supportive of RCV – some more enthusiastically than others. A few still have reservations about using RCV in 2-seat elections. A few mentioned the need for greater outreach and voter education.

Using RCV in the 2024 General Election would be a step in the right direction – however, RCV supporters, including the League, would like the Board to designate RCV as the method of voting in **all future** General (and Primary) elections.

As League members you may be asking: "What can I do?"

Here are a few suggestions and requests:

**Email the County Board** and ask them to support using RCV in the 2024 (and all future) general elections. **Countyboard@arlingtonva.us** 

**Plan to attend** the County Board meeting on **Saturday, February 24<sup>th</sup>**, which will begin at 9 a.m. The RCV **ordinance** is listed as item #32 on the **agenda**. It is among 3 "Regular agenda items" scheduled at the end of the meeting.

**Attend in person** at 2100 Clarendon Blvd, 3<sup>rd</sup> floor.

**Watch the Board meeting** via livestreaming or on Verizon or Comcast channel ("Arlington County's YouTube channel or broadcast on Arlington County's cable channel on Comcast Xfinity 25 or 1085(HD) and Verizon FiOS 39 & 40 ").
