

This session will explore the Constitution, the 13th, 14th and 15th

Amendments, and the Reconstruction founders' vision of a "Second Founding" for our nation. Judge McKee will also talk about his legal career and his work on the Court of Appeals, as well as answer questions from participants.

Battles for Equality in America: The 14th Amendment

This session will explore the America's first and second civil rights movements, the Constitution and women, and modern interpretations of the 14th Amendment.

This session examines the issues and events that led to the Constitutional Convention in Philadelphia in the summer of 1787, including the weakness of the Articles of Confederation, Shay's Rebellion, and the growing need for a new national government. the Three-Fifths Compromise, and the Slave Trade Clause.
