Voter Safety is a Priority

Delay of May Elections Supports Public Health Press Release LWV Virginia

The League of Women Voters of Virginia supports Governor Northam's decision to delay May town, city, and county elections to May 19 in Virginia, in order to increase the safety of elections during the COVID-19 crisis.

Deb Wake, President of the League of Women Voters of Virginia, stated: "Postponing these elections to May 19 is the right decision. This will help voters cast their ballots in greater safety. Even two weeks can give election workers more time to prepare for social distancing at the polls. Still, we encourage voters to apply now for absentee ballots and return them promptly."

The League supports voting by mail while the pandemic persists. In order to best protect health while keeping our democracy strong, voters should apply now for absentee ballots on the Department of Elections website, https://vote.elections.virginia.gov/VoterInformation

The League advocated by <u>letter</u> earlier this month for voting by mail. We urge policy makers to consider secure drop boxes, website optimization for voting at home, and strong support for transparent and efficient processing of the anticipated surge in absentee voting.

"April planning brings November safety," said Joan Porte, First V.P, League of Women Voters of Virginia. "While ballot processing this year may take longer, due to distancing measures, we appreciate the Commonwealth's attention to health, security, and transparency. Our democracy is resilient, Virginians treasure their right to vote, and we support safe access to the polls."

This announcement follows an April 8 decision to move the June primary elections from June 9 to June 23, 2020.

Legislative Priorities

LWV Virginia is asking for the input to plan their legislative priorites for the 2021 General Assembly. Advocacy should not just happen during the few weeks that they are in session. We need to work year-round to make sure that we are not only reacting to but initiating legislation.

Please send Joan your suggestions by May 15. Remember, that legislation must be in line with existing LWV policy (on a state, local or national level.) You can find these on websites for each under "issues" and "policies."

Ranked Choice Voting Comes to Arlington

With some caveats. The General Assembly voted to allow Ranked Choice Voting in Arlington providing that the County pays for it. High estimates place costs at \$1,000,000 although that seems very high! However, in the age of Covid, the County may not have the desire or ability to make that kind of outlay.

The Department of Elections will have to formulate guidelines before this can proceed. While it is doubtful that this will happen in November, the law is on the books and we are going to make sure it is not forgotten.

Celebrating Dr. Rosalyn Terborg-Penn

This column celebrates the successful movement for female suffrage, but we wouldn't understand anything about the struggle if historians weren't remembering it for us. So this week's Centennial Corner pays homage to one of the most important scholars of the suffrage movement, Dr. Rosalyn Terborg-Penn.

Dr. Terborg-Penn (1941-2018) had local ties. She earned a master's degree at The George Washington University and a Ph.D. at Howard University. She then served as a professor of history at Morgan State University, in Baltimore, for more than three decades. She co-founded the Association of Black Women Historians.

In her obituary, the *New York Times* noted that her signature work, *African American Women in the Struggle for the Vote, 1850-1920*, "challenged the existing narrative that was dominated, and framed, by white activists."

In a recent journal article, Dr. Terborg-Penn described some of the key findings from her decades of study:

Most Americans are surprised to learn that Black men and women were part of the nineteenth-century woman suffrage movement, which began officially at a small women's rights convention in Seneca Falls, New York, in 1848. During the over seventy years that followed, hundreds of African American women mobilized to gain the right to vote, especially during the years 1900 to 1920. Some organized in

women's clubs formed in churches and in neighborhoods to aid Black communities. However, most joined national African American organizations like the National Baptist Woman's Convention and the National Association of Colored Women (NACW), often through state federations. Still others were members of Black secret societies like sororities of Black college women or Black women's auxiliaries of Masonic orders. Each developed appropriate strategies for gaining the ballot or, in states where women could vote, for electing candidates of their choice. In associations, Black women focused on voter-education classes and other vehicles for helping inform their communities and preparing women to vote effectively. Some Black clubwomen lived in the few states where woman suffrage had been legislated before 1920. Their goals included working to support an all-inclusive woman suffrage amendment that would give all women the right to vote in any type of election.

We celebrate Dr. Rosalyn Terborg-Penn for enriching our knowledge of history and the women who made it.
