
Volunteers needed for September Voter Girl project

November 2021 Election information available now

The next election will be a General Election **November 2, 2021**.

Deadline to register to vote is October 12, 2021 for the General Election Register to vote online, check registration status and see what's on the ballot for your district at locality voter information websites (below).

To vote by mail -

All voters are eligible to vote a mail ballot. Voters must request a mail ballot.

Voters can request a Mail Ballot until Oct. 22, 2021.

Ballots for the November Election will be mailed starting Sept. 17, 2021
Ballots must be mailed be delivered in person by Nov. 2, 7pm or mailed with a post mark of Nov. 2nd and received by Noon on Nov 5th.

To vote early in person -

Early voting is open 45 days before all elections. All voters can vote at any early voting location.

Early voting for the November General Election starts Sept 17th.

Vote Election Day -

On Election Day, all Arlington polling places are open from 6 a.m. to 7 p.m. You must vote at your assigned location.

Governor Northam Announces Artifacts for New Time Capsule including artifacts submitted by LWV VA

New handmade capsule will replace capsule in Lee Monument Base

RICHMOND—Governor Ralph Northam today announced the artifacts for the new time capsule, crafted by Richmond sculptor Paul DiPasquale. The capsule will be placed in the concrete pedestal of Richmond's Lee Monument.

Historians believe a copper time capsule was placed in the cornerstone of the Lee pedestal on October 27, 1887. Records from the Library of Virginia suggest that 37

Richmond residents, organizations, and businesses contributed about 60 objects to the capsule, many of which are believed to be related to the Confederacy.

Redistricting News

Redistricting Commission Bogs Down Over Voting Rights Criteria

The Virginia Redistricting Commission September 9 resumed its review of draft legislative maps from a larger area of Northern Virginia, but not without some sharp exchanges between some commission members about the treatment of incumbents.

The commission listened to lengthy presentations by its partisan counsels on recent case law interpreting the act, but two motions, eventually suggested by Meg Lamb, a lawyer for the Division of Legislative Services, both narrowly failed. The counsels were instructed to work together with Lamb and the commission's co-chairs on language that both sides could support to present at the commission's September 15 meeting, beginning at 8 a.m.
