#### Information You Need for the 2020 Election!

Even without all of the current weirdness, 2020 was going to see many changes to Virginia election law. New legislation, some just passed earlier this month, has changed much regarding the way we vote.

LWV Arlington has put together a PowerPoint presentation which addresses many of these changes. We are using it for virtual webinars at interested community organizations.

Find below the PowerPoint, done by **Lisa Koteen Gerchick** and **Don Gurney**, for your review. Please don't use it to make presentations...if you know of a group who is interested in us doing a webinar please let me know. It is best for the Voter Services team to do these as they can answer questions!

However, do go through the slides so that you have a better grasp of the law. For instance, we have learned that many people are not aware that you can't bundle people's ballots and return them to the registrar! That is against the law in Virginia.

#### **LWV-VA Applauds Passage of Voter Protections in Pandemic**

The General Assembly adopted the governor's plans to allow voters to safely deposit their ballots for the November 3rd elections at designated voting areas. The Virginia Department of Elections will prescribe measures to ensure security at drop off locations in addition to numerous existing ballot verification measures. The new legislation also provides for prepaid return postage on vote by mail ballots and enables voters to correct errors on their mailed ballots received by October 31.



We will be holding a Debate Watch Party for Northern Virginia Leagues on September 29 at 8:45 PM EDT. You do not have to be a new member to attend!



# THURSDAY, OCTOBER 8, 2020 AT 7 PM — 8:30 PM Racism and Redistricting: How Unfair Maps Impact Communities of Color



**Join us** 10/8 for a discussion on the role systemic racism plays in silencing voters of color and what's at stake in this year's election

As the 2020 Census count comes to a close, states prepare for the 2021 redistricting cycle—but not all states will have maps drawn that truly represent

voters. In 2019, the League of Women Voters of the United States launched the People Powered Fair Maps TM campaign in all 50 states and Washington, D.C. The campaign has prompted state-led actions to create transparent redistricting processes that involve citizens and ensure the needs of communities, rather than elected officials, are represented as districts maps are drawn.

On October 8, the League of Women Voters of the United States, along with LWV of Georgia, North Carolina, and Virginia will host a discussion on the role systemic racism plays in silencing voters of color and how it's shaped one of the most important processes for ensuring voters' voices are heard. These community leaders will share information on the work being done to end some of the most egregious racial gerrymandering in the country—and what all is at stake in this year's election.

The League in American Democracy: A Century of Leadership

After ratification of the 19<sup>th</sup> Amendment, many people feared that women's organizational energies would dissipate. The National League of Women Voters had been created out of the National American Woman's Suffrage Association to educate millions of newly enfranchised female citizens in the ways of representative democracy. But early commentators and subsequent histories told a story of a "woman movement" in decline. Was this story true?

One contemporary study set out to answer this question *with systematic data*. The study employed an important measure of women's organizations' political involvement – appearances before the US Congress – and charted them from roughly 1880 (when women's groups first testified) through 2000.

Did the "woman movement" collapse after 1920, resting on its laurels? Nope. Here's what the study found:

- Women's organizations' presence on Capitol Hill expanded greatly in the four decades after the 19<sup>th</sup> Amendment was ratified. This is true whether one looks at number of hearing appearances, appearances as a share of all hearings, and number of groups testifying. Women's groups stormed the Hill.
- The range of issues that women's organizations engaged also expanded greatly. This finding means that women's groups had encompassing interests and that Congress took seriously women's input across a wide range of causes. These causes included international relations, environmental protection, poverty, immigration, and women's rights, among many other issues.

But what about the League? Did it become a shadow of its former organization, as some had feared? Again, the answer is, Nope. Underline that: <u>Nope</u>.

- Together with its state and local affiliates, the League testified more often (990 times) and on a broader range of issue areas (105) than any other women's organization in the 20<sup>th</sup> century. The League testified nearly twice as often as the second-most-prominent organization, the General Federation of Women's Clubs.
- The League accounts for nearly 10 percent of *all appearances before*Congress by women's groups from the nation's founding through 2000.

The second half of the 20<sup>th</sup> century posed challenges to mass membership organizations, including women's associations. But there's hopeful evidence of a turnaround in the 21<sup>st</sup> century, and again, the League is a national leader. From 2016 to 2019, League membership grew by a third nationwide. Membership growth in the Arlington League also has ballooned over the last decade.

Reflecting on the League's history, and particularly its role in the present day, the study's author concluded: "The League offered a locally accessible organization, with a trusted brand, strong leadership, and a policy agenda ideally suited to citizens anguished over the state of American democracy. People were ready to advocate for democracy, and the League had decades of experience doing so."


