#### **MEDICAID EXPANSION (ME)**

ME plods along in South Carolina. Governor Nikki Haley and Director of Health and Human Services Anthony "Tony" Keck are adamantly opposed to accepting Medicaid Expansion. They continue to say they have a better plan for those in the State who need ME, but have shown nothing to date except for self-help encouragement and broadening of the CHIPS program. Lt. Governor Glenn McConnell cautions that ME is necessary, but only if waivers are accepted so that the state will not be held to the rigidity of the mandates from the Federal government. The waivers would allow the states to tailor the monies from ME to the best possible use within each state while remaining within the spirit of the law.

About \$11 billion is involved in the first 3 years of ME. The Feds will pay for 100% for the first three years and gradually phase to 90% Federal money and 10% state money. SC will pay the difference going forward after the first three years.

Potential savings for the State may come from increased Medicaid spending on mental health. This would free up mental health monies to be spent elsewhere. It may also help to keep people out of the criminal justice system. ME would allow access to preventive health care for adults and children and, hopefully, better overall health for all South Carolinians and less stress on the existing health care system. Obviously, there will be much soul-searching, research

continue to develop

and arm-twisting before any decision is made.

AARP and the Coalition supporting ME, which includes the League [see flyer in January *League Lines*], its position and is

formulating a campaign to present its pro-ME position to the Governor and to the members of the House and the Senate. Major advocacy efforts must continue, and all groups involved think that pressure on individual members of the Legislature and on the Governor may bear fruit. This will be a long and protracted battle. More information will be forthcoming. *Contact your legislator and convince him or her that something major needs be done soon*.

#### **NEW MEMBER ORIENTATION**

On January 17, 2013 *Keller Barron* invited all who could come to her home for new member orientation. It was an opportunity to learn more about the Columbia Area League. *Jody Thomas*, *Carla Damron, Regina Fields, Kathy Handel*, and **Julie Sellers**, all new members, accepted the invitation and were glad they did.



Keller, Sarah Leverette, Rita Paul, Janie White, Carol Medich, and Shirley Geiger presented. Keller gave an overview of the history, organization, and mission of the League. Sarah reviewed activities at the State level including advocacy, studies (including the current education study), as well as the role of the State Convention. Rita provided information on the local League including its Bylaws, Program, and the Program Planning process. Janie described League funding, dues, the budget, and the Education Fund. Carol gave a report on voter service activities over the past year. She and Shirley discussed some of their experiences at voter registration events.

The new members then completed information sheets indicating which areas were of most interest to them. We look forward to including those issues in our ongoing activities.

I hate to tell this to the new members, but they'll find out soon enough. All that education did not earn you CEUs, but it did provide you with the basic tenet of the League, to encourage you to become an informed citizen and take an active role in government. #### January PP Luncheon...*Recap*

The January Public Policy Luncheon program was true to form because it highlighted the current issue of *teacher evaluation* with two knowledgeable speakers, former US Deputy Secretary of Education **Frank Holleman** and attorney **Betsy Carpentier**, policy analyst for the SC Association of School Administrators.

Speaking first, Frank immediately let it be known that public education is the greatest creation of American democracy. It is offered in every community to every child without regard to location, wealth, race or language. As an advocate for public education, Frank has strong opinions about current teacher evaluation proposals. He stated the state cannot "evaluate" teachers. Such a focus lets everyone else (politicians, students, parents) off the hook. Evaluation of the teacher does not take into account many of the issues that strongly affect the student, including poverty, mental health and immigration issues, which are completely out of the teacher's control. Student achievement is \_ the responsibility of the community, not just the teacher. Frank feels strongly that if the community addressed the issues of adequate teacher compensation. provision of necessary teaching supplies, and community prestige (recognizing the important role of teachers), there would be a change in the education outcome.

Betsy spoke on the current teacher evaluation plans advanced by State Superintendent Mick Zais, and the counter proposal developed by state education groups and endorsed by the State Board of Education. Betsy described the types of evaluations offered by each group and validated Frank's presentation, especially concerning issues over which teachers have no control. She pointed out research indicating the family accounts for 60 percent of a student's academic outcome.

She continued that central to any useful evaluation plan would be the type of tests given to students. Betsy said the current PASS test measures only mastery of curriculum standards at a certain grade level. It is different from an adaptive test, which gives a better understanding of the achievement level of a student, whether higher or lower than grade-level standards. She said a better approach to increasing student achievement would be more teacher planning time, professional development and instruction, improved classroom environment, and content proficiency.

The material presented by the speakers will be valuable for the **February 11th consensus meeting** and will contribute to an informative presentation and spirited discussion. Please familiarize yourself with three important documents: 1) consensus questions; 2) Executive Summary of the state study; 3) the Alternative Perspective, written by LWVSC's Education Study members *Janelle Rivers* and *Sally Huguley*. *Together*, the Executive Summary *and* the alternative perspective provide balance on this consensus issue. The main report emphasizes the *corporate* view of teacher evaluation; the alternative perspective presents research findings and opinions by educators, economists and psychologists as well as the impact of poverty on children's academic achievement.
