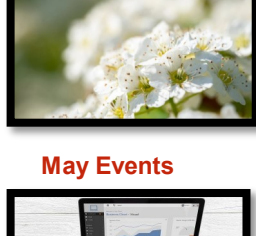

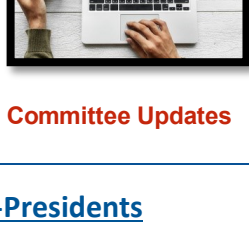

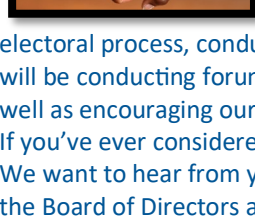

Committee Updates



- **Homelessness—**
Learn about Project Roomkey:
L.A. County (with the help of significant federal funding) is [renting hotel and motel rooms](#) for some of its most vulnerable residents who are vulnerable to COVID-19 but don't have a safe place to isolate. In the South Bay, COG efforts are focusing on housing at-risk homeless seniors. Unfortunately, some local cities are [actively opposing](#) Project Roomkey, as the protective housing initiative is known, citing health concerns. Cities' claim that the initiative creates increased health risks for neighborhood residents and customers patronizing local businesses. In actuality, the [proposed immediate housing](#) would be staffed with security and medical personnel as well as on-site meal services, and people housed there would only be able to leave the premises in designated vehicles, would not be permitted visitors, and would be required to self-quarantine and follow all isolation protocols.
Governor Newsom [spoke out against](#) the resistance to Project Roomkey, saying, "Cities blocking these efforts — please consider the morality of those decisions," and announced that he is in talks with the state legislature about the possibility of purchasing some of the hotels and motels in question and converting them into desperately-needed long-term affordable and supportive housing.
According to Everyone In, LA County United Way backed leadership, often too much is made of the opposition we see. There is a vocal minority dwarfed by a quiet majority. Be sure to get the facts on any homeless efforts you hear about, especially as it pertains to all Angelinos' safety, during the pandemic and beyond.
- Our team meets every 6-8 weeks to work on educational updates for our members and local residents; we also coordinate support for service projects. Most team members work with other organizations actively involved with homelessness and housing, bringing that knowledge back to the League. - **Natural Resources— Written by Grace Peng**
Right now, we are dealing with two large problems that expose the flaws of our systems. Some of the same operators are actively disseminating misinformation about both climate change and COVID-19.
The American Association for the Advancement of Science just accepted a paper analyzing the results of 6,990 studies about climate change mitigation strategies. [The plain English summary](#), and the [full paper by Diana Ivanova et al](#) are open access. In short, the biggest drivers of climate change are transportation emissions. The biggest impact intervention is for people to get around without cars (walk, bike, eBike, eScooter, transit.) Those that must drive a car, should switch to an electric car or use the most fuel-efficient vehicle needed for the task.
Helping people make less carbon-intensive transportation choices requires societal-wide cooperation. LA County officials have drawn a road map, the [OurCounty Sustainability Plan](#), that follows these best practices. We are fortunate to have officials and staff that follow the science and act accordingly. But, we need to keep showing up at meetings to push electeds to do the right thing and to give planning professionals political cover to implement these needed changes in the face of vocal and well-funded opposition.
The opposition never sleeps. Right now, they are working hard to add local planning factors back into the [SCAG Regional Housing Needs Assessment](#). Local planning factors sound like a good idea—who would be opposed to giving residents input on the shape or their community? In practice however, it means that cities that have been the most successful at fighting inclusionary housing get assigned a lower housing need based on prior demonstrated inability to produce housing.
COVID-19 is another example of seemingly plausible but wrong ideas gaining traction. Because the New York City area is currently the hardest hit in the US, it's easy to assume that density and transit use is to blame for spreading the disease. However, that doesn't explain why much denser Asian capitals have not shared the same fate. Even looking at the NYC metro area, it's hard to explain why relatively low-density Staten Island and Westchester County have the highest COVID-19 infection rates. In Los Angeles, both high density neighborhoods such as West Hollywood and Little Armenia, and low density neighborhoods such as Bel Air and Palos Verdes Estates share the highest infection rates.
There is a preponderance of evidence that exposure to air pollution increases the likelihood of death should one contract COVID-19. Those who lived in the areas with [highest air pollution were twice as likely to die](#) from (COVID-19 coronavirus cousin) SARS. A [similar pattern appeared in Italy](#) with a case mortality of 12% in the areas with the highest air pollution and 4.5% elsewhere. We cannot all seek shelter in private cars because there is simply not enough room for all of us on our limited roadways and we would choke from the resulting air pollution.
As we shelter in place, let us think about those who can't. Who has to go to work despite being provided little or no protection from infection? Who doesn't get paid sick leave? Who doesn't have a home or running water? How can we structure our society to make us less vulnerable to climate change and pandemics?
