Education Committee

Over the last few weeks, members of the Education Committee have met with Superintendents from the Redondo Beach, Manhattan Beach, Hawthorne, El Segundo and Inglewood School Districts. We discussed with them our recently revised local position statement on K-12 education. While each district faces its own challenges, there was a consistency in many of their concerns. They are all concerned about stress facing students and families, about socio-emotional development of students, about school safety and about budget concerns, particularly related to the rapidly increasing number of identified students with disabilities. They expressed appreciation for our attention to local education and said they would be willing to participate in future public programs highlighting current education issues.

Dale Petrulis will host a discussion event at her home on Monday, May 6 from 4:30 to 6:00 for League members to meet and discuss the new position statement and the Superintendents' impressions, and to share their questions and concerns about local education.

Legislative Interview with Assemblyman Al Muratsuchi

The Leagues of Women Voters of the Beach Cities and the Torrance area interviewed California Assemblyman Al Muratsuchi on March 15, 2019. In attendance from the Beach Cities were Joan LeSage, Grace Peng, and Arnette Travis. Representatives from Torrance were Lola Ungar and Jimmy Gow. Assemblyman Muratsuchi emphasized how important it will be to do an accurate census count in 2020. The state is allocating resources to facilitate the effort.

Regarding Water Resources, his main water resources priority is for all Californians to adopt sustainable water sources and practices. According to him we need to focus on adopting a culture, practices, and a mindset that water is a precious resource that we need to conserve and use wisely. The state needs to support agriculture, one of our biggest industries, but we must call upon them to adopt sustainable water practices. Locally, voters passed Measure W to fund sustainable water infrastructure that will allow us to capture and treat rainwater to refill our underground aquifers. This allows us to rely less on Northern California. He supports Gov. Newsom's proposal to have only one underground tunnel to bring water to Southern California.

Assemblyman Muratsuchi is very proud of the state's acclaimed higher education system but finds it inexplicable how California can be 41st^h in the country as to per-pupil funding for K-12 education. He is sponsoring AB39 that will help us to get California back into the top 10. <https://legiscan.com/CA/bill/AB39/2019> (Continued on page 6.)

The legislature is trying to make school districts' compliance with state regulation less burdensome, but we also need assurance that money is well spent. He believes we need to ensure that districts are operating in a transparent way. LCAP <https://www.cde.ca.gov/re/lc/>, the local control and accountability plan, provides an online dash board to see actual breakdowns of school district spending in a simple way.

Regarding unfunded pension liabilities he believes cities must be held accountable for fiscal reporting and obligations. Cities determine their own city pensions. Citizens need to monitor and hold their cities accountable. Having the state help school districts with their unfunded liabilities has its pros and cons, but the state should not be counted on to bail out cities and school districts that have not been fiscally responsible. The State has its own pension problems. We need to closely monitor the pension system so it doesn't affect our children's education in the classroom.

Assemblyman Muratsuchi believes the fundamental challenge for the South Bay is how to build more housing while not destroying our quality of life. Proposals for additional housing in the Beach Cities are met with opposition from residents who bring up traffic and parking. As he sees it, his job as the Assembly member for the South Bay is to work with all of the communities to balance those challenges. He believes we need to build more housing to shorten commutes, fight climate change and provide worker housing in a way that has the collective support of residents in our communities.

In his book, Rosling suggests the vast majority of human beings are wrong about the state of the world. He shows that his test subjects think the world is poorer, less healthy, and more dangerous than it is.^{[1][2]} Rosling recommends thinking about the world as divided into four levels based on income brackets. He suggests ten instincts that prevent us from seeing real progress in the world.^{[3][4]} [Bill Gates](#) highlighted the book as one of his suggested five books worth reading for summer 2018.^[6]
