The League of Women Voters is a non-partisan organization. It does not endorse or oppose any candidates. The League's purpose is to promote political responsibility through the informed and active participation of all citizens.

All candidates were contacted by email and asked to respond to the following question: "Belmont citizens look to our elected officials for fair and responsible solutions to the issues facing our community. Please pick an issue or two from this list, and describe what you have done recently &/or how you would deal with this in the future: capital projects (e.g. library, skating rink), housing (e.g. McLean, Beatrice Circle), schools, financial management (e.g. taxes, overrides), traffic, and transparency." Responses, limited to 100 words, is printed verbatim. Contact information, if provided by the candidates, is included.

Candidates who did not reply to the questionnaire sent to them by the League are included in the Guide so that you will have a complete list of candidates.

An asterisk (\*) preceding the candidate's name denotes an incumbent. Where applicable, attendance at Town Meeting for the past three years, according to the Town Clerk's records, is given in parentheses. The second number indicates the number of Town Meetings the candidate was eligible to attend. If one or more Special Town Meetings are held on the same night as a regular Town Meeting, each is counted as a separate meeting. If candidates were previously elected at caucuses or moved within Belmont, they are not incumbents, but their attendance is noted.

# PLEASE READ: ELECTION CHANGES IN 2022

### NEW PRECINCT BORDERS FOR PRECINCTS 1, 2, 6 & 8:

Due to the 2020 United States Census, half of Belmont needed to be Reprecincted, meaning the borders of the precincts were moved to accommodate areas of the town that are growing and those that are not. Belmont has 8 Precincts, and that will continue. Four Precincts have new borders. Your Precinct and your Voting Location might have changed since last year! If you were affected by the change, you should have received a notice from the Town Clerk's office.

### Precincts 3, 4. 5, & 7 remain unchanged.

In Precincts 1, 2, 6 & 8, all Thirty-Six (36) Town Meeting Member (TMM) seats will need to be elected this year. All current TMMs' terms expire this year, regardless of when they were elected.

In these precincts, Thirty-Six (36) candidates will be elected as TMMs with terms determined as follows: Twelve (12) receiving the highest number of votes, will be elected for three (3) year terms; the next twelve (12) candidates will be elected for two (2) year terms, and twelve (12) more candidates will be elected for one (1) year terms. This is set up to create a cycling of members – just Twelve (12) TMMs will elected for Three (3) year terms in these Precincts in future years.

### NEW TOWN-WIDE OFFICE - MEMBER OF THE LIGHT BOARD:

Belmont Light is established as Belmont's municipal light plant (MLP) under Mass. General Laws, Chapter 164. Since 1938, the Belmont Select Board has served as the Municipal Light Board, with guidance from the Light Board Advisory Committee (previously the Municipal Light Advisory Board) since 2005. With the Town Meeting vote in approval of Article 2 on May 3, 2021, a new elected, 5-member Municipal Light Board, separate from the Select Board, will be chosen during the Annual Town Election. There are 41 municipal light plants in Massachusetts. Belmont was one of only four governed by its Select Board and the only one governed by a three-member Select Board. With certification of the 2022 Town Election, the Select Board will cease to act as the Municipal Light Board and the Light Board Advisory Committee, which was created under the current Municipal Light Board setup, will be dissolved.

In Massachusetts, Light Boards are comprised of individuals who may or may not have extensive technical experience in power supply, transmission, distribution, and other matters. The Legislature created a system in which Light Boards establish policy that is executed by a general manager. Because this is the first time Belmont is electing the Light Board, Two (2) members will be elected for three-year terms; Two (2) members will be elected for two-year terms; and One (1) member will be elected for a one-year term. This is set up to create a cycling of members – just Two (2) Light Board Members will elected for Three (3) year terms in future years.


