Potluck and Emergency Planning and Preparedness Forum, Tuesday, Jan. 30

Please bring a dish to share for our annual LWVBC Potluck Dinner and Forum on Emergency Preparedness. In less than a year, California has faced catastrophic emergencies and evacuations, including incidents related to the Oroville Dam, the Santa Rosa fires, and the Montecito mudslides. How prepared are we? Bring a friend and join us for an informational forum with four panelists who will discuss their agency or department role during an emergency/disaster:

Lt. James Bell, Butte County Sheriff's Office Cindi Dunsmoor, Butte County Emergency Service Manager

Bob Kiuttu, Enloe Hospital Emergency Preparedness Manager Capt. Aaron Lowe, City of Chico Fire Department

Forum topics will include:

- What to do to prepare for evacuation/disaster
- How the public will be made aware of the scope of an emergency
- How to help with an evacuation
- · What to take to a shelter
- What is needed to shelter in place
- What to do if separated from family members
- Physical items to have prepared in case of evacuations such as important documents, personal items, medications, etc.

Attendees will have an opportunity to pose questions to the panelists. Our Potluck dinner will begin at 6pm with the Forum to begin at 7pm. We will gather at the Fellowship Hall of the First Baptist Church, 850 Palmetto Avenue, Chico.
