The 2024 Annual Meeting climaxed with an event not on the agenda: the presentation to Treasurer Sandra Flake of the **Mita Markland Award for Outstanding Community Service.** The 2010 recipient, Carol Burr, explained the history and meaning of the award, which was launched in 2003 with the posthumous presentation to Mita Markland, for her many contributions to LWVBC and the



community at large. Sandra was an obvious choice for the award given her five years on the board, one as Government Director and four as Treasurer, and her dedication to the complex task of our transition to 501c3 status.

LWVBC Members Start a Criminal Justice Committee

The League of Women Voters of California's Position on Criminal Justice supports a criminal justice system that is "just, effective, equitable, transparent and that fosters trust at all stages including police practices."

Our Position covers a lot of territory but primarily supports humane and non-discriminatory treatment for each person who comes in to the carceral system at any level.

The League of Women Voters of Butte County is establishing a Criminal Justice committee so that we can observe, review, watch and hopefully respond when needed to justice issues in Butte County that are within the parameters of our Position.

Many Americans believe that our criminal justice system presents some of the major human rights issues of our day. For instance, according to the Prison Policy Initiative we have over 1.9 million people in custody in the United States—more per capita than any other nation. Our jails hold over a 1/3 of that 1.9 million, most for minor offenses, most unable to afford bail, most waiting for trial.

Our committee's initial goal is to become knowledgeable about our Position and local issues particularly concerning the Sheriff's Department, the new jail, and mental health treatment in confinement.

For nearly two decades, Carol Burr and Toni Reid have been pillars of the League of Women Voters, embodying the organization's commitment to democracy, community service, and political engagement. Foundations of Engagement

Carol Burr traces her involvement in the League back to the early 2000s, when she joined the Chico organization. Inspired by a friend's engagement and her own motto, "breathing is a political act," Carol recognized that politics are a part of everyday life. "No way someone

League Activities and Impact

From voter registration drives to educational campaigns, Carol's contributions reflect the league's commitment to democratic participation.

Toni's engagement centered on voter registration efforts, from various locations like post offices, city halls, and retirement communities. Through her work, Toni embodies the league's mission to empower citizens and expand participation in the electoral process.

League's Role in Today's Political Environment

Both Carol and Toni emphasize the league's unique position as a community-driven force for political awareness and action. Carol emphasizes the league's advocacy for issues that benefit the community, regardless of partisan affiliations. For her, feminism intersects with the League's mission for inclusive civic engagement.

Similarly, Toni highlights the importance of informed decision-making and the League's commitment to studying issues comprehensively before taking a stance. She emphasizes the League's role in fostering dialogue and consensus-building, essential elements of a strong democracy.

Looking Ahead

As they reflect on their decades of service, Carol and Toni expressed optimism with a sense of urgency. They stress the importance of voting as a fundamental act of self-determination and civic responsibility. With the rise of younger generations as future voters, they see a changing environment where the League's principles of inclusivity and informed engagement will remain vital.
