CA Redistricting Update: The Mixed Fate of 2023 Legislation

This year, LWV of California supported two bills to improve and extend the reach of the [Fair Maps Act of 2019](#) and to expand the use of [independent redistricting commissions](#) (IRCs) in local elections. Gov. Newsom signed one and vetoed the other.

Signed: [AB 764](#), which explicitly prohibits drawing district lines in order to protect an incumbent, establishes a legal process to challenge redistricting violations, expands the Fair Maps Act to include school boards and other local districts, and increases requirements for transparency and public participation in the redistricting process.

Vetoed: [AB 1248](#), which would have required use of IRCs in counties and cities with populations greater than 300,000, and a school district or community college district with a population greater than 500,000. (Butte County's population is about 205,000, so it would not have been affected.)

In his [veto message](#), the Governor stated that he supports the goals of AB 1248, but believes it should have been included in the annual budget process because of the costs involved in implementation.

Also signed: AB 34, establishing an independent redistricting commission (IRC) for the Orange County Board of Supervisors, and SB 314, doing the same for Sacramento County.

Also vetoed: SB 52, which would have required a charter city with a population over 2.5 million (that is, Los Angeles) to establish an IRC.

It will be essentially the same: a way for voters to access concise and accurate information on candidates and ballot measures.
