**TAKE YOUR MAIL-IN (ABSENTEE) BALLOT** to the Board of Elections, 741 Kenilworth Ave., Suite 202, Monday 11/2 or Tuesday, 11/3. Note: you cannot take your ballot to your polling place on Nov. 3.

AS A LAST RESORT: Making sure you have it postmarked by Nov. 3, mail your ballot to the Board of Elections address indicated on your ballot.

**NEED A RIDE** to your poll Election Day?

Neighborhood Assistance Corporation of America is offering rides. To request a ride, call 1-888-495-6222. Members of the National Federation of the Blind can contact the organization for a ride and receive an exclusive discount code with Lyft.

#### LUNCH WITH THE LEAGUE, Wednesday, 11:30 am on Zoom

School Finance and the Leandro Decision in NC, presented by **John Lee**, co-chair of the LWVCM Education Committee, will introduce League members to the critical issue of underfunded public schools in North Carolina.

The Education Committee wants to build a conversation around the issue of underfunding the public schools and what it portends for students and communities. North Carolina is ignoring a constitutional mandate to provide an education system that meets the educational needs of all the students.

Our concern is that by underfunding education today, the state is eroding the future intellectual capital necessary for a vibrant economy. The Leandro court case highlights critical areas where NC has fallen short in providing a sound basic education for all NC students.

John has investigated public school funding in the state and will detail the ways the WestEd consultant report provides a roadmap to address the unmet needs. Appropriate and consistent funding is required at the state and local level. Get your questions ready to ask for a better understanding of the issue.

## **League Advocacy Steps Up**

#### Healthcare advocacy must become a priority

League members have completed Herculean and critical tasks preparing for the election, among them registering voters, producing Vote411, and monitoring and advocating for fair election laws and processes. But our work is not done. Post-election, healthcare must once again become a high priority for Leagues.

At a time when the United States faces two pandemics: Covid-19 and systemic racism, the healthcare of millions of people, especially people of color, hangs by a thread.

The future of the Affordable Care Act (ACA) will be argued before the Supreme Court of the United States on November 10, 2020. The most prominent arguments are likely to be around severability. That is, if a provision is removed as was done when the individual mandate to purchase insurance was ruled to be unlawful, can the remainder of the ACA stand? Opponents of the ACA, namely the litigants bringing the case, say it cannot.

#### If the ACA is ruled invalid, consider these potential impacts:

- Over 20 million Americans could lose their health coverage.
- Millions more could lose ACA-guaranteed protections such as coverage for:
  - people with pre-existing conditions, including those who have Covid-19
  - adult children under age 26 who are covered under their parents' policy
  - Medicare patients who have enhanced prescription drug coverage
  - women who have access to birth control at no out-of-pocket cost

Though GOP attorneys general make up the plaintiff in this case, there is no known replacement healthcare plan currently being considered in Congress. Leagues need to diligently monitor these issues and be prepared to act. Legislation to watch:

Health Care Emergency Guarantee Act (H.R. 6906) was introduced in the House of Representatives in July 2020 by Rep. Pramila Jayapal. The bill requires the Department of Health and Human Services to pay out-of-pocket expenses of individuals receiving medically-necessary care or services during the Covic-19 pandemic. Specifically, the bill covers the costs of services provided through public or private health insurance and to uninsured individuals until a Covid-19 vaccine is widely available to the public. This bill was referred to a Subcommittee on Health.

**Medicare for All Act of 2019** (H.R. 1384) was introduced in the House of Representatives by Rep. Pramila Jayapal in February 2019. This bill aligns with the criteria outlined in the LWVUS position on Healthcare.

## **Advocating for Fair Election Districts**

Cutting the time for numeration by the US census is sure to sure to cripple reapportionment of the 435 seats in the U.S. House of Representatives, according to LWVCM Redistricting Reform director **Harry Taylor**, who is calling for an end to gerrymandering as a legislative priority in 2021.

In addition to heading his own Flush Gerrymandering campaign, Harry is the LWVCM representative to Fair Districts NC, a coalition of Leagues advocating for an end to gerrymandering using an independent commission. Fair Districts NC advocates a citizens' commission as the best way to draw districts, recognizing when politicians draw their own districts, it creates a conflict of interest and leads to rigged districts, whichever party is in power.

Fair Districts NC has held a number of virtual forums featuring conversations with NC legislators. 

League had billboards all over town advertising our on -line voter guide.




The League's Vote411.org website was the winner of a 2020 Webby Award honoring excellence on the internet.

## **Voter Services**

**Regan Aduddell-Mahoney** has worked tirelessly on the League's Voter Services the entire year, leading up to November's election. And the work doesn't end Nov. 3 because voter services are offered to new citizens at ceremonies which continue year around.

Regan, working with Leta Bosc, has assembled an army of volunteers who work on mailings, voter registration events and even carpentry

which produced an eye-catching Vote sign that stood in front



of the League office in September.

You have read in previous issues of the Voter the extensive activities of the Voter Services Committee which Regan has led, participated in or supervised. In addition to serving thousands of voting citizens in the county, she has forged working relationships for the League with numerous organizations sharing similar interests in good government. Here is her summary report of many hours of activity during the past two months:

"I would like to start by saying THANK YOU! to all of the stalwart volunteers who came out and helped get so many of our citizens registered! This was definitely a "it takes a village" approach. We were able to host over 46 voter registration events from September 1st to October 9th.

We were so fortunate to partner with Inlivian and host events at all of their family complexes as well as all 6 high rise buildings. We were able to identify residents who need rides to the polls and contact groups that were offering those services. We also got 50 Lyft rides for \$15.00 each and donated them to Inlivian for their residents. The staff and volunteers we worked with were also making sure all the residents had participated in the Census.

We are excited about the partnerships we have built and look forward to continuing working together.

We hosted events at Roof Above (formally Urban Ministries and the Men's Shelter) locations as well as the Day Center and Tent City. We worked with League member Pam Pearson who also works with Vote Riders, an organization that helps people get ID's. We were able to help many clients and hope to continue working with Roof Above registering voters, helping them get ID's and educating clients on the importance of voting!

Members Holly Wood and Kelly Hofstatter tirelessly walked the car lines at Crisis Assistance getting folks registered, educating them on Vote411.org and making sure they had all the information needed to vote. We hope to continue working with Crisis Assistance to make sure that all citizens feel empowered to vote every election.

Compare Foods was another partner that helped the LWVCM reach voters. We hosted four events at the Compare Foods stores across Mecklenburg County. We also filmed a video about Vote411.org for their in store channel. One of the benefits for me was learning new food and great cooking videos on the Compare Foods Facebook page!

We were fortunate to work with many other organizations and informal groups who wanted to reach out to folks and make sure that they were ready to participate in the democratic process.

In addition to all our other events we continued our relationship with USCIS. They continue to have new citi-

zen ceremonies but due to COVID restrictions we still don't have a physical presence there. That being said, USCIS has worked with us to pass out our "Registration Packets", and they have been very well received by the new citizens. We have made over 4,000 packets and after this update is written I am off to make 500 more for November....the "Arts and Crafts Committee" has been busy.

I want to thank all of the volunteers who have helped engage voters, make packets and walk carpool lines! I am excited about all of the partnerships we have made and hope to continue to work together." —Regan Aduddell




