**Primaries in Washington State**

Washington was the first state in the country to establish a Top 2 Primary Election system in place of a party nominating system. A Top 2 Primary narrows the number of candidates to two. The two candidates who receive the most votes in the Primary advance to the General Election, regardless of party preference.

## Registering to Vote in Washington State

You must be:

- A citizen of the United States
- A legal resident of Washington State
- At least 18 years old by Election Day
- Not be disqualified due to a court order
- Not under Department of Corrections supervision for a Washington felony conviction
- If you were convicted of a felony in a Washington State court, your right to vote is restored unless you are currently under the authority of DOC. Note: You must re-register to vote to receive a ballot. If you have questions, please call DOC (800) 430-9674

## Residency Requirements

You must establish your voting residency address at least 30 days before Election Day. Your mailing address may be different from your residence address.

## Residence Address Does Not Need to Be Your Mailing Address

PO Box numbers may not be used for your residence address. However, they may be used for your mailing address.

If you have a nontraditional address, such as a motor home or transitional housing, your voting residence is the physical location at the time you register to vote. You may list a different mailing address.

If you are a Snowbird, update your seasonal mailing address at the County Auditor's Office. Provide the first and last days you'll receive mail at this address and the County Auditor's office will send your ballot to your seasonal address between the dates indicated.

Washington residents who are away at college can update their mailing address online at MyVote ([www.sos.wa.gov/elections/myvote](http://www.sos.wa.gov/elections/myvote)) and receive a ballot anywhere in the world. The ballot will reflect ballot measures and candidates for your Washington residence address.

**THE US POST OFFICE DOES NOT FORWARD BALLOTS. You must change your address at the County Auditors Office or online ([www.sos.wa.gov/elections/myvote](http://www.sos.wa.gov/elections/myvote)) when you move.**

## Where Can I Register to Vote

- Online voter registration is available through the Secretary of State's website at [www.sos.wa.gov](http://www.sos.wa.gov). You will need a Washington State Driver License or ID to register online
- Mail-in registration forms can be requested or printed at [www.sos.wa.gov](http://www.sos.wa.gov) and may be available at some State agency offices (Dept of Licensing)
- Mail-in registration forms can be printed in different languages at [www.sos.wa.gov](http://www.sos.wa.gov)
- Pick up a voter registration form or register to vote in person at the Clallam County Auditor's office, Clallam County Courthouse, 223 E 4<sup>th</sup> St, Suite 1, Port Angeles, website <http://wei.sos.wa.gov/county/clallam/>

## Voting in Clallam County

All elections in Washington State are by mail-in ballot. If you are registered to vote in Washington State, you are automatically mailed a ballot 20 days before Election Day. There are three ways to return your ballot.

- Mail it with a first-class stamp making sure it is postmarked no later than Election Day
- Drop it off at a curbside Ballot Drop Box by 8 PM on Election Day. Curbside Ballot Drop Boxes require no postage. These are located at:
  - Port Angeles: 223 E 4<sup>th</sup> St, Courthouse circular drive; also directly across from the disabled parking
  - Sequim: Sequim Village Shopping Center, by JC Penny parking lot
  - Forks: 502 E Division St, District Court II lobby
- Drop it off in person at the Clallam County Auditors Office by 8:00 PM on Election Day

## Make Sure Your Vote is Counted

Carefully follow all instructions on your ballot. Use only black ink pen to vote. Make sure to sign your ballot. The signature on every ballot envelope is verified against the voter's registration record.

Respond immediately if you are contacted by the County Auditors office. You may have forgotten to sign the return envelope or your signature may not match your voter registration record. If you do not respond, your vote will not count.

## Contacting Your Representatives

Sharing your thoughts with the persons who represent you at the local, state and national level is vital to the functioning of a democracy. When an issue or legislation arises that is important to you, contact your representatives! They need to hear from you to do their job. Use email, phone or regular mail to make sure your voice is heard. While form emails are easy, a personalized email may have greater impact. Snail-mail letters won't get "deleted" as easily as emails and phone calls also send an effective message.

Tips for Communicating with Elected Officials:

- Use email, snail mail and the telephone
- Outline what you want to say before you communicate
- Be courteous
- Be concise and focus only on one issue
- Describe specifically and in your own words how an issue or legislation will affect you and others you know
- Keep letters to one page
- Letters to elected officials should be addressed to the person by position, as in "Councilmember Jane Doe" or "Congressman John Doe"
- Include the legislative bill number or its popular name if you are commenting on specific legislation
- Be sure to give your name, current address and contact phone number or email and state that you are a constituent
- Ask for a response
- Elected officials can be offended if lectured to and may respond in the opposite manner you want. Instead, offer them the opportunity to propose and enact change
- Remember to give positive feedback when your elected official does something you like. Your representatives need to hear praise too
