Senator Penry Gustafson

District 27 -- Chesterfield, Kershaw & Lancaster Counties

Penry Gustafson, 53, serves over 116,000 constituents in South Carolina's third largest geographic district. Penry was the only female senator elected in 2020. Out of 46 senators, only five are women, and she is the first Republican elected to District 27 in over a hundred years.

She serves on Agriculture and Natural Resources, Family and Veterans Services, Corrections and Penology, and Judiciary Committees. During the 124th Session (2020-2022), Gustafson sponsored or co-sponsored 15 general bills signed into law.

Senator Gustafson was named an "Elected Woman of Excellence" by the National Foundation for Women Legislators (NFWL) and currently is a South Carolina State Director. She serves on the Board of Directors for Game Changers and the Santee Lynches Council of Government (SLCOG).

She graduated from Newberry College in 1992 and furthered her education with a full graduate assistantship at USC-Columbia. She has championed those most vulnerable or underserved through decades of community service and advocacy. Her wide-ranging career includes coordinator of Operation Inasmuch of the Midlands, top 10% sales producer with Delta Foremost, and case manager for adults with special needs. In younger years, she enjoyed owning a restaurant.

She and her husband Todd live in Camden, SC. Todd is a combat war veteran, retired Lt. Colonel from the US Army, and a retired CRNA. Their blended family includes children William, Maggie, and Drew and their goldendoodle Grace. They love spending time on Lake Wateree, traveling, and listening to live music. When the calendar allows, they both enjoy performing in local community theatre. Born and raised in the state capital of Columbia, South Carolina, Senator Gustafson is honored to represent her home state.



Temus C. "Tem" Miles, Jr.

Mayor of West Columbia

Tem Miles grew up in Lake City, South Carolina. He graduated from Lake City High School, class of 1996, and The Citadel, class of 2000 (Golf Company). He started his career at Southeastern Freight Lines, where he worked until he started law school. He met his beautiful wife, Cassie, while in law school. Both Cassie and Tem were admitted to the South Carolina Bar Association in 2006.

Cassie and Tem have three smart, beautiful daughters: Emma; Cate; and Charlotte. They are members of The Basilica of St. Peter, Columbia, South Carolina.

Tem started his legal career as a Law Clerk to the Honorable Paul E. Short, Jr. at the South Carolina Court of Appeals. Columbia City Council At-Large (former)

Growing up in a family dedicated to public service, Tameika Isaac Devine learned early on that we all have a role to play in making our communities better—and that if you want change, you have to roll up your sleeves and get to work. Tameika knew she wanted to make a difference, so she dedicated her life to bettering the city she loves. In 2002, Tameika ran for City Council At-Large, becoming the first African American woman to serve on the Council and the first African American to be elected at large. In her almost 20 years on the City Council, Tameika has planned and executed countless projects that make a real

difference in people's lives, including the recognition of National Youth Violence Prevention week and the creation of the Police Athletic League. During her tenure on council, she served as Mayor Pro Tem, using her experience as a coalition-builder and a problem-solver to deliver results for our families.

In 2021, Tameika ran for mayor of the City of Columbia. While she lost by a narrow margin to become the city's mayor, she built a diverse coalition across this city, bringing together different demographics that she is still working with to strengthen our city in her role as a community advocate.

In addition to being a partner in her own law firm, Jabber & Isaac, PA, where she practices in the areas of real estate and probate, Tameika is also the founder and CEO of The Possibilities Institute, LLC, a peak performance public speaking and consulting firm specializing in working with women leaders and working moms to help them with strategies to excel professionally while still maintaining a family first lifestyle. Tameika's leadership has been recognized nationally. She has been named one of the 50th Most Influential People in the Midlands by Columbia Business Monthly and a 2018 Woman of Influence by the Columbia Regional Business Report. She was selected by Governing Magazine to be one of their 20 leaders in the Women in Government Leadership Program. She is also a graduate of the inaugural Cohort of Power, Innovation and Leadership Executive Leadership program and the Center for Public Leadership at Harvard Kennedy School and the Dorothy I. Height Global Leadership Academy with the International Black Women's Public Policy Institute.
