League Starts Year With Busy Pace...439 Registrations in Six Weeks

LWV-CC has facilitated 439 registrations since the start of the year--a very busy pace with just one month into the 2020 election season. In comparison, we did just over 960 during all of last year. It's going to be absolutely hectic all the way to October 5, the last day to register for the November 2020 General Election).

The League's team of deputized voter registrars (DVR) has facilitated several voter registration events this year to include Tuloso-Midway HS (155 registered), Ray HS (60 registered), TAMU-CC Political Science classes (124 registered), and Moody HS (63 registered). Other venues, like the Puppy Love 5K and the Homeowners Association, also generated new voter registrations. Thanks to all Deputized Voter Registrars for devoting their time to participate. We are doing great and meaningful work.


















March Membership Meeting To Feature County Judge

NEWS FROM LWVUS

"We saw history this month," writes the National staff in their email message.

In her famous House address, U.S. Representative and LWV member Shirley Chisholm said the Equal Rights Amendment (ERA) "represents one of the most clear-cut opportunities we are likely to have to declare our faith in the principles that shaped our Constitution."

And, this month, <u>Virginia became the 38th state to ratify the ERA</u> – crossing the three-fourths threshold of support required from the states.

But the end is not here yet. Now we need Congress to remove the deadline so the ERA can become a permanent part of the U.S. Constitution.

When the ERA passed Congress in 1972, lawmakers attached a 1977 ratification deadline to it, which they later extended to 1982. Earlier this month, the League of Women Voters of the United States sent a letter to the United States Congress urging them to remove the ratification deadline on the ERA.

It's been almost 100 years we have been waiting and working for the ERA; let's not wait 100 more. Furthering equality by removing the deadline on the ERA would be a fitting tribute to those who fought so hard to ensure that women had the right to vote 100 years ago.

From Arizona:

Earlier this month, voting rights advocates celebrated a win that will make it easier for Arizonans to exercise their right to vote! For the first time, voter registration services will be incorporated directly into the process for reporting a change of address online.

"With this agreement, all qualified voters in Arizona can be certain that their address for voter registration has been updated when they change their address through the Motor Vehicle Department," stated the League of Women Voters of Arizona, one of the organizations who filed the lawsuit. "We applaud the Secretary of State and ADOT for helping Arizona close a gap in compliance of the National Voter Registration Act."



From Texas:

This month, the League of Women Voters of Texas <u>filed a federal lawsuit demanding the state follow the rules of the motor-voter law</u> and make their voter registration available with their online driver's license services.

The National Voter Registration Act requires states to ensure the opportunity for voters to register to vote or update their voter registration each time they obtain, renew, or update their driver's license.

However, in Texas, this opportunity is only offered when eligible residents appear at a Texas Department of Public Safety office in person—not when they update or renew their license online.

"Voters have a right to clear and easy access to registration. By not providing this access to online users, the state of Texas is denying its voters their rights," said the League of Women Voters of Texas

League To Participate in Barefoot Mardi Gras Parade

For the fourth consecutive year, LWV-CC will have a presence at the Barefoot Mardi Gras Parade on Saturday, February 22, on North Padre Island.



A truck (furnished and driven by League member Raul Ramirez) will be decorated with the League's magnetic signage and red/white/blue bunting and American flags. Two League members will ride in the truck bed. Other League members will walk behind the truck, and all will be throwing red, white and blue Mardi Gras beads to the hundreds of folks of all ages lining the parade route.

Sponsored by the Padre Island Business Association, the parade will feature dozens of floats, vehicles, and groups moving along a one-mile stretch of beach from White Cap Blvd. and Nueces County Park Road near Access Road 5.

Wearing patriotic colors, suffragist attire, or the "Votes for Women" sashes are all appropriate! The parade begins at 11 a.m. and takes about 80 minutes to make its way down the beach. The parade ends at the pavilion area where a festival with food trucks and community booths will be staged from 11 a.m.-5 p.m. The League will man a voter registration table in the festival area.

Preview of the League's April 16 Lead Education Forum

LWV-CC will follow-up Tax Filing Day with a Lead Education Forum on Thursday, April 16. Plans continue to make it a free early evening event at the Del Mar College Center for Economic Development with light food for those who miss dinner.

Our president, Anne Stewart, began conversations months ago with the Corpus Christi Independent School District (CCISD) about preventive steps it had taken toward lead reduction in campus drinking water. She and Dr. Mary Jane Garza, former LWV-CC president, have also been in

Historical Exhibit on US Suffrage Movement To Be at Courthouse

LWV-CC is partnering with the Corpus Christi Public Libraries, Delta Sigma Theta, AAUW, and YWCA to present an historical exhibit titled *Women's Right to Vote: Celebrating the U.S. Suffrage Movement, 1848–1920.* The core of the design team consists of Sue Williams, Linda Snider, and Vickie Natale working with Laura Garcia, Director of Libraries.

The exhibit will be on display from March 5-31 in the Nueces County Courthouse lobby.

The display will consist of 20 panels of documents focusing on the events and suffragists who were instrumental to the success of achieving the final passage of the 19th Amendment.

After months of research and sorting through thousands of documents, the team is in the process of narrowing down the selection of highlighted events beginning with the first convention in Seneca Falls, New York, in 1848 and ending with the final ratification of the 19th Amendment just weeks before the 1920 presidential election.

The display will be moved to La Retama Library in April and rotate to the other five libraries for two or three weeks each through August 21. It will then be made available for the August 28th Women's Equality Day Dinner celebrating the National Observance of the 100th Anniversary of the Passage of the 19th Amendment.

contact with the Corpus Christi Naval Air Station concerning an invitation to share its experience in meeting regulations after lead exceedances were discovered in station water in 2013 and 2018. During Dr. Garza's tenure, our League commissioned the 2016 Study to explore "Potential for Lead Contamination in Our Communities' Drinking Water."

Dr. Garza will act as moderator at the Forum and Dr. Jim Klein from Del Mar College will join presenters from the League in making a wind-up presentation.

The school district and the Navy will be invited to the Lead Education Forum to participate as "presenters." The Navy has a new focus on Lead in Priority Areas that emphasizes target areas where children are likely to congregate. Other invitees will conclude the City of Corpus Christi and the Public Health District who the Leagues hopes will provide insight into opportunities for tracking, prevention, and education.

Updates in epidemiology will be discussed at the Forum, as well as simple and cost-effective steps to help guard against lead consumption from residential home taps. A new Lead and Copper Rule has been published by the Environmental Protection Agency (EPA) and the comment period has closed. Among the welcomed federal reform proposals is a requirement for annual water testing at schools and child care facilities. League members hope to hear how those obligations will impact CCISD.

Loopholes continue in the proposed new rules, and the Forum presenters and participants will talk about those. The permissive utility standard of 15 mcg of Lead per Liter of Water will continue to be the action level at which water systems must take additional steps to reduce lead.

However, that action level continues to be divorced from health standards that impose Food and Drug Administration (FDA) limits at 5 mcg in a liter of bottled water. The American Academy of Pediatrics continues its recommendation for only 1 mcg/l at school water fountains.

Be watching for more details about the Forum, and plan to attend the April 16 event.
