PROMOTE: and **gather signatures** to place The California Schools and Local Communities Funding Act of 2018 on the ballot which will increase state revenue by \$11 billion for local schools (40%) and community services like parks, libraries, public transportation, fire fighters, and others. SUPPORT STUDENT VOTER ACTIVISM: If you volunteer or work at high schools, community and local colleges, any or all of these activities are invaluable to their maturing voter engagement.

BECOME A KNOWLEDGEABLE VOTER: Learn how to help others to register to vote. Learn the content of current ballot measures and what offices have candidates to consider. Learn how to use Voter's Edge. **AND share information with others.**

MapLight https://maplight.org/what-we-do/

MapLight has partnered with the California Secretary of State to build user-friendly, open-source software that helps Californians see the money behind their elections, including tools such as <u>Power Search</u> and the <u>Quick Guide to Props</u>.

Dark Money Watch supports investigations of dark money in order to help the public understand how hidden donors can influence our political system.

Voting Rights: LWV Activity Around the Country

The LWV of Missouri and A. Phillip Randolph Institute have just <u>filed a lawsuit against the state</u> of <u>Missouri for violation of the National Voter Registration Act</u>. According to the Huffington Post, the suit claims that "Missouri is violating federal law because it does not offer all residents the option to register to vote at the state's motor vehicle agency or automatically update voter registration information when people notify the state that they have moved. . ."

State Leagues around the country have been active in the courts to protect voting rights. Major successful redistricting fights which resulted in redrawing congressional districts in Florida and Pennsylvania involved LWV plaintiffs. LWV Texas is involved in a Texas redistricting case currently in front of the Supreme Court. LWV North Carolina <u>sued successfully</u> to throw out that state's most recent district maps, but the decision has been stayed pending other Supreme Court decisions on gerrymandering involving Wisconsin and Maryland. LWV Wisconsin filed an amicus brief in the Wisconsin case, and LWV Maryland is a key partner in the "Tame the Gerrymander" coalition supporting the Maryland case. In December 2017, LWV Michigan filed a case challenging that state's congressional and state legislative districts.

LWVUS has supported the efforts of the state Leagues as these cases have progressed. Because your dues support all levels of LWV, including LWVUS, your membership contributes to these efforts. Stay current on voter suppression, redistricting and more at https://www.lwv.org/voting-rights.

California Schools and Local Communities Funding Act of 2018

With passage of the California Schools and Local Communities Funding Act of 2018 corporations will pay their fair share AND homeowners, renters, agricultural land and small businesses will retain their Prop 13 protections. With this small change returning to the original intent of Proposition 13, we anticipate generating an increase of about \$9 billion annually in money for education, libraries, health clinics, public safety. We, the public, will be told how this revenue will be spent. Transparency!! Another League value.

Update:

FINAL DEADLINE EXTENDED TO END OF JUNE.

Most LWVDV members have been mailed a petition to gather signatures of registered voters by county in California to place the initiative on the state ballot. You will be receiving a follow up phone call to answer questions or to provide more petitions if desired.



Misinformation is being spread about this initiative! Here are some key FACTUAL points:

The initiative will:

- Restore over \$9 billion per year in revenue for our schools and local communities by closing the Prop 13 loophole for specific commercial property taxes.
- Help small businesses by eliminating the burdensome business personal property tax while also leveling the playing field for new businesses.
- Mandate full transparency and accountability for all revenue restored to California's schools and local communities.

The initiative will NOT:

- It will <u>NOT</u> raise taxes on residential property
- It will NOT raise taxes on renters nor on rental property with residents.
- It will NOT raise taxes on small businesses.

Remember, Proposition 13 taxes cannot be changed without a state initiative voting process.

If you can support this effort, please do so. Every registered voter's signature helps!!! The entire petition of 8 signatures can have 1 to 8 signatures to be turned in.
