## **Census Comments Needed!**

U.S. Commerce Secretary Wilbur Ross has directed the department to include a citizenship question on the U.S. Census. Including this question on the Census will discourage participation and impact the data collected in every community across the country. This decision is bad for the Census, bad for our communities, and bad for America.

Now is the time for you to act! **Submit a comment about the U.S. Census questions** today!

The Census helps to determine fair political representation and aid policymakers when making decisions about where and how to allocate vital program funds and resources over the next decade. It is imperative to get the most accurate count because every community relies on Census data for things like public safety and transportation resources.

## Help California Take the Next Step To Fight Climate Change!

The climate crisis is endangering all aspects of our daily lives. We must act now to move away from fossil fuels and preserve a healthy and sustainable environment for ourselves and future generations. Fossil fuels account for 75-80 percent of greenhouse gas emissions—but you can help change that.

Take action today and tell your Assembly Member to vote YES on SB 100 - the California Renewable Portfolio Standard Program.

This bill will require that 100 percent of California's electricity comes from zero-carbon fuels by 2045. It also gives clear guidance and sufficient lead time so businesses can plan for the change.

## **VOTERS SERVICE:** VOLUNTEER OPPORTUNITIES

LWV Diablo Valley is gearing up for the November Election. Our goal is simple: informed, engaged voters who understand the issues and know that their vote counts.

#### **VOTER REGISTRATION: Training**

Saturday, August 18<sup>th</sup>, 10 am at Pleasant Hill Cohousing, 2200 Lisa Lane, Pleasant Hill *(see information on pages 1 and 3)*, and Thursday,

September 6-8 pm at Concord Library, 2900 Salvio Street, Concord (see Save the Date below for details).

#### **DVC STUDENT ELECTIONS**

Poll workers are needed to help the Associated Students at Diablo Valley College run their student elections. This is a "do-over" election, as the one held a few months ago was invalidated for improper procedures -- so they need our help!

We will be staffing elections on Wednesday, September 26 and Thursday, September 27, from 9 am-7pm, and on Monday, October 1, from 9 am- 1:30 pm to do the ballot tally and certification.

Volunteers can work in shifts, but at any given time during the election days we will need **3-4** volunteers at the DVC campus in Pleasant Hill and 2 volunteers at the DVC San Ramon location.

**What do poll tenders do?** You will sit at the polling place, check student IDs, check names off the list, and hand out and retrieve the ballots.

Why respond NOW if this is not until late September? Because DVC considers the poll workers to be temporary staff, you need to arrange to fill out paperwork ahead of time (you will be paid, and volunteers usually donate the money they earn for this service). The preferred time slots for doing this advance paperwork are on **Tuesday**, **August 7**, from 9-11 am or 3-5 pm. If alternative times are needed, Martha will need to make the arrangements with DVC for that.

#### **VOTER'S EDGE CALIFORNIA (VEC)**

A partnership between The League of Women Voters of California Education Fund and <u>Maplight.org</u>, this online system gives voters information about candidates and ballot initiatives, and who is funding them. There will be nearly 100 contests in Contra Costa County (24 School Districts, 43 Special Districts, 28 City contests, 3 State Assembly Contests, and 1 County-wide contest).

We will need many **Candidate Liaisons** to learn about VEC and encourage candidates to participate. This can be done from home at a time you choose by using phone, Facebook, Twitter, or the candidate's web site. **Dates**: Early September to Mid-October (when mail-in ballots go out). I attended my first LWV United States Convention in Chicago in June. It was an exciting opportunity to learn about many issues and positions, and to meet League members from around the country. (49 States and D.C. were represented!).

I attended the Health Care Caucus program: *The Critical Role of Healthcare in a Democracy*. The program was co-sponsored by eleven Leagues. The excellent keynote speaker was Dr. Claudia Fegin, Director of Cook County Hospital and Treasurer of Physicians for a National Health Program (PNHP).

She discussed the lack of equity in health care—ZIP code matters—as well as the 30% of the U.S. population who are uninsured or underinsured, and how that impacts our democracy. For a video of the Caucus meeting, use this link:

## How Nonprofits Can Advocate: Know the Ropes

You are invited to a training by <u>Alliance for Justice</u> for Contra Costa County community leaders and organizations hosted by The San Francisco Foundation, in collaboration with Family Economic Security Partnership, First 5 Contra Costa, Ensuring Opportunity, Lift Up Contra Costa, East Bay Alliance for a Sustainable Economy, Faith Alliance for a Moral Economy, the Racial Justice Coalition and the Budget Justice Coalition.

The training will take place on Tuesday, September 18 from 2:00 - 5:00 pm at the First Presbyterian Church (1935 Colfax Street, Concord), which is within walking distance from the Concord BART Station.

During this training, participants will learn **how nonprofits can legally advocate for public policy and community change at every level of government** AND **what nonprofits need to know in California to get involved in a ballot measure campaign.** 

Worry-Free Lobbying Topics:

- 501(c)(3) organizations' rights to lobby;
- Your annual lobbying limit;
- What does and doesn't count as lobbying; and
- How to make the most of your lobbying power.

<u>Understanding California Ballot Measure Disclosure</u> <u>Topics</u>:

- Which ballot measure activities do not require registering or reporting under state law;
- The activities and thresholds that trigger registration and reporting requirements;
- How different approaches to raising money for ballot measure campaigns will lead to different reporting requirements; and
- Different options for engaging in ballot measure campaigns.




#### In Memoriam: Audrey Albrecht
