## **Program Planning Priorities – Your Opportunity to Vote**

Our LWVDV held its annual Program Planning meeting on Saturday, but we are not quite done – we need your help!

As we selected the policy priorities for the year, we also were aware that we want to find opportunities to:

- generate and deliver ongoing information through multiple sources like our website, Facebook and twitter and alerts:
- provide, perhaps co-sponsor, voter and community information presentations;
- actively track legislative activity to advocate successfully for our approved positions;
- and coordinate volunteer time and effort focused on our chosen local priorities.

### Three new commitments for volunteer time other than Program Priorities

We have a few ongoing local, state and national advocacy and celebratory activities important to our League message and member growth. Two of those efforts are important for 2020 only, so we will not need as much time for them in 2019.

One of these important advocacy activities is our state League-sponsored **"Schools and Communities First"** state ballot initiative for November 2020, which will change the way that Proposition 13 taxes are assessed for very wealthy commercial property owners that have avoided them, raising money for public schools (40%) and other community services.



The second is the 100 year anniversary of the League of Women Voters and the Nineteenth Amendment granting women the right to vote. We definitely want to plan informative and celebratory events for that critically important and hard fought success - getting the right to vote.

Finally, we have initiated a new effort, our **new Schools Voter Education Team** for regular contact at central and east county high schools, community and state colleges for voter registration and Voter's Edge and voter education activities. This commitment will need your support and volunteer time to be successful. Those members joining the team this year will be designing and setting the course for the regular delivery of voter services at schools. Lead Members of the Schools Voter Ed Team have met several times over the past month to develop a strategic plan for expanding the LWVDV outreach to county schools. The goal is to develop a consistent partnership with the CCC Elections Office that aligns with the state's efforts to promote more civic engagement in schools. Since the county is large and volunteers are few, the team is focusing initially on the more underserved communities where voter turnout is low.

## Action Alert for HR 1, the For the People Act

Our national League of Women Voters strongly supports H.R. 1, the For the People Act, which has been introduced in the House of Representatives. The League actively participated in drafting this bill which protects voting rights, restores the Voting Rights Act, and makes illegal many of the forms of voter suppression which have become widespread in the past 10 years.

The League has issued an Action Alert for all its members to contact their congressional representatives to support the bill. We are fortunate that our representative, Rep. Mark DeSaulnier, is a co-sponsor of H.R. 1. We can call to thank him for his support of this bill at his Washington office at (202) 225-2095, and/or at his Walnut Creek office at (925) 933-2660.

Here are some of the bill's key provisions, as summarized by the Brennan Center for Justice, which also strongly supports the bill:

- Streamlining Voter Registration: H.R. 1 would bring Automatic and Same-Day Voter Registration to voters across the country. Automatic Voter Registration (AVR) is a transformative reform under which eligible voters are automatically registered when they provide information to the government at the DMV or other government agencies, unless they opt out. Since 2015, 15 states and the District of Columbia have approved AVR; if adopted nationwide, AVR could add as many as 50 million new voters to the rolls. Same-Day Registration (SDR) allows eligible voters to register at the polls on Election Day, making it less likely that voters will be disenfranchised by last-minute registration problems. It is already offered in 16 states. Combined with AVR, SDR would solve most of the serious registration problems voters experienced in 2016 and 2018.
- Commitment to Restore the Voting Rights Act. H.R. 1 reaffirms Congress's commitment to restore the full protections of the 1965 Voting Rights Act, the landmark civil rights law that was hobbled by the Supreme Court's 2013 Shelby County decision. Shelby County enabled states to pass a wave of restrictive voting measures and set the stage for the brazen attempts at voter suppression we saw in 2018. The bill makes clear that Congress is committed to reversing the effects of the Supreme Court's decision.
- Nationwide Early Voting. H.R. 1 also would ensure
  that all voters have at least two weeks of <u>early voting</u>,
  including evening and weekend hours. Early voting,
  which is offered in most but not all states, boosts turnout
  for those who may have difficulty getting to the polls —
  such as working Americans and those providing
  childcare and reduces long lines on Election Day. It



- also provides an important protection for election integrity by allowing officials to spot and address problems well in advance of Election Day. Early voting is extremely popular with voters and helped fuel record-breaking turnout in 2018.
- Citizen-Funded Elections. H.R. 1 would create a <u>small-donor matching</u> system for Congressional races and revamp the matching system for presidential contests. Small-donor matching is an innovative reform that uses public funds to amplify

small private donations. The bill would provide qualified presidential and congressional candidates with \$6 in public funds for every \$1 raised from small donors. A similar program has existed for decades in New York City, where it has diversified the donor pool, helped candidates of modest means run for office, and allowed elected officials to spend more time talking to their constituents instead of dialing for dollars. The bill also increases presidential public financing for general elections

- Other Important Campaign Finance Reforms. H.R. 1 also includes strong measures to close <u>loopholes in federal campaign disclosure rules</u>, <u>curb foreign funds in U.S. elections</u>, and <u>fix the Federal Election Commission</u>, our nation's dysfunctional campaign finance regulator.
- Gerrymandering Reform. H.R. 1 would curb extreme partisan gerrymandering by ensuring that states draw congressional districts using <u>independent redistricting</u> <u>commissions</u> whose members represent diverse communities across the state, by establishing fair redistricting criteria, and by mandating greater transparency for the redistricting process.
- **Election Security.** H.R. 1 also contains a number of provisions to improve election security, including a requirement that states <u>replace paperless voting machines</u>, new grants to help states enhance election security on an ongoing basis and develop better processes for auditing disputed election results, and new security requirements for election system vendors (including an obligation to report cybersecurity breaches).
- **Ethics Reform.** Finally, H.R. 1 <u>shores up government ethics</u> by strengthening enforcement of ethics rules in the Executive Branch, requiring disclosure of presidential tax returns, tightening restrictions on congressional conflicts of interest, and requiring the Supreme Court to adopt a code of ethics.

In addition, the bill also prevents the purging of voter rolls based on eliminating the voter registrations of voters who have failed to vote in recent elections.

## **Resource for the March 16 Monthly Meeting:**

OBSERVERS: Serving as an observer is something that anyone can do. It is an opportunity for new or less active members to contribute to the organization's work. It might be something that would appeal to students or new residents who are trying to learn more about their new community, or to recent retirees who have new- found free time and more flexible schedules. While there are no "qualifications" per se, ideally observers are:

- good listeners and able to summarize and "interpret" proceedings in a fair way;
- interested in local government and/or issues being discussed by the governmental body that they are observing;
- able to serve as an "ambassador" for the organization (e.g., talking about the organization with other attendees at a meeting):
- discreet and courteous;
- not working a personal or partisan agenda while serving as a League observer.
