Hello League Leaders, Members and Friends,

- 1) Providing online voter registration and Voter's Edge California access and information at libraries and community centers.
- 2) Participating in a fact-based social media and NextDoor campaign, including members and friends and active users of social media. (Our League is endorsing several school bond measures and a future-facing tax measure on the March 3 primary ballot. Sharing our League of Women Voters endorsements and sharing facts can contribute to these measures' success.)

SO VOTE 2020, considering that the most essential criteria (aside from experience and proven accomplishment), will be the ability to bring most of us together again. Then we can rebuild democratic processes that lead us to much needed community solutions for each of the challenges so overwhelming us. Then we can better protect our children and model appropriately how we communicate and collaborate to initiate our best-case community-based solutions.

We have lots to celebrate! We've returned 1050+ signatures to the *Schools and Communities First (SCF) Campaign* thanks to our energetic and expanding team of petition circulators. The hardworking enthusiastic reliables—Sue Brandy, Janet Hoy, and Peggy Huston—continue to make presentations, most recently to an AAUW group organized by Bette Felton. On the same night, Barbara worked with our Rossmoor Democratic Club friends who welcomed Barbara, Nancy Thursby and friends and collect more signatures. And the Saturday before, at the Women's March, our expanding team circulated through an enthusiastic crowd. Confirmed! Yes, that was a Diane Mader sighting, softly but persistently talking to marchers, petitions in hand. We even enlisted (the always helpful) Mike Brandy to hold up a large SCF poster so people could locate and sign petitions circulated by Sue Brandy and other League members. We had the Women's March blanketed!

Sadly, while we are having so much fun building momentum, the Campaign statewide is at only 50% of the 1.6 million target, and not on schedule. **We have until March 18, 2020**, to get our petitions to Sacramento. Loud cheers for our Diablo Valley Leaguers who, at events and through personal contacts, continue the work to get this measure on the ballot.

The opposition is distributing fancy brochures and emotional arguments. I hear from Facebook and NextDoor readers that there are many misunderstandings and misleading statements. This underscores that our signature drive is our opportunity to get SCF on the ballot and address voters' worries. Our work is important!

We provide trusted information, as Lee Lawrence never tired of declaring, and Renee Zeimer reminds me! When it is time to VOTE, people TRUST our facts and our position. Talk with your neighbors and friends if you hear misinformation. Our February house parties are opportunities to get the truth out and get signatures. Our September events will re-focus our slide show and Q&A to pass SCF.

February 14th Day of Action--Redistricting

Census 2020 Update - Diablo Valley League Volunteers Needed

Starting on March 12, households will receive a postcard in the mail inviting them to fill out the census online for the first time ever. The Census is only nine questions, will take about ten minutes, and will impact us for the next ten years.

Please look for an invitation from Mary Schreiber to join her as a "boots on the ground" **Census Ambassador** in your community and nearby locations as needed. After training, which is educational, interesting and fun, you can be invaluable in ensuring everyone will be counted where they live on April 1, 2020:

- Be the Ambassador that can answer concerns such as using a computer and explaining the "nuances" of the questions.
- Be the Ambassador to note citizens in your community who need translation and other assistance that may best be served by Census NGO's established in Contra Costa County.
- Be the Ambassador who is aware of community reach-out groups, churches, etc. that could use assistance and may not be aware of where that assistance is. There is still technical assistance and grant money available to such reach-out groups or individuals.

Healthy California for All Commission Inaugural Meeting

The Healthy California for All Commission held its first meeting on January 27 in Sacramento. The charge of the commission is to provide the Governor and Legislature with options and recommendations to advance progress toward achieving a health care delivery system that provides coverage and access to all Californians through a unified financing system, including, but not limited to, a single-payer financing system.

The Commission's 13 voting members include California Health and Human Services Secretary Mark Ghaly, who chairs the Commission, eight gubernatorial appointees and four legislative appointees. There are also five ex-officio, non-voting members. Their work will be supported by a consulting team and staff from the Department of Health and Human Services. At this first meeting, Commission members heard presentations by members of the consultant team who considered the history of health reform in California, the status of health care in the state today, and an overview of the policy questions that must be addressed to achieve a unified financing system.

The Commission is mandated to issue an initial report on their work by July 2020, with a final report due February 1, 2021. The next meeting is on Monday, April 6, 2020, in Sacramento.

Suffragists You Need to Meet: Carrie Chapman Catt

Carrie Chapman Catt was born January 9, 1859, in Ripon, Wisconsin. She completed her upper academic studies at Iowa State Agricultural College (now Iowa State University) where she was the only woman in her graduating class. After graduation, Catt became a teacher and later Superintendent of Schools in Mason City, Iowa. It was during the late 1880s that she became involved in the woman's suffrage movement.

Catt proved to be a skilled political activist and orator for peace and woman's suffrage. In 1900, she was chosen president of the National American Woman Suffrage Association (NAWSA), replacing the aged Susan B. Anthony. In this role, Catt traveled the nation at the behest of many state women's suffrage groups, encouraging women's efforts and prompting men to support a woman's right to vote. Before long, Catt was traveling across the globe as an international speaker promoting the importance of

woman's suffrage. She also created the International Woman Suffrage Alliance (IWSA) in 1902, as a body dedicated to spreading the ideas of democracy around the world.

Following the death of her husband in 1905, Catt stepped away from NAWSA for a while to mourn and travel. During that time, she served as president of the IWSA, traveling the world and speaking on behalf of women's rights, especially their right to vote.

Returning to the U.S. in 1907, Catt formed the Interurban Suffrage Council (ISC), which was an association of most of the smaller suffrage groups in New York City. The ISC held its first Convention of Disenfranchised Women at Carnegie Hall with over 800 delegates participating. It was then that Catt founded the Woman Suffrage Party (WSP) of New York.

The focus of the WSP was on winning women's right to vote in New York. As the chosen chairperson of the Party, Catt adeptly guided the efforts to raise awareness about women's right to vote through meetings, flyers, parades, door-to-door campaigning, and unique fundraising tactics like "self-denial week", which encouraged women to walk instead of paying a fare for transportation and then donate the savings to the Party. While the WSP was inclusive and welcomed women of all backgrounds, many white society members still were not accepting of mixing with minorities or the poor.

Ultimately, New York women won the right to vote in 1917. Prior to New York women winning the vote, Catt had resumed being president of NAWSA in 1915. Under her "Winning Plan" leadership, which combined strategic state-by-state suffrage campaigns with skillful lobbying pressure for a constitutional amendment, suffragists were victorious when the 19th Amendment was ratified in August 1920.

True to her nature, Catt had already turned her thoughts to thinking about what would come next, now that the 19th Amendment was ratified. With her constant focus on raising awareness and educating women about politics, Catt founded the League of Women Voters in February, 1920.

The mission of the League of Women Voters, as a nonpartisan organization, continues to be protecting and promoting democracy. This February 14, we celebrate the League's centennial. **Happy 100th Birthday, League of Women Voters!**
