

# Measure X 2023: The Allocations, Lessons Learned, & Ensuring Equity in 2024

Voters passed Measure X in November 2020, a County-wide sales tax to support health and human services for our local neighbors and families. The tax money continues to be collected and allocations were made in 2023. What lessons have been learned?

As we move forward into 2024, how do we ensure equitable implementation that reflects the values and needs of the residents of Contra Costa?

Things to Know About Voting:

- CA Voter Information Guides have been mailed
- February 5 County starts to mail out ballots
- February 20 The <u>last day to register to vote</u> online; mail-in paper forms must be postmarked today

**After February 20<sup>th</sup>**, anyone can still register to vote at the County Elections Office or at early voting sites. However, you must be prepared to vote at the site right after registering.

#### Important! Are You Registered as No Party Preference (NPP)?

As a voter who declined to provide a political party preference, or if you registered with an unknown or unqualified political party, you are considered a "No Party Preference" (NPP) voter. Your primary election ballot <u>will not</u> have presidential candidates on it. It is easy to do, and you will be notified of when your ballot is mailed to you. After voting and returning your ballot you will receive notice of when it is received and then when it is counted. https://california.ballottrax.net/voter/

### Sign Up to Be a Poll Monitor!

The March 2024 primary elections are quickly approaching! This year, Advancing Justice - Asian Law Caucus, California Common Cause, and the Lawyers' Committee for Civil Rights are teaming up to run the largest **non-partisan election protection program** in the state.



They are currently looking for volunteers to help them observe polling places across the Bay Area, Southern California, and Central Valley on Saturday, March 2 and Tuesday, March 5. No prior experience

or legal background is necessary, and volunteers will receive training on how to conduct poll observation. Attorneys and law students can earn MCLE credit or *Pro Bono* hours by participating in this program; other volunteers can receive a stipend. Please visit their web pages to learn more and sign up by February 9.

They hope you'll join them on Election Day to help make sure our elections run smoothly and fairly. *This notice was shared by LWV California*.

## **Board Briefs for January 2024**



At its meeting on January 11, the Board took the following actions:

- Approved a collaboration with St. Mary's College on projects aimed at informing young voters.
- Set the date for Program Planning for Saturday, February 10<sup>th</sup>, from 10 am to noon.
- Set the date for Annual Meeting for Saturday, June 1<sup>st</sup>, from 10 am to noon.
- Agreed to endorse Moraga School District Measure D on the March ballot.

The Board also:

- Received copies of the revised Non-Partisan Policy for LWVDV.
- Declined to participate in a coalition, The Alliance to Protect Public Schools, over concerns about partisanship.
- Heard an update on the review of positions which will be presented at Program Planning.
- Learned about ongoing Legislative Interviews with state legislators.
- Heard that luncheon attendees prefer a monthly luncheon rather than continuing with Happy Hours every other month.
