## ONGOING ACTIVITIES -- GET INVOLVED!

### ACTION

**California voters' privacy is protected!** Following intervention by the League of Women Voters of California on behalf of voters, a federal court dismissed the DOJ lawsuit seeking California's full, un-redacted voter registration data. This is a significant victory for voters!

LWVUS has joined League of United Latin American Citizens and Common Cause in **calling on Congress to launch an independent investigation into recent use-of-force incidents involving federal immigration personnel**. This partnership reflects broad, nonpartisan concern about transparency, accountability, and constitutional compliance.

In memory of Renee Good and Alex Pretti, let us gather to turn our collective grief into action and our voices into a movement for a better future. When we remain silent, we give our consent to the decay of our democracy. Change doesn't happen when we wait for it; it happens when we show up for it. History has shown us time and again that the most powerful force in the world isn't a single leader or a closed-door policy—it is the **collective roar of people**.





**Grab your sign, bring your voices, and join a local rally.** Your presence is more than just a gesture — it is a powerful statement that their legacy lives on through our determination.

## VOTER SERVICES

In November 2025, the Voter Services Team was approached by the Contra Costa & Solano County Food Bank to determine if the League would be interested in a partnership to register voters. **We said YES!**

In January, the Voter Services Team Leaders, Shawn Gilbert and Ana Pan, completed training approximately 20 volunteer LWVDV members to register voters. **Beginning on February 5th and continuing through at least June 25th, LWVDV will be providing information on voting and registering eligible voters at various food pantry locations throughout Contra Costa County.** Volunteers will not be waiting for people to approach them. Instead, volunteers will be walking the waiting line and speaking with individuals while they wait for the pantry to open.



Partnering with the CC&S Food Bank is an opportunity for LWVDV to do important outreach in a community we do not often enough engage with. We hope to begin to build a relationship that will lead to increased knowledge of voting rights and processes, as well as a richer connection with the League.

## Happy 106<sup>th</sup> Anniversary, LWV!!



As we celebrate this amazing anniversary, I invite us to pause a moment to remember that **the first organized demand for rights by women in the U.S. began in 1848, in Seneca Falls, New York.** It was then that a few hundred women, and a few of their male supporters, came together to demand women be included as full citizens

of the republic. At this first of its kind convention, the delegates presented the **Declaration of Sentiments** mirroring the 1776 Declaration of Independence, but with more emphasis on equality. This was 72 years before the ratification of the 19<sup>th</sup> Amendment in 1920.

The [Declaration of Sentiments](#)' introduction states:

*When, in the course of human events, it becomes necessary for one portion of the family of man to assume among the people of the earth a position different from that which they have hitherto occupied, but one to which the laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes that impel them to such a course.*

*We hold these truths to be self-evident: that all men and women are created equal; that they are endowed by their Creator with certain inalienable rights; that among these are life, liberty, and the pursuit of happiness; that to secure these rights governments are instituted, deriving their powers from the [consent of the governed](#).*

*Whenever any form of government becomes destructive of these rights, it is the right of those who suffer from it to refuse allegiance to it, and to insist upon the institution of a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness.*

A lot of years preceded the winning of the 19<sup>th</sup> Amendment. It was a multi-generational fight and so much happened over those years. Of course, another 45 years would pass before our sisters of color would be able to vote. Indeed, many Black women were already fighting in the movement for abolishing slavery and were being confronted with untold patriarchal barbs for being women and speaking out. A long battle, and one that continues!
