President's Letter

League Leaders and Members:

The assault on our democracy and our rights is unrelenting and LWV is fighting back.

LWVDV members have participated in protests around the area on May 1 and on Saturdays in Walnut Creek. Several of us attended the press conference advocating for immigrants outside the Federal Immigration Court on Concord on May 15.

In California, LWVC is co-sponsoring SB 42, the California Fair Elections Act, to remove the ban on publicly-financed local elections. I attended a kickoff event in Berkeley on May 18 with other LWVDV members. We are working to get this legislation passed in Sacramento and then our Action-Advocacy team will be recruiting volunteers to gather signatures to get this measure on the ballot.



At the national level, LWVUS is active on many fronts, including challenging the Anti-Voter Trump Executive Order signed in April. More information and updates are here. LWVUS issues statements and press releases frequently, and you can keep up by signing up for their emails. You can also check the information and links to details on LWVUS activities on our LWVDV webpage.

Rally for Democracy – Our First *Unite and Rise 8.5* Action!

Holding elected officials accountable to the public interest is not a partisan act; it is a vital function of a healthy democracy.



On May 1, 2025 the LWVUS launched the <u>Unite and Rise</u>
8.5 initiative -- 8.5 million is the estimated number of voters the League seeks to activate to combat an authoritarian takeover attempt through nonpartisan protest and civic activism.

LWVDV is taking up this initiative throughout Contra Costa County by offering our members and community allies a range of activities we can do locally in protest to the administration's abuse of power.

We Won! And So Did Our Community!

"Congratulations! Your League has been selected to win the Strength in Collaborating award!"

This was the message that was received by LWVDV on May 27 from LWV California. Diane Bianchi and Brooke Schwartz wrote the winning award application, which described our work with Hispanic community organizations to create and distribute postcards with voting information in Spanish during the 2024 election season. Ana Pan and Shawn Gilbert were also active in making this project a success. Our community partners included LWV West Contra Costa



County, United Latino Voices, and Douglas Lezameta from the Contra Costa Hispanic Chamber of Commerce.

Progress Report on California Fair Elections Act

Great news! SB 42, the *California Fair Elections Act*, cleared a major hurdle on May 23, 2025, passing the Senate Appropriations Committee 5-1! Thank you for making this happen!

This bill is our best chance to curb the influence of billionaires in politics by putting a measure on the ballot that allows any jurisdiction in California to adopt public campaign financing — giving voters more power and ensuring good candidates can compete with Big Money interests.

Now SB 42 moves to the Senate floor, where it will be decided by June 6. We need to rally as much support as possible to secure votes! Please continue to contact your State Senator to urge him/her to vote "YES", and share this great opportunity to make a difference with three neighbors!

Celebrating and Defending Democracy!

Celebrate Our Nation's Birthday on July 4th!

Something to celebrate: the Contra Costa County Elections Office does a lot of work to ensure that elections are fair and safe for us all. At the March 12th Contra Costa Elections Community Engagement meeting, attended by several LWVDV members, we learned that in the November 2024 election **the county had the largest number ever of people registered to vote.** Over 74% turned out to vote. Unfortunately, this is 10% less than was estimated by the county. Estimations are an important part of the preparation process for elections. Reading through the <u>notes from this meeting</u> offers good insights into the work that takes place to get ready for elections.

Overcoming Angst

Every day it seems as though another Executive Order is signed challenging the rights of Americans and the very foundations of our democracy. I do a lot of talking to myself to keep from becoming overwhelmed. Perhaps you experience a similar angst. My way

of managing these feelings is to **seek out reputable individuals who are experts in their field to read or listen to.** In this instance, it's those who know law and the U.S. Constitution.



Recently I listened to an episode of *Amicus* with **Dahlia Lithwick** | Law, Justice, and the Courts on @TuneIn. #NowPlaying http://tun.in/tFuRvB In this episode, at the 24:14 mark, you will find a very good discussion with Wendy Wiser of the Brennan Center for Justice about the Executive Order (EO), *Preserving and Protecting the Integrity of American*

Elections. While the title sounds like it is a good thing, it actually is deliberately designed to suppress people's vote. The SAVE Act, recently passed in the House of Representatives, is also designed to do the same thing...keep people from voting.

On *America's Constitution* on @TuneIn. #NowPlaying http://tun.in/tFGqZ0 you will find another good discussion. In this episode, **Yale University professor Akhil Reed Amar** offers insightful analysis on the U.S. Constitution as it relates to elections, voting, and other guardrails designed to protect democracy. Yes, you and I, as voters and activists, are one of the major guardrails protecting our democracy. **Elections matter!**
