With attacks on democracy making daily headlines, it's easy to feel overwhelmed. But real change is happening—right in our own communities. Across California, local leaders are stepping up to defend democracy, protect rights, and drive policy that ripples across the nation.



We're proud that some of our very own League members have recently been elected to serve their cities—and we want you to meet them.

Join us on March 30 for an inspiring conversation with three newly elected League members who are making a difference:

They'll share why local government is more important than ever, how they're strengthening democracy in their communities, and what we can all do to make an impact. <u>Tickets are just \$10</u>—additional donations are strongly encouraged

to support the League's critical advocacy efforts in Sacramento and throughout California.

Please, please, pay your League dues by ACH/eCheck!

When you pay your dues through the Member Portal, the payment is processed through ChapterSpot and Stripe. You have the option to pay by credit card or by ACH/eCheck.

After nearly a month with the new membership system, the true cost is starting to surface. And it's staggering. Your \$75 dues payment gives 20% to our Local League, or \$15. When you pay by credit or debit card, we pay \$1.39, or **9.27**%, in (membership and payment) processing fees to receive that payment. On a \$50 dues payment, we receive \$10, and pay \$1.19, or **11.9**%, in processing fees. LWVUS and LWVC pay similar amounts for their portions. Even if you included a donation, this payment method still costs us a lot more to process than almost any separate donation through our Donate button.

Please consider paying your dues electronically from your bank account, also known as ACH or eCheck. You will need your bank's routing number as well as your account number. **It's easy and secure**, and saves the League a lot in processing fees. On \$15, the ACH fees are \$0.77, or

lot in processing fees. On \$15, the ACH fees are \$0.77, or 5.1%. On \$10, the ACH fees are \$0.68, or 6.8%. This is nearly half of what we pay for processing credit or debit cards. If you're considering donations, we are working on getting those processed at significantly lower costs, even less than

Checks are highly discouraged for paying dues with the introduction of the new membership system. Donations by check or Zelle are still very much appreciated.

The Constitution and Citizenship

Two panels of amazing people including historian Martha Jones and attorney Sherrilynn Ifill offer history and thoughtful analysis in this two-hour program. The panels shine light on the importance of the 14th Amendment and its history pertaining to citizenship. The discussion is rich in its focus on the foundation history of the amendment during the Reconstruction Era and full of passion for

A key take-away is learning that the original version of the 14th Amendment included a voter protection component, Section 2, which is referred to as the lost 110 words. Central to that



section is the last sentence which says, "States that deny their citizens the right to vote will have reduced representation in the House of Representatives." Unfortunately, that version of the amendment did not make it into the final version.
