## **Leaders' Letter**

League Leaders and Members:

Dear League Leaders and Members,

September was another busy month for your League. We were part of the planning group for a <u>well-attended national Zoom webinar</u> suggesting ways to build trust and participation in our democracy prior to the 2024 elections. One of our own board members was a panelist, sharing information on the programs our local League has developed to involve people in the democratic process.

Aligned with our <u>Gun Safety</u> priority, we sent a letter to the Contra Costa County Board of Supervisors, partnering with Diablo Moms Demand Action, to support adoption of a Gun Safety Ordinance for the unincorporated areas of the county (it passed!)

Our first **League luncheon**, open to all members and friends, was a big success and we plan to continue them every other month. Even months we will have no-host <u>Happy Hour</u>, with our next one on October 11<sup>th</sup>.

Also in September, we co-sponsored an online Community Conversations

presentation on **Immigration**. Because this is such a complicated issue, there will be a follow-up presentation in March – watch for it in emails and the March *Voter*.

Our October Community Conversations program will focus on Income Inequality, followed on October 29th by our first-over Points of View event on the related topic of Cu

our **first-ever** <u>Points of View</u> **event** on the related topic of Guaranteed Income – details for both events are below. Points of View is an in-person opportunity

to discuss current issues in a facilitated environment. We hope to see you there!

LWVDV has an **Observer Corps** of members who attend governmental meetings, note what happens at the meeting, and report back to the League. LWV Observer programs promote government transparency and accountability, and ensure that citizens are aware of the decisions that impact their communities. We are working on establishing a **Youth Observer Corps** to increase youth engagement in our democracy, and LWV Bay Area is also creating an <u>Observer Corps for regional agencies</u>. Stay tuned!

October is **Voter Education Month**. Important dates include:

# **INCOME & WEALTH INEQUALITY:**Pathways to Balancing the Scales

October Community Conversation Thursday, October 19th, 4-5:30 pm

"As long as there is poverty in this world, no man can be totally rich even if he has a billion dollars." - Dr. King, "The American Dream" speech, 1961.



Income disparities are now so pronounced that the average income of America's richest 1 percent of households was more than 84 times the average income of the bottom 20 percent in 2019, according to the Congressional Budget Office.

Disparities in tax policy, challenges to families endeavoring to live on minimum wage jobs, and increasing costs of living are some of the factors contributing to wealth inequality in our nation.

Two approaches to addressing this inequality will be featured in our

October 19 webinar, including the Guaranteed Income Program employed by some cities and in Contra Costa County, and the Patriotic Millionaires, who focus on tax policy, increasing the minimum wage, and their hope to pass the Oligarch Act.

## The League Takes Action!

### **Gun Safety Report**

This month LWVDV partnered with Diablo Moms Demand Action to support adoption of a Gun Safety Ordinance which requires gun safes or locks for the unincorporated areas of Contra Costa County. LWVDV President Anne



Granlund signed a letter of support that was sent from the League to the Contra Costa County Board of Supervisors in advance of their meeting on Tuesday, September 19. The Board also sent an all-member Action Alert encouraging members to contact their supervisors asking them to support this ordinance.

Moms Demand Action will be an important partner in our work to promote Gun Safety. I am also working to connect with the Rossmoor Gun Safety Club and the Contra Costa County Violence Prevention Coalition.

The **Gun Safety Interest Group is continuing to seek members** who are interested in working in this area. As an interested person, you could assist the team and the League in being informed of important events and information regarding gun safety. While it would be nice to have a committee that meets, a person may only be interested in being a set of eyes and ears for the group.

### Local Lobbying for SB 94

LWVDV received a <u>request from LWVC Criminal Justice interest groups</u> to do targeted in-district lobbying for SB 94 Sentencing Reform, which allows judges to review certain life-without-parole sentences.


Sue Brandy, Diane Bianchi and I met with Assemblymember Rebecca Bauer-Kahan, and Marian Shostrom and I met with Michael Sponsler, District Office Manager for Assemblymember Tim Grayson.

To prepare for the meetings, we were given a SB 94 Fact Sheet and guidelines for lobbying meetings, and we met with Gloria Chun Hoo and Carolina Goodman from LWVC and Natasha Minsker from the California Anti-Death Penalty Coalition.

At our meeting with Assemblymember Bauer-Kahan (*pictured*), she asked questions we were not able to answer about how SB 94 is different from other sentencing reform bills already passed. Sue Brandy then contacted Gloria Chun

Hoo. Natasha and a colleague provided further information for Sue's follow-up email to the assemblymember.

Marian and I were able to use this information when we met with Michael Sponsler. During that meeting, Marian emphasized that the people eligible for this review are mostly women and people of color, as well as youthful offenders. The support from many members of the faith community was also important. The response to our visit was positive.



One lesson that I learned from this experience is the importance of working with a legislator's staff in the lobbying process. It can actually be more effective to meet with staff, who are often more knowledgeable about bills, and very difficult to get a meeting with the legislator. I would definitely recommend getting the first available meeting with a staff member for lobbying.

Both Assemblymember Bauer-Kahan and Michael Sponsler said that they have high regard for LWVDV and our support for a bill is meaningful.

Unfortunately, SB 94 did not make it to a vote in the Assembly. It is now a twoyear bill, currently inactive, and may be brought up again in 2024.

"We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America."

And perhaps, take another moment to read the "<u>Common Interpretations</u>" of the Preamble offered by two highly respected scholars. We know The Preamble is the introduction to the Constitution, but what does it mean? If you want to delve a bit deeper into The Preamble of the Constitution and its history, scroll


• The article by Matt Leighninger, <u>What do people need to feel heard?</u> This provides research backed innovative ideas for creating effective and successful civic discussions.
