CANDIDATE FORUMS

The LWVGGB uses their candidate forums to keep the voters informed about the issues important to our community. We also use them as an opportunity for the citizens to meet the candidates.

The coronavirus pandemic has made it impossible during this election cycle to have the candidates present at a public gathering.

However, we are planning to host "Virtual Forums" in an effort to continue our practice of keeping voters up to date. The candidate forum team is inviting the candidates running for the 30th Senate District, the 90th Assembly District and the 89th Assembly District. All three of these races have opponents in the Aug. 11 partisan primary.

Please tune in for more information. With more and more voters voting absentee, we would like to do these forums as soon as possible.

Request Absentee Ballots NOW for August and November!

In Wisconsin you don't need a reason to vote absentee. Request your absentee ballot on-line and the ballot will be sent to your home, along with a pre-stamped return envelope!! Absentee ballots will be mailed to those people who have requested them for the Fall Primary, starting June 25th

If you haven't requested your absentee ballot yet, do it now!

Instructions from COVO (local voting support group

- 1. Request your absentee ballot on MyVote.WI.Gov. Do it today. It takes around 2 minutes.
- 2. If this is your first time requesting an absentee ballot, you'll have to upload a picture of your **PHOTO ID**. This is the same ID you would use to show at the polls, usually a driver license. It's easiest to use a smart phone or a tablet to do this. We've prepared a video that may help you: https://bit.ly/3agKiZx
- 3. After you request your ballot, go back to MyVote.WI.Gov and track the status. It should show that you have requested a ballot. If it doesn't show within a few days, call your clerk (you can find your clerk under MyVoterInfo on the MyVote website.)
- 4. Your local clerk will mail you the ballot when it's available, usually 3-4 weeks before the election. You can go to MyVote and see whether it's been mailed. If you don't receive it 2 weeks before the election, call your clerk.
- 5. If you decide to vote in person, you can do that, as long as you haven't already

mailed back your ballot. It helps to bring the ballot back with you, but it's not necessary.

- 6. If you're worried about the return mail, many municipalities have a drop box available, or you can bring it to the early voting hours that your clerk provides. This is still safer than the crowds on election day.
- 7. Your ballot must be RECEIVED by the clerk by 8 pm on election day. If you're mailing it, allow at least a week for it to get to your clerk. Under normal Wisconsin law, postmarks don't matter. It simply has to be received by election day. Again, the problems with the spring election were due to lawsuits that pushed out the return deadline, but then required a postmark. For the August and November elections, we will back to normal rules.
- 8. When you seal your ballot envelope make sure it has three things: your signature, your witness' signature, and your witness' address. Your witness can be any adult U.S. citizen.

LWVUS Responds to Police Killing of George Floyd 5/29/2020

WASHINGTON – The League of Women Voters of the United States issued the following statement in reference to the murder of George Floyd:

"The League of Women Voters grieves the murders of George Floyd and the countless other Black lives that have been tragically taken at the hands of rogue law enforcement officers who are rarely held fully accountable for their actions.

"We also mourn those who have lost their lives or been harmed, mentally or physically, as a result of America's pervasive culture of anti-blackness. The systems of oppression that have perpetuated the myth of white supremacy in our country must be dismantled if we are ever to become the nation we pledge to be—indivisible, with liberty and justice for all.

"As an organization whose mission is to empower voters and defend democracy, we stand in solidarity with all Black communities. The League shall do so not only by speaking out against racism in all forms, but by doing the work required of us to be anti-racist. We are committed to listening to and amplifying Black voices, and educating ourselves and our children on the historic and ongoing systemic racism that plagues this country.

"The League acknowledges, painfully, that America is a nation founded on racism. Therefore, all who live in this country must contribute to and participate in organizations actively working to achieve full liberation and inclusive freedom. We must all advocate for anti-racist policies at every level of government.

"We join the League of Women Voters of Minnesota in calling on law enforcement officials to provide transparency during this investigation, and to seek justice for George Floyd, his family, and his community.

"Finally, we echo the call of our partners at the NAACP: we must all vote in November – the road to change lies at the ballot box."

Redistricting question added to Brown County November ballot!


Thanks to emails and calls from many of you, the Brown County Board of Supervisors voted 15 to 10 to add the following question to the November ballot! "Should the Wisconsin Legislature create a nonpartisan procedure for the preparation of legislative and congressional district plans and maps?"

Now members of Brown County will be able to tell our State Legislature that we want nonpartisan redistricting (NPR) in 2021!

Next, the Fair Election Team will work to 1) educate the public why they should answer YES and 2) convince our state representatives to support NPR.
