Four excellent speakers will address the topic *Why more effective recusal rules are needed for judges at all levels who receive campaign contributions.* The speaker include: Former State Supreme Court Justice JANINE GESKE; Former Manitowoc County Court Judge PATRICK WILLIS, Common Cause in Wisconsin Executive Director JAY HECK, and UWGB Democracy & Justice Studies Assistant Professor, KRISTINE COULTER.
