

Theno continues his longtime passion for good governance by, among other contributions, serving as a statewide speaker for the Fair Elections Project, advocating reforms in redistricting. He is also a political consultant and has recently authored a book on campaigning, titled *Winning Local Elections*.

The People's Maps Commission is a nonpartisan redistricting commission charged with drawing fair, impartial maps based on 2020 U.S. Census data.

The People's Maps Commission is holding an online public hearing 5:30 – 8:30 p.m. Thursday, Oct. 1, 2020, to seek public input on the upcoming redrawing of legislative redistricting maps.

The hearing is the first in a series of at least eight meetings the Commission will

host. The focus of the hearing will be Wisconsin's Eighth Congressional District and highlight redistricting basics including why redistricting matters and how it works.

The online public hearing will include testimony from experts and also provide Wisconsinites the opportunity to express how they have been impacted by legislative redistricting and share their ideas for how Wisconsin can work together to achieve fair maps.

Every 10 years, each state redraws their legislative and congressional districts using data from the decennial census. In addition to the data from the 2020 U.S. Census, the Commission will use information gathered during the public hearing process to prepare new maps. It is then up to the Legislature to take up and approve the maps created by the Commission.

Although the Oct. 1 hearing will focus on the Eighth Congressional District, all Wisconsin residents are encouraged to watch and participate. Anyone wishing to testify at the hearing must register in advance by visiting the People's Maps Commission website <u>HERE</u>. The deadline for remote public appearance requests for the October hearing is 5 p.m. Tuesday, Sept. 29, 2020.

Remote public testimony will begin at 7:30 p.m. Each speaker has a time limit of 3 minutes. Registration is on a first-come, first-serve basis, with residents of Wisconsin's Eighth Congressional District being given priority.

For anyone unable to join online, written comments are strongly encouraged. All written comments also can be submitted at any time using the feedback form available on the People's Maps Commission website <u>HERE</u>. Written comments will be reviewed by the commissioners and are public record.

Selected by a three judge panel, the Commission is a nine-member nonpartisan redistricting commission charged with drawing fair, impartial maps for the state of Wisconsin. More information about the Commission, its members and its activities is available HERE.

Anthony Phillips, of Appleton, will represent the 8th Congressional District. Phillips is a physician with Theda Care Hematology and Oncology and has been involved with several grassroots organizations working on election and campaign issues, including Fair Maps Wisconsin and Voters First WI.

# In August 2020, the Brown County Board added a SECOND REFERENDUM QUESTION

to the November 3 ballot. This is an advisory referendum.

#### Question #2

Should Wisconsin State Statutes be amended to provide County Boards of Supervisors with a mechanism to approve or overturn any actions taken by County Health Officers that impose county wide restrictions on citizens and/or businesses, or that require county wide closure of businesses?

As you review this question, consider if the County Board should have the ability to approve or overturn the county wide restrictions as noted in the question.

A yes vote would allow the County Board to set up a mechanism to overturn or approve the action of the County Public Health Officers by the County Board Supervisors.

A no vote would not allow the County Board to set that mechanism. It would allow our County Health Officers to maintain the authority to keep the public safe with regard to communicable disease.

This question was approved by the County Board, in August, only a month before absentee ballots were mailed. The timing does not allow sufficient time for public

input or education.

The LWVGGB Healthcare Committee would prefer to have time to study the question which would include a review of Wisconsin Statutes as they relate to the authority of Public Health Officers.

For anyone who lives alone and needs a witness signature on their absentee ballot: If you need a witness, bring your blank ballot to the Voting Mural, and COVO can witness it through your car window. Show them the blank ballot, mark it in private, then they will sign your envelope and you can drop it in the mailbox or your clerk's ballot drop box. They are at the Mural (230 N Monroe) on Saturdays and Sundays from noon to 4pm through October 11th.
