Last month a programing survey was sent out to all League members in the our weekly email Blast. The survey asked members to tell us their top 3 "Hot Button" issues. The results of the survey will guide our programing for the upcoming year, targeting topics that are most timely and most important to us, locally and nationally.

40 people, with one being an expat in China, responded to the survey with 60% of respondents concerned, not surprisingly, about our Elections – Voter Turnout/Registration/Representation – and 42.50% concerned about the Safety/Integrity of the our elections. Fair Districts – Gerrymandering – and the Environment, Climate Change/Fossil Fuels/Air and Water Quality, were tied with 40%.

These issues were followed by Criminal/Social Justice Reform, 30%, and Healthcare Reform – Medicare for All, 22.50%. If anyone is interested in having the complete report of the the survey results, please contact me and I will forward to you.

Because of the importance of the next election and the latest events that threaten our democracy and our fundamental right to vote, our next two League meetings will focus on Elections and Voting. The continuing pandemic does not allow for us to meet in our usual fashion, therefore for the rest of the year, we will be meeting over Zoom. South, Central and North Unit meetings will be combined into one Zoom meeting in October and November. And, although we look forward to meeting over dinner and socializing every September for our Kick-Off, we will have to wait until next year!

FAIR DISTRICTS PA UPDATE by Maureen Grosheider

The time for enacting legislation to create an Independent Citizens Redistricting Commission and meet the other deadlines required to change the state Constitution has gone by.

So, FDPA has turned its attention to a transparency and criteria bill – LACRA (Legislative and Congressional Redistricting Act, HB2638 and SB1242). Both bills are in their respective State Government Committees. The goal is to get both bills out of committee in September and passed on the floor before the November election.



The focus for the moment will be on the Senate State Government Committee, with a lesser focus on the House State Government Committee. Senators in our area on SGC are Lindsey Williams (D–North Hills) and Pat Stefano (R-Westmoreland/Fayette/Somerset).

FDPA may be working on scheduling Zoom meetings with interested constituents in both Senator Williams' and Senator Stefano's districts.

TIME TO DOUBLE CHECK YOUR VOTER RECORD



The 2020 presidential election will be here soon — November 3rd to be exact. This is a good time to check your voter record. Check to see that you are registered and where your polling place is. Please help those you know who may be new at this (Hurray

for first time voters of all ages!) and those who may have moved to a new address to be sure their record is correct. Voters (and want-to-be-voters) in Pennsylvania need to register by October 19th. If you are helping someone to register or update information, including an address or a name change, an easy way is to go to <u>www.votespa.com</u>. The voter can sign up online with a PA driver's license or PA state ID card. The person can sign up and the required signature will be loaded from the signature that is on the state file for the person's PA driver's license or PA state ID card. If the person does not have either of these forms of ID, the website has additional instructions for submitting a signature.

Check your address. Have you moved, but forgot to change your voter record? Correct it now! Again, you can use <u>www.votespa.com</u> to correct your address.

Want to vote by mail? Guess where you can go to request your ballot? You got it – <u>www.votespa.com</u>. Allegheny County will send you an email confirming that your application was submitted. If you provided

an email, the County will send you an update when your ballot is being sent to you. The time frame for your ballot to make it to the County Elections office is very specific – it must be there by 8 pm on November 3rd – whether delivered by the post office or delivered by you. The County also sends an email when your ballot is received, due to the unique barcode on the return envelope.

Do you have a student in your household who will not be at home on election day? She or he can follow the steps above to request a mail-in ballot and be sure it is returned on time.

Family member or friend who probably should not stand in line for what may be a long time? Suggest the mail-in ballot option, and help them complete the application. No excuse is needed any longer in Pennsylvania, so someone does not have to be disabled or expect to be away from home on election day to vote by mail.

In the primary, I requested and voted via a mail-in ballot because I wanted to see how it would work. It was a good experience, and I plan to do it again. I have already requested my ballot for November. On November 3, I expect to be working at my polling place, but will have already sent my vote in – carrying on the right I gained as an 18-year-old when I voted in the 1972 election.

Thank you for being an always voter – and remember that your Vote is Your Voice!

It has been an extremely productive July and August for our team:

 A new Voter Resources Website, published mid-August, is now linked from the "Voter Resources" tab on the left-hand menu of the League of Women Voters of Greater Pittsburgh's MyLO website. These new Voter Resources pages contain all of the original infographics, tutorial PDFs with active links, student handouts, videos, and other documents in shareable formats that have been created by our dynamic team to empower voters of all ages.



Each member of our team has made key contributions to this effort. Imaginative new infographics, created by team member Ruth Quint, have been especially popular on LWVPGH social media.

- Our committee will kick-off our fall, all virtual classroom visits with a return to Dr. Patricia Sheahan's Social Justice class at Duquesne University. We will present our updated "Voting Made Easier" PowerPoint to her students during three Zoom sessions (September 21st, 23rd, and 25th), which will include question and answer sessions and voter registration.
- On September 22, we will make a virtual visit to **Parkland Community Library in Allentown, Pennsylvania.** Our PowerPoint will be presented to 5th through 12th graders in the library's after-school program.
- Individuals have contacted the LWVGP from **Carnegie Mellon** and **Pitt Universities** in search of reliable, nonpartisan materials. Shareable documents and the new website link have been shared with them. A separate College/University Outreach committee is actively extending outreach with many more contacts.
- Beginning August 17, the new Voter Resources website link will be shared in emails to all of our high school, college and community contacts.

Exciting news from Linda Capozzoli, Brentwood High School counselor. Following our March 2nd visit, Brentwood applied for the **Pennsylvania Governor's Civic Engagement Award.** Last month, Linda notified us that **Brentwood High School** was one of the Pennsylvania recipients and the only Allegheny County school to be awarded the **2020 GOLD Award!**

One other school we visited, **Elizabeth Forward High School**, was awarded the **Silver Award** along with two other Allegheny County schools. This year, only 24 Pennsylvania schools earned the Gold level (at least 85% of eligible students registered to vote) and 18 earned the Silver Level (between 65% and 84% of eligible students).

There was even more exciting news after Linda shared the **WQED "Campaign U" video** with the PA Department of State, which highlighted our visit along with the inspiring Brentwood student interviews. <u>https://www.wqed.org/campaignu</u>.

Linda Capozzoli, representing Brentwood High School, and Amy Kleissas, representing the League of Women Voters of Greater Pittsburgh, were invited to participate in an **August 20th Department of State webinar**. The webinar promoted best practices in youth voter empowerment and engagement for high school personnel across Pennsylvania.

Candidate Forums

Nine candidate forums are being planned by the League of Women Voters of Greater Pittsburgh prior to the November 3 General Election. Since voting by mail-in or absentee ballot is encouraged, dates for the forums will be earlier than usual. We are inviting candidates from the following jurisdictions to participate, each in their



own forum: 17th and 18th U. S. Congressional Districts, 37th PA Senatorial District and the 21st, 28th, 30th, 36th, 40th, and 44th PA Legislative Districts. Announcement will be made in advance of when each forum will be posted.

Voter Registration Forms Distribution

The PA Department of State shipped us 12,000 voter registration forms to be inserted in every family's bag or box of food from an Allegheny County food pantry in September.

for several minutes about the League's 20+ documents posted on the website thanks mostly





Marvelous Members Wise Women (and Men) of the League

We have many outstanding members of the League of Women Voters of Greater Pittsburgh, and as we are inclusive, some of them happen to be men! Here are the reflections of a truly "Marvelous Member" of our League – Preston Shimer, Treasurer

1. *Describe your early years:* I was born in New York City and raised in Scotch Plains, New Jersey. My dad was a public health engineer and an early researcher in air pollution for the New Jersey State Health Department. My mom was a professional bassoon player and teacher. I grew up with my mom operating a music studio in our living room. I started to sing in my church's choir of men and boys as a first grader and have sung in church choirs ever since. My mom needed an oboe player for her woodwind quintet, so I started the oboe in the 4th grade.



2. *Tell us about your educational background:* I went to public schools in Scotch Plains and then continued in the School of Hotel Administration at Cornell University in Ithaca, New York. Later, I earned an MBA at Penn State in State College.

3. *What is your professional or work history?* I have worked in the hotel and restaurant industry, public accounting, large corporations and non-profits. We came to Pittsburgh when I was hired as Corporate Records Manager for Rockwell International in 1977. When Rockwell wanted us to relocate to Los Angeles, we decided to stay in Pittsburgh. Initially I worked as a records management consultant, then joined a company that sold records management software and ended up serving as the administrator of a non-profit foundation.

4. *Why and when did the League become important to you?* Annette joined the League in Montclair, New Jersey in 1969 and I became a League spouse. It has been a part of our lives ever since!

5. *Who was a notable or first League mentor to you?* Annette is a constant mentor. However, I have had many, many league people help me grow in wisdom and understanding over the years.

6. *What was your League "portfolio", including offices you held?* I have served as Treasurer of LWVGP since 2013. I also served as VP of Administration for LWVPA from 2014 -2017. I have continued to support the LWVPA off-board, with support for budgets, technology and administrative support.

7. What do you feel are the most important things you accomplished for the League (and our democracy)? Supporting the office staff with ever-improving uses of technology and enabling the League to accomplish a great deal with limited financial resources and with an all-volunteer membership. The most recent migration to Google Suite will, I think, in the long term be the most significant. I think I had a major impact as a member of the "Living with Guns" program which was a major initiative for the League several years ago.

8. What are your concerns and/or hopes for a post-pandemic America? That we will take this opportunity to reshape our economy focusing on climate change industries and solutions; that we will learn from the current administration and codify limits on the President's powers; and that we will solve gerrymandering and campaign finance damages to our democracy.

9. *What are your wise words for the rest of us*? *Be open minded, curious and playful when you have the opportunity to learn new technology.*
