## **Archiving Our League- Uncovering Our Rich History**

Exciting news! The Steering Committee has employed Bob Malme, an experienced archivist, to inventory our Chapter's records. These are the 11 boxes that have travelled from house to house for decades. We are grateful for Bob's talents and the generosity of members who are donating the cost of his services.

Bob has completed half of the inventory and given the Steering Committee a record of his findings. Documents fall into several categories: organizational materials such as by-laws, meeting minutes, financial reports; internal publications such as bulletins, consensus reports, committee reports, presidents' reports; external publications such as Voter's Guides, Know your Town, study reports; local study materials such as committee notes, news clippings; and State and National study materials and news clippings.

Here are some nuggets Bob uncovered:

- Handwritten and typed notes from meetings starting in 1945
- Slides and documentation for a unit the League presented at the Middle School on Hingham's history
- League Local Action Program on Drug and Alcohol Education 1985
- Studies, including The Impact of Hingham's Growth and Development 1987-88; Casino Gambling Study 1981; Affordable Housing Study including special needs housing, public housing and homeless population; 1986-89

Steering Committee member Cathy Salisbury has agreed to chair oversight of the archiving process. Upon completion of the inventory, the Steering Committee with Cathy's leadership will decide how to organize the papers and which records to digitize. The Committee has been delighted to learn about the wide number of topics our League has tackled for study and voter education over the years.

As we prepare to celebrate the 100<sup>th</sup> Anniversary of the passage of the 19<sup>th</sup> Amendment to the US Constitution in 1920 and the founding of the League of Women Voters of the US, these materials will provide the foundation for sharing our Chapter's accomplishments with members and the public.

## 2017 Hingham Town Meeting Proposed Zoning Articles

The League has <u>not</u> taken positions on these articles however Steering Committee member Cathy Salisbury has provided this overview for your information.

There are five zoning articles proposed by the Zoning Board of Appeals for the 2017 Town Meeting. One is a proposal to place a moratorium on the sale and consumption of non-medicinal marijuana pending the drafting of appropriate zoning amendments to regulate it. Two articles change the definitions of lot width, lot area and lot line to close loopholes that permit the development of odd shaped lots. Another changes parking design standards and allows the sharing of parking to meet zoning requirements. The fifth one proposes to change the standard for the consideration of alterations,

extensions and changes to non-conforming structures accessory to dwellings (such as sheds and garages that are either attached or detached from the dwelling).

#### Zoning continued

This last article proposes to substitute approval by Special Permit for Variance approval as now required by the Mass. General Laws. Variance approval is difficult to obtain due to the requirement that the applicant prove hardship due to unique characteristics on the lot (e.g. soil, shape or topography of the lot not otherwise present in that zoning district). There is great demand from Hingham homeowners to alter, expand or rebuild their accessory structures and sometimes they need a variance to do so. Granting these requests sometimes results in incursions or greater incursions into sideline and front and rear setbacks. Sometimes the re-built accessory structure is much larger than the original structure and allows for new living space as well as the original use.

There have been anomalous results such as when a homeowner attaches the garage to the house in order to avoid the variance strictures applicable to detached accessory structures. The Board of Appeals is attempting to address this problem with this article. There should be robust debate of all this on Town Meeting floor.

There are pros and cons regarding this article. On the one hand, a Special Permit is easier to obtain than a variance since it does not require a finding of hardship and generally allows the permit-granting board to exercise more discretion. As a result, abutters will have a more difficult time legally challenging their decisions. On the other hand, there are restrictions written into this article that state that the alterations etc. cannot go closer to the existing setbacks, cannot increase in volume more than 25% and cannot go more than one and one half stories tall or the height of the existing roof if it is higher than one and one half stories tall. At least residents know there are limits to what their abutters can do with their accessory structures.

There are appeal provisions for abutters in both variance and special permit decisions but not for other residents. There are general standards applicable to both proceedings that the permit-granting authority has to refer to in their decision.

This is a significant change to the Hingham Zoning By-Law similar in scope and effect to Article 48 of the 1984 Town Meeting (the so-called Hatfield Article) which led to the adoption III-IE of our Zoning By-Law and to changes in the MGL.

#### **Voter Education- FY '18 Warrant Review**
