Ballot Bid

We are required to go to bid for ballots for 2022. The ballot bid ad was placed in the Record Courier. Two responses to the bid request were received, one from ES&S and the other from IVS.

ES&S's bid was in order. The prices were for black and white ballots: 14" ballot - \$.24; 17" ballot - \$.24; and 19" ballot - \$.30. For color ballots: 14" ballot - \$.26; 17" ballot - \$.26; and 19" ballot - \$.32. There is a bar code generation fee of \$750.

IVS's prices for black and white ballots: 14" ballot - \$.23; 17" ballot - \$.23; and 19" ballot - \$.29. For color ballots: 14" ballots - \$.25; 17" ballots - \$.25; and 19" ballots - \$.30. All fees included in the price of the ballots. Although required in the bid specs to get ballot paper from ES&S, they indicated they would meet the specs of ES&S paper. This does not meet the bid requirements.

A discussion occurred regarding the problems we had with Midwest and the paper they printed the ballots on. Also discussed the warnings we have received regarding paper supply issues.
