# From the President.....


I share with you a message from the national LWV.

"100 years ago, women didn't have representation in government. With the ratification of the 19th Amendment, women and their allies won the biggest growth in our democracy in the last 100 years. We celebrate this great accomplishment by standing in our power, but at the same time, we acknowledge that the 19th Amendment did not break down voting barriers for all women. Even today, our work is not done.

Many Americans still don't have their voices heard in choosing our representatives. Politicians have robbed voters of their power by manipulating access to the polls and gerrymandering districts at all levels of government. As the 2020 decennial Census approaches, the prospect of an inaccurate or incomplete count threatens to deprive even more people of their rightful share in American democracy.

Women have played a fundamental role in shaping an inclusive and active electorate. Women have powered -- and continue to power -- the vote. On the 100th birthday of the League of Women Voters, we are keeping in line with the fact that we were born from the suffrage movement."

# All voters now can vote early

Step 1: Request your ballot.

Get an application at county, township and city clerks' offices or at Michigan.gov/Vote.

- · Mailed-in applications must be received by 5 p.m. the Friday before an election. Your ballot will be mailed to you.
- · Voters also can drop off their application in person at their township or city clerk's office by 4 p.m. the Monday before Election Day and get their ballot.

Step 2: Complete it, sign it, submit it.

- Option 1: Drop off completed ballot in person to your township or city clerk.
- Option 2: Return your ballot through the mail.
- Ballots must be signed and received by 8 p.m. Election Day.

## FARM LABOR AND IMMIGRATION TASK FORCE

Our forum of April 1 will be titled **Agricultural Challenges and Solutions in Leelanau County**. We will have speakers on the following topics, 1. Environmental challenges; 2. Tariffs and markets; 3. Unplanned changing of crops; 4. Labor; and 5. Grower resilience. A continuing concern is the loss of the summer Migrant Head Start program. We know that the local immigrant community is very fearful of ICE raids and visits by Border Patrol. ICE raids are very traumatic for children and adults and there is little to no mental health treatment available to help them. They are also anxious about the DACA status of several local young people who are

waiting to see what happens.

We discussed proposed legislation that will expand K-12 funding at the State per pupil level to "early 5" or second year of kindergarten programs. The measure will be a topic of our discussion with Sen. VanderWall on the January 27<sup>th</sup>. A more full report of this meeting will follow.

We set the following legislative priorities for the upcoming year:

- o Early childhood education funding
- Expanded support for child care providers
- o Amending/repealing current restrictions on County funding

We discussed a possible April showing of the film "No Small Matter." Members will look into venues.

We will continue to monitor the implementation of the EC millage proposal. Lisa Peacock presented the proposal on behalf of the Health Department to the BOC on January 15<sup>th</sup>. Many committee members were there in support. Sue Miller forcefully addressed the BOC at the end of the meeting. As reported in the Record Eagle:

"Sue Miller said she's tired of some commissioners who continue to say that no one knew about the proposal, which passed by a slim margin. "The assertion that no one knew about the millage is false and I'd like to put that to rest," Miller said. Presentations were made at every township board and village council meeting, at women's clubs, churches and service groups, Miller said. There was also information on social media, in school newsletters and in several local newspapers, she said. "I'm not sure what else could have been done to reach the voters," Miller said. "The voters have spoken and it's time to move ahead."

**ENERGY AND NATURAL RESOURCES** members are planning an evening program for Wed. April 29 from 5 to 9 PM at the Gov't center community room. Since that date is the 5th Wed of April, there should be no conflicts... right? It also follows Earth Week. This will be a **Forum and Fair** around the topic of connecting the climate crisis with the huge possibility of reducing its impact by utilizing Nature to **reduce the amount of carbon already** in the atmosphere. Participants will discover how that would work as well as learn from many local folks what they are already doing. We have discovered there is a huge interest in agriculture, reforestation, and gardening to employ practices associated with regenerative growing techniques which not only would **sequester carbon** but also produce clean water and air, healthy food, healthier people and wildlife, increased biodiversity, fertile soil, and even increased income. We will have a keynote speaker to introduce the topic followed by short "lightning" chats by some of the many exhibitors who already are planning to participate. For early arriving attendees we may even show the film about a couple who have developed, in a short time, an amazing eco-farm especially utilizing sustainable and ecological practices...." THE CHARLEVOIX EMMET UNIT OF THE LCLWV continues to grow with 41 members! Voter Services is the Unit's primary focus until after the 2020 election. Currently scheduled events include voter registration at North Central Community College and local high schools, and public forums covering the new changes in voter laws, redistricting, and the history and fragility of voting rights. The Unit is celebrating the 100th anniversary of the passage of the 19th amendment protecting woman's constitutional right to vote with a 100-woman suffrage float in the Petoskey 4th of July Parade. To commemorate local suffragists, a tree and plaque will be donated and placed in Arlington Park in Petoskey, and a collaborative event with the Little Traverse Historical Society is in the works. The weather was nasty for the January 18th Women's March in Traverse City. Several LWVLC attended and some showed solidarity in their own back yards.










The RunWomanRun cohort has been underway for several months supporting area women who are thinking about running for office.
