The Auditor needs to find a larger space to house new voting equipment in order to accept grant money for that equipment.

Commissioner Shutty says that the number of homeless has decreased from 2017's 353 people to 2020's 172, 103 to 20 in Belfair alone. Keep momentum going.

For you Bayshore residents, rezoning request that'll be voted on in March 16's meeting, to move 96 acres from rural residential to rural natural resources, request made by Bayshore Sand and Gravel. Will expand the John's Prairie pit in the future. Split between Sharon's and Kevin's districts--Tremont buffer Rainbow Lake will be affected.

Cynthia presented an informative program on Housing and Homelessness in WA State. Cynthia answered questions and stated that the most important issue to urge our legislators to support is a Capital Gains tax for high earners in WA.
