Climate Change Committee

Sherri **D.** reported on activities of the committee.

WA Climate Assembly met on January 12th. The assembly was made up of 80 randomly selected citizens from across the state representing the different demographics and will send a report to the State Legislature.

A study group was launched for the Growth Management Act/Mason County Comprehensive Plan. The GMA is the comprehensive planning framework which requires every county and city in the state to adopt, and periodically update, their comprehensive plan and development regulations. The GMA/CP Study Group will be a separate undertaking from the CCC. Currently, we have six people interested. Ideally, the Committee would have ten members. The Dept. of Commerce is holding weekly workshops on issues relevant to the GMA. The next session will be Jan 20 from 9 – 11 a.m.

Advocacy

Observer Corps

Lynda L. reported that a new full-time but temporary person will be hired to give COVID-19 shots. As yet, Lynda does not have further information on the City of Shelton's proposal to build 400 housing units designed to house low-income populations.

HB 1099 is important legislation dealing with climate change. Letters to the Editor are a good way to support upcoming legislation; there should be some Letters to the Editor addressing climate change this week. People are always needed to help.

Lobby Week is Feb. 22 – 26. People can register for it now. **Legislative Lobby Day** is Feb. 22. Information about it will be in our newsletter. Attending that would be a good way to become involved.
