Approval of the November General Membership Meeting Minutes was so moved by Linda W. and seconded by Lynda L. Membership voted to approve.

Treasurer's Report

Pat C. reported a bank balance of \$6,938.70 with one check of \$60.00 to be deposited. The value of the CD is \$1,065.30.

40 members have paid dues for the year so far. Pat reminded all that dues can now be paid with a credit card, on line, through LWVMC website.

Voter Services

Bobbie S. reported that she is waiting to hear from the Thurston County LWV about plans for a joint civics education project but does not expect to hear until after the first of the year.

Amy D. submitted a report to LWVWA regarding our activities for the past year: 112 members volunteered a total of over 3,000 hours, participating in 70 activities.

Member Services

Lynn B. reported that League 101 will occur the afternoon of Saturday, Jan. 23. Exact time to be announced soon in a formal invitation. All are invited- new and old members as well as those community members who want to learn more. It will be a virtual event to last 1-2 hours long.

Climate Change Committee

Sherri D. reported on activities of the committee.

WA Climate Assembly will meet on January 12th. The assembly will be made up of 80 randomly selected citizens from across the state to compile a report to the State Legislature.

UW Program on Climate Change

Sherri D. is working with Marion Bertrum to create a webinar for Mason County Highschool students on Climate Change. High school students will submit questions to be answered by UW graduate students.

Sherri D. is working on an in-depth webinar on the impacts of Climate Change on Mason County. The target audience is elected officials of the county as well as local citizens.

Washington Can't Wait campaign, endorsed by LWVWA, is an effort to require an update to the Growth management Act of 1990. There is need for the Act to include response to Climate Change challenges in the state.

A committee to study the Mason Co. Comprehensive Plan is being formed. Anyone interested is encouraged to email Sherri D. to volunteer.

Advocacy

Amy D. urged all to contact legislators to get on board with the WA Can't Wait Campaign. Also, on Dec. 14th, Gov. Inslee proposed a 365-million-dollar initiative, the Equity and Diversity Policy Project that members should show support for.
