Linda W – "Sawamish" is the name of the Salish sea Randy L – "Sawamish" is the anglicized Squaxin tribe word describing themselves – it means "People of the Water" Sawamish was the original name of the County, until changed to "Mason" Randy has promoted reverting the County name back to original "Sawamish" Is hoping the LWVMC will promote the concept Linda W very interested in a name change – <u>Randy will send her materials</u>

I'm following the WCW (Futuerwise) campaign:

 $\cdot$  Pass HB1099 to ensure Washington cities and counties are planning for climateresilient communities while reducing our contributions to the climate crisis.

 $\cdot$  Fully fund HB1220 to ensure that the state legislature does not short-change housing equity and that we are doing everything we can to address race and income-based housing discrimination.

 $\cdot$  Close the GMA's 'vesting loophole' to protect farmland, forests, and critical habitats from unnecessary sprawl by passing SB5042.

I am strengthening my connection with Kitsap County organizations.

# Education:

I have established a connection with Miriam Bertram, Assistant Director of the UW Program on Climate Change (continuing collaboration). TO DO: Discuss the effectiveness of the UW programs with Deena Alley, and ask about programming for the upcoming school year.

# Forestry:

I have been nominated to become a member of the LWVWA Lobby Team, as Issue Chair-Forests. If my application is accepted by the LWVWA Board, I would be one of the volunteer lobbyists, joining Marty Gibbins and Raelene Gold who I have been interacting with frequently over the past year. Raelene would continue as Issue Chair-Rivers and Water. I would need step out of the Climate Change Committee "chair" position for Jan – March 2022, but want to continue membership in the Committee.

I have been invited to join the Board of the Center for Responsible Forestry.

I am attending the DNR Board of Natural Resources meetings which are held the 1st Tuesday of each month (except for August) at 9:00 AM. The BNR sets policies to guide how the WA State Department of Natural Resources manages our state's lands and resources.

I am attending the Olympic Climate Action (OCA) meetings (OCA is a chapter of 350Seattle). OCA has a Forestry Management committee, which has been dormant for many months. I am helping revive/refocus the committee. The focus is HB 2528 (2020), and its ramifications in current legislation.

PNW Forest Climate Alliance - WA Forestry Working Group

I've established a Working Group to advance an Ecological Preserve proposal, applicable to WA State trust lands (proposal crafted by former land commissioners Peter Goldmark and Jennifer Belcher). Met with staff member of Pramila Jayapal on 9/24 to discuss possible Federal funding.

I've joined (as an individual) the PNW Forest Climate Alliance organization, and their Wildfire Working Group.

I've joined the LWVUS Wildfire group (most of the members are from CA).

I'm maintaining contact with Mason County Climate Justice (they have formed the Lorax Coalition).
