President's Message



Has America abandoned civility and good manners? And if it has, should we care? Civility, after all, means being a good citizen. Civility and good manners are not about which fork to choose for the salad. They're about how we treat one another in everyday life. And how we treat one another determines the strength of our society.

Boomers were the first generation to be fed oversize portions of self-esteem and self-entitlement. We must not be so self-absorbed that we forget the value of restraint and use it when called for. To survive, a society needs an amount of goodwill—people willing to treat others with respect and to give of themselves to the community. Civility is the lifeblood of a society.

The Internet has depersonalized our relationships. We email, instant-message and make anonymous comments online. We live in a time when anyone can say anything about

anybody. The shrillest voices are the ones that get the most attention. We shout our opinions because the media seems to tell us that's the way to be heard.

Bipartisan conflict is part of democracy. It's healthy. It's important to leave enough space for the other's opinion.

Today some politicians use nothing but tactics of attack or obstruction. Too often we have rigid adherence to a party line. Common sense, compromise and goodwill are vanishing.

If we cannot be civil, our quality of life deteriorates, society itself begins to fray and democracy is weakened. We get to the point where incivility escalates and crosses into violence. We all have an incentive to foster civility because the higher the level of civility, the lower the level of violence in a society.

In the past few years, hundreds of projects have sprung up across the country to foster civility. And more school districts are including manners and civility in their lesson plans. These are all attempts to improve the quality of life by increasing the quality of human interactions. They are small but important. I believe the best place to learn civility is by example from the older members of the family – ideally in the home. When we are young we pursue beauty, success. The young tend to be idealists. They feel people should behave the way they were taught by parents, schools, faith-based organizations and other influencers. Their idealism helps push society forward and helps us grow by opening our minds to new ideas and points of view often with positive results. Seniors may be more mature and have more wisdom about life in general, but we can be obstinate curmudgeons who don't accept change well.

Civility means we listen to and hear one another, and that we be willing to strike a balance to reach a compromise. After all, how well we treat other people is the basis of every ethical system.

19th Amendment and Founding of League Celebrations

August was a month full of celebrations commemorating the 100th anniversary of the certification of the 19th Amendment to our Constitution giving women the right to vote and the 100th anniversary of the founding of the League of Women Voters on February 14, 1920.

On August 22, a lecture sponsored by the Foster City Library and hosted by our League's VP **Patricia West Smith** featured author Dr. Ellen Carol du Bois who spoke of highlights from her new book, *Suffrage: Women's Long Battle for the Vote*. The Zoom webinar had 200 registrants.

During this exciting year celebrating women's right to vote, League members appeared by Zoom to receive proclamations from many jurisdictions recognizing and celebrating the anniversaries. Proclamations have been received from the U.S. House of Representatives (Congresswoman Speier), California State Legislature (Senator Hill and Assemblyman Mullin), towns of Hillsborough and Colma, cities of San Carlos, Pacifica, Burlingame, San Mateo, South San Francisco, Millbrae, Daly City, Belmont, and Foster City.

On Women's Equality Day, August 26, sponsored by County Supervisor Carole Groom, our Past President **Marta Bookbinder** was honored.

San Mateo County Ballot Measures

November 2020 Election

There are eleven local ballot measures on our ballots this November. Only one of them is countywide and will be voted on by every voter in San Mateo County. The other measures will be voted on only by residents of specific local cities and school districts. Measure V affects only the City of East Palo Alto.

City/County/School	Measure	Summary	
District			
County	Measure RR	This a county-wide measure to ensure funding for CalTrain. Voters in Santa Clara and San Francisco counties will also be voting on this measure. The measure would levy a 1/8 cent increase in the sales tax for the next 30 years. The approximately \$100 million raised would be used to preserve CalTrain service and add capacity and frequency of trains among other	
		things. This measure must pass by a 2/3 majority of votes.	
San Mateo – Foster City School District	Measure T	Measure T is a bond measure for the San Mateo-Foster City School District. It would authorize the K-8 district to purchase bonds in the amount of \$409 million to be used for such things as upgrading classrooms for STEM, providing art and music classes, repairing deteriorating infrastructure, and adding safety measures and equipment such as hand washing stations. It must pass by 55%.	
Jefferson High School District	Measure Z	For residents of the Jefferson High School District, Measure Z is a bond measure in the amount of \$163 million. Money would be used to improve student safety, campus security, and to renovate/construct classrooms at the district's 6 sites. It must pass by 55%.	
Daly City	Measure Q	For residents of the Jefferson High School District, Measure Z is a bond measure in the amount of \$163 million. Money would be used to improve student safety, campus security, and to renovate/construct classrooms at the district's 6 sites. It must pass by 55%.	
Half Moon Bay	Measure U	The City of Half Moon Bay is asking to raise its transient occupancy tax (commonly known as a bed tax, the tax guests in hotels pay per night) from 12% to 14% beginning on 1 July 2021 and to 15% on 1 July 2022. Funds garnered would be used for emergency services, disaster preparedness, supporting local businesses, and keeping public areas healthy and safe. It needs to pass by a majority of votes.	
San Bruno	Measure S	The City of San Bruno is asking passage of an ordinance that would impose an additional business license tax of 10% of gross sales receipts on cannabis businesses within the city if and when cannabis businesses are permitted within the city limits. Currently there are no cannabis businesses within San Bruno. It passes by a majority vote.	
	Measure X	Measure X is asking to raise its transient occupancy tax from 12% to 14%. If passed, the measure is estimated to raise an additional \$370,000 per year for the city. It requires a majority vote for passage.	
San Mateo	Measure W	Measure W would raise the transient occupancy tax within the City of San Mateo to 14%. It requires a majority vote for passage.	
	Measure Y	This is a citizen's initiative placed on the ballot in the City of San Mateo. It would amend the City's General Plan to maintain for 10 years voterenacted policies limiting building heights, residential density, and	

City/County/School District	Measure	Summary
		nonresidential building intensities. It would modify and maintain for 10 years an inclusionary housing requirement for residential projects. A majority vote is required for passage.
	Measure R	Measure R was placed before the City of San Mateo's voters by the City Council. It would create affordable housing near the three San Mateo CalTrain stations and on industrial/commercial lands. Preference would be given to nurses, teachers, public safety personnel, health care workers, and retail clerks. It would continue the height and density limits in single-family neighborhoods. It needs a majority vote for passage. Measures Y and R are competing measures.

Alert: USPS Vote by Mail Postcard Incorrect for Voters in California


Note: The following alert was published in the Thrive Alliance newsletter.

All Californians received a postcard from USPS that has *inaccurate* information regarding how to vote in California. Please help us spread the word that this is not correct.

To clarify:

- 1. If you are a registered voter, there is no need to request a mail-in ballot. Starting October 5, a ballot will be mailed to you. If you have not registered, do it before October 19 to receive a ballot in the mail. And you can always register to vote and vote at any Vote Center, up to and including Election Day.
- 2. Return postage is pre-paid first class.(Bonus: your I Voted sticker comes with your ballot!)
- 3. Ballots postmarked by Election Day will count if they arrive within 17 days.
