

Fortunately I had gone to the Ambassador Training at Peninsula People Power to see what would work for the League's Ambassador Training so I had my 30 second elevator speech on the census ready to go and tons of facts at my fingertips. This is one way that you can benefit from attending census training on Saturday January 11 from 10:30 – 12:30 at the Redwood City Library – becoming a trusted messenger on Census 2020.

Debby Maio from South County LWV and I have been working with Aparna Ramakrishnan, Census Coordinator for the San Mateo County Office of Community Affairs. Aparna is the trainer who will cover the following topics:

- Census basics
- Census 2020 Outreach including key points (the what, the why, and the how) and 5 common barriers and how to address them
- Messaging that includes security of personal information
- Communication principles for census outreach

Much of the time will be spent interacting in a Q & A format. It's fun, easy, and you'll learn a lot!

The goal of the training is to provide you with the tools to:

- Talk about the census with your circle of friends and family that might extend to your work colleagues, faith-based groups, and other groups that you belong to, such as a book club
- Table at League events, usually combined with voter registration
- Solicit pledges from people to complete the census
- Become part of a group of volunteers who will go out to hard to reach population groups coordinated by Thrive Alliance

I will send an Evite so we can get a ballpark figure of how many people are coming. Aparna is preparing booklets and has a surprise for everyone.

Getting Ready for the March 3 Primary: Political Parties

When you vote in a presidential primary election, it's important that you get a ballot for the political party that you support. This can be confusing as there are many political parties but only the following six parties are qualified parties in California:

• American Independent

NOTE: If you identify as an Independent/No Party Preference, chances are you do not support the American Independent party. An Independent voter is a No Party Preference voter. The American Independent Party is a conservative party.

- Democratic
- Peace and Freedom
- Green
- Libertarian
- Republican

So how do you make sure that you receive the correct ballot? The following guidelines will be in the *County Sample Ballot* that will be sent between Thursday, January 22 and Tuesday, February 11. This guide is mailed to each voter who is registered at least 29 days before the election.

Political Party Ballot Guidelines for the Presidential Primary

- 1. If you are registered with one of the above mentioned qualified parties, then you will receive a ballot for that party.
- 2. If you are a No Party Preference voter (Indpependent), then you can choose a nonpartisan ballot or a ballot from one of the following political parties:
 - o American Independent
 - \circ Democratic
 - o Libertarian

These three political parties have opened their presidential primary to No Party Preference voters. This does not change your registration as a No Party Preference voter.

To request one of these three ballots:

- Vote by Mail voters can request their ballot choice in advance in writing or by returning an unvoted ballot.
- Voters can request a ballot at a Vote Center on or before Election Day.
- 3. If you are No Party Preference voter and want a ballot from one of the following parties, then you must reregister with that party:
 - o Green
 - Peace and Freedom
 - o Republican
- 4. If you are registered with one of the six qualified parties but you want a ballot from a different party, then you must reregister.

The deadline to reregister is February 18. However, you can register conditionally up to and including Election Day at a Vote Center. To reregister online, go to http://www.registertovote.ca.gov.

Broadcasting of the San Mateo Community College Board Meetings

Background - At the June 12, 2019 SMCCD Board meeting, the presidents of both San Mateo County Leagues sent a letter to the Board of Trustees stating their concerns regarding the proposed modification of Board meeting minutes from detailed to action, without providing a live visual or an online video archive of each board meeting as most other county government agencies do. As the Leagues' letter noted,

..our nation's access laws are only as good as we, the people, demand that they be. Protecting the public's access to information, either written public documents or access to governmental meetings, is fundamental to the League's mission and, we believe, fundamental to the health of our democracy.

Three members of the Board, President Goodman and Trustees Holober and Manelkern supported the League's position and agreed that the public's perception of transparency and access were key objectives. Board President Goodman directed staff to immediately maintain audio recordings of meetings for longer than 30 days and to livestream audio recordings and make them available on the District website. Status - The audio recordings are now maintained indefinitely; however, the public must call the Board Secretary to request a copy, usually created on a CD. Online audio recordings are not yet available to the public on the District website, but appear to be available to staff in a Dropbox account. Observer Corps member, Maxine Terner, has been unsuccessful at finding out why these recordings are not publicly available on the District's website as per the Board's direction. Phone calls and emails to responsible staff have not been returned.

At the October 10 Board meeting, under public comment, Maxine, on behalf of the Observer Corps, requested an update on the status of broadcasting meetings. As a result, a follow-up discussion of broadcasting Board meetings was held on the October 23, along with a discussion of utilizing the former KCSM-TV space for public/local access broadcasting. Prior to this meeting, staff ran a test broadcast of a Board meeting using Zoom Conferencing. Trustees felt important functionality was not available using that format. They wanted the camera to be able to pan and focus on the speakers, be searchable, and have closed-captioning. President Goodman said he hoped staff would have this action item on the next meeting agenda. Staff said they would list various options and costs and bring them back to the Board for direction. To date neither of these items have been placed on an agenda.

Follow-up - Progress has been exceedingly slow on increasing the transparency and accessibility of Board meetings. It's now been over six months since the Board requested action on this item. The League's involvement was critical in helping the Board recognize the public's interest in making meetings available on-line to facilitate public participation and in retaining the audio of meetings. Online access to meetings will be especially important as the District is beginning the search process for hiring a new Chancellor. The Observer Corps will continue to monitor this issue, but it will require active public involvement to make action on this item a priority.
