# **President's Message**

The right to vote appears in the Constitution more than any other single right. It is mentioned five times in five different amendments. The freedoms of speech, religion, and assembly are all mentioned just once. Voting is often treated as a privilege, not a right. Laws have proliferated across America which erected hurdles between citizens and the voting booth. They do not respect voting rights' difficult road throughout our history.

President Johnson warned us that "every device of which human ingenuity is capable" has been used to deny this right. The 1965 Voting Rights Act, which prohibited discrimination in voting, was passed five months after the President's words, but his warning has unfortunately proved prophetic 55 years later.

Dozens of states added new voting restrictions before the 2016 presidential election. Many states enacted these laws after the U.S. Supreme Court's 2013 decision in Shelby County v. Holder including forcing discriminatory voter ID, proof-of-citizenship restrictions on eligible voters, and reducing polling sites and hours. Studies of such laws show they adversely affect people of color, students, the elderly, and people in rural areas. Today, spreading disinformation is a clear tactic, instilling fears of voter fraud with no evidence to discourage vote-by-mail. There is also the alarming attempt to slow down the US Postal Service with the objective of reducing the number of eligible, countable ballots.

As November's presidential election approaches, we must continue to do all we can to ensure the voting process is fair and accessible. Tuesday, September 22<sup>nd</sup> is National Voter Registration Day, a nonpartisan civic holiday in celebration our democracy. Nearly 3 million voters have registered on this holiday since it was first observed in 2012. National Voter Registration Day is a day of civic unity. It's an opportunity to set aside differences, enjoy the rights and opportunities we all share as Americans, and celebrate our democracy. **Spread the word, voting by mail is easy, safe, and secure; every vote must be counted and every vote counts.** Without regard to our political likings, all eligible voters should be able to vote and more people should be encouraged to register and vote. Voting should be easier, not harder. Too many people fought for too many years to have this right.

# San Mateo County Ballot Measures

#### **November 2020 Election**

There are eleven local ballot measures on our ballots this November. Only one of them is countywide and will be voted on by every voter in San Mateo County. The other measures will be voted on only by residents of specific local cities and school districts. Measure V affects only the City of East Palo Alto.

City/County/School District	Measure	SummaryThis a county-wide measure to ensure funding for CalTrain. Voters in Santa Clara and San Francisco counties will also be voting on this measure. The measure would levy a 1/8 cent increase in the sales tax for the next 30 years. The approximately \$100 million raised would be used to preserve 	
County	Measure RR		
San Mateo – Foster City School District	Measure T	Measure T is a bond measure for the San Mateo-Foster City School District. It would authorize the K-8 district to purchase bonds in the amount of \$409 million to be used for such things as upgrading classrooms for STEM, providing art and music classes, repairing deteriorating infrastructure, and adding safety measures and equipment such as hand washing stations. It must pass by 55%.	
Jefferson High School District	Measure Z	For residents of the Jefferson High School District, Measure Z is a bond measure in the amount of \$163 million. Money would be used to improve student safety, campus security, and to renovate/construct classrooms at the district's 6 sites. It must pass by 55%.	
Daly City	Measure Q	For residents of the Jefferson High School District, Measure Z is a bond measure in the amount of \$163 million. Money would be used to improve student safety, campus security, and to renovate/construct classrooms at the district's 6 sites. It must pass by 55%.	
Half Moon Bay	Measure U	The City of Half Moon Bay is asking to raise its transient occupancy tax (commonly known as a bed tax, the tax guests in hotels pay per night) from 12% to 14% beginning on 1 July 2021 and to 15% on 1 July 2022. Funds garnered would be used for emergency services, disaster preparedness, supporting local businesses, and keeping public areas healthy and safe. It needs to pass by a majority of votes.	
San Bruno	Measure S	The City of San Bruno is asking passage of an ordinance that would impose an additional business license tax of 10% of gross sales receipts on cannabis businesses within the city if and when cannabis businesses are permitted within the city limits. Currently there are no cannabis businesses within San Bruno. It passes by a majority vote.	
	Measure X	Measure X is asking to raise its transient occupancy tax from 12% to 14%. If passed, the measure is estimated to raise an additional \$370,000 per year for the city. It requires a majority vote for passage.	
San Mateo	Measure W	Measure W would raise the transient occupancy tax within the City of San Mateo to 14%. It requires a majority vote for passage.	
	Measure Y	This is a citizen's initiative placed on the ballot in the City of San Mateo. It would amend the City's General Plan to maintain for 10 years voter- enacted policies limiting building heights, residential density, and

		nonresidential building intensities. It would modify and maintain for 10 years an inclusionary housing requirement for residential projects. A majority vote is required for passage.	
	Measure R	Measure R was placed before the City of San Mateo's voters by the City Council. It would create affordable housing near the three San Mateo CalTrain stations and on industrial/commercial lands. Preference would be given to nurses, teachers, public safety personnel, health care workers, and retail clerks. It would continue the height and density limits in single- family neighborhoods. It needs a majority vote for passage. Measures Y and R are competing measures.
