#### Climate Crisis 2018

The news is full of stories about Climate Change these days. There was the recent gathering of global leaders in Paris, where California governors past and present attended along with business and banking leaders. And then there are the recent fires in California – is this a sign of what's to come? It is said that a single wild fire can release more CO2 than the state has gained from a reduction in emissions from fossil fuels.

Join the League for a timely and riveting discussion on Climate Change by climate reality leader Gary White. Mr. White, who was trained by former Vice President Al Gore, incorporates material from the award winning film, "The Inconvenient Truth," to discuss three questions about climate change. Do we have to change? Can we change? Do we have the will to change? This presentation will include current data on climate change, visuals of extreme climate events and materials on renewable energy, what is available today and what is coming next.

Gary White is a climate activist who informs organizations on the perils and solutions to climate change. He holds a M.S.W. from UC Berkeley and an Executive Education Certificate in Corporate Social Responsibility from Harvard University.

The success of the League's mission statement, Making Democracy Work, rests on the involvement of each American citizen in our political process. As League members, we are in a position to promote education and advocacy on a wide range of issues. As you ponder your resolutions for the new year, I urge you to take some time and consider how you might assist the League in its efforts. We have a wide range of jobs from serving as a board member to helping as a greeter at one of our events. How you choose to get involved will provide you with an opportunity to interact with League members and with the public.

A primary focus of our League this winter and spring will be to educate voters in San Mateo County on the new voting system that will be implemented through the Voters Choice Act (VCA). The VCA committee is targeting groups with which to partner and to provide education. We are using a version of the presentation that was presented at our September meeting on the VCA. We are working with the San Mateo County Elections office and we hope to have a representative at each of our meetings to help answer audience questions.

The Election Administrative Plan (EAP) draft for San Mateo is coming out on January 4. This plan will provide details on how the VCA is to be implemented. Among other things, it will include the location of voting centers and drop-off boxes. There is a public hearing on the EAP draft on January 18. Our League will continue to have a presence at the CSM Farmer's Market from 9:30 – 11:00 on the second Saturday of every month. In addition to registering voters, this is an opportunity to inform voters on the new voting model in San Mateo (VCA), provide information on issues in the upcoming primary, informing the public about our meetings, handing out bookmarks publicizing the League's Voter's Edge website where voters can get the facts on candidates and ballot propositions and measures, and whatever else comes up. If it is raining, the event will be cancelled.

#### **Civil Discourse Training: Focused Discussion Method**

Join us for training in the Focused Discussion Method on Saturday, January 20 from 10:30 – 12:30 at the League office. This

workshop will be conducted by the LWV Santa Clara County Council Civil Discourse

Committee.

The Focused Discussion Method is a progression of questions that takes a group on a journey of consciousness. It is useful for reflecting on experiences such as a movie, a project site visit, a planning session, a work day, a story, or any common or extraordinary life event.

The method works with a series of questions that

- Directs the thinking of the group involved toward making a decision
- Uses a specific sequence of questions every time
- Is adaptable to any situation and group
- Takes participants on a four level journey of awareness:
  - Objective Getting the facts
  - Reflective Illuminate emotions, feelings, and associations
  - Interpretative Highlights values, meaning, and purpose
  - Decisional Decisions regarding future resolves allowing individuals to decide their relationship and response to the topic and the discussion
- Ordered very carefully so that a progression in consciousness takes place

The Focused Discussion Method is the first tool developed by the Technology of Participation Methodology (ToP) which "provides structured facilitation methods to help groups think, talk and work together." As reported in past *Voters*, a coalition of regional leaders, transportation experts, employers, nonprofit groups, and others has been brought together to find a solution to San Mateo County's transportation issues. While the League does not have a position on any solution, including a possible sales tax measure in 2018, the League is represented on the Stakeholder Advisory Group. Barbara Wallis (LWV South SMC) and Jackie Jacobberger (LWV No & Central SMC) are the League representatives to this group.

The group agreed that the community is an important part of the process. Recently you may have received a brochure with a survey seeking input from residents on their top priorities for improving transportation in San Mateo County. We hope you will take time to fill it out and return it promptly. (It is postage paid so no need to look for a stamp!)

If you can't find the brochure or prefer to do it online, take the survey at <a href="www.GetUsMovingSMC.com">www.GetUsMovingSMC.com</a>. A plus for taking the survey online: it allows everyone in your household to express an opinion in case you have different opinions. It is important to do it now. The Stakeholder Advisory Group will review the responses as well as potential project proposals in February and we want your voice to be heard.

#### Big News on Make it Fair!



After almost 40 years, the LWVC is seizing the moment to close the corporate loophole in Proposition 13 that keeps too many companies from paying their fair share.

Since 2015, the League has been a part of the **Make It Fair** coalition—which today filed an initiative to do just that. The League campaigned against Prop 13 in 1978, and we're excited to continue our leadership and help pass this critical reform.

Californians deserve world-class schools and universities, quality healthcare, safe neighborhoods, and affordable homes. That is what our taxes should pay for. It's past time to close this loophole and stop letting big business rob our schools and local communities, impoverish future generations, and endanger California's economic future. The California Schools and Local Communities Funding Act of 2018 is the responsible, fair, and long-overdue tax system to ensure California can thrive now and in the future.

The California Schools and Local Communities Funding Act of 2018 will create a "split roll"; non-residential, non-agricultural commercial property will be reassessed on a regular basis. This will lead to an estimated increase in property tax of over \$11 billion per year—revenue that will go directly to schools and local governments.

We are excited about this legislation; it's long overdue. We'll be talking about the campaign in the coming months and reporting updates on the legislation.


