Census 2020

Speaker: Perla Ni CommunityConnect Labs

The job of the Census is to count the entire United States population every ten years. The data collected by the census determines the number of seats each state has in the U.S. House of Representatives and is also used to distribute billions in federal funds to local communities. Counting everyone in our community is vital whether you are a citizen or not as this will determine funding for many federal programs in San Mateo County.

San Mateo County is working with CommunityConnect Labs, along with partner agencies and non-profits, to expand the list of addresses for Census 2020. Currently, the county is hiring local community members to canvas neighborhoods looking for addresses to add to the Census Master Address File. Later, the Census will be hiring numerators to knock on doors to take the census.

Join us to learn more about Census 2020 and how you can be part of this important process.

President's Message



The June 5th primary may seem distant but voting begins on May 7. On May 7, a mail-in ballot will be sent to every registered voter and the first four Vote Centers open in East Palo Alto, Redwood City, San Mateo, and South San Francisco. Three days before

Election Day, all 39 Vote Centers will be open. On May 8, 29 drop-off ballot boxes will be open. What probably won't be open is the neighborhood polling place where you last voted. However, there are more options and more flexibility for you to determine how, where, and when you want to vote.

Change does not usually come easily, so we are incorporating Voter's Choice Act 101 at several public Pros & Cons events, which are listed below in Pros and Cons and Voter's Choice Act 101 Presentations, p. 3. If you would like to discuss the issues with other members, please attend our Brown Bag Lunch with the League on May 9 at noon in the League office.

It's hard to believe that counting people can become a controversial issue, but already the 2020 census is becoming a hot button issue. Even before the proposal to put a citizenship question on the ballot was raised, Assemblymember Marc Berman, chairman of the Assembly Select Committee on the Census, expressed concerns of getting an accurate count of the immigrant community. The state budget has allocated \$40.3 million and Assemblymember Berman hopes to raise another \$40 million from philanthropic sources. This is where the League can come in. At the local level, the League can provide education and outreach on this issue. In response to Commerce Secretary Wilbur Ross' decision to include a question pertaining to citizenship in the 2020 Census, LWVUS President Chris Carson wrote:

For more than 200 years, the Census has collected information about the geographic distribution of our population so we can provide representation and invest in our communities equitably. A fair and accurate Census is essential to the way the federal government allocates resources for infrastructure, education, and transportation. Census data is critical when determining resources for fire, water and trash collection. Without a complete count of our nation's people, businesses will not have the tools to make sound investment decisions that keep our communities thriving.

At our May 15 meeting on the 2020 Census on, we hope to lay the groundwork for taking action and providing a valuable service to our San Mateo Community. One or two of you may even want to take a leadership role on this issue and spearhead this project.

A big thank you to all who have turned in your petitions for the Schools and Communities First Funding Act, but guess what? The deadline has been extended! The powers to be decided that it would be better to have this initiative on the November 2020 ballot because the higher turnout in a presidential year would make its passage more likely. This will also allow more time to fundraise. See Schools and Communities First Initiative, p. 6 for more information. So keep gathering signatures and we will keep you informed.

Ballot Measures on the June 2018 Ballot and the Voter's Choice Act

In the June 5, 2018 primary election there are five State Ballot Measures and one Regional Ballot Measure on our ballots. All of them have been placed on the ballot by the California State Legislature.

- Proposition 68 is a bond measure that would raise approximately \$4.5 billion to fund various water projects including coastal protection, parks and climate change among others.
- Proposition 69 requires that certain new transportation revenues be used for transportation purposes only.
- Proposition 70 requires a legislative supermajority vote to approve the use of the cap-and-trade reserve fund beginning on July 1, 2014.
- Proposition 71 would change the effective date of ballot measures and referenda approved by a majority of voters to be the fifth day after the Secretary of State files the "statement of the vote." In past elections this has taken an average of 37 days.
- Proposition 72 would exclude newly constructed rain capture systems from property-tax reassessment beginning January 1, 2019.
- Regional Measure 3 would increase the toll on the seven state-owned bridges, excluding the Golden Gate Bridge, \$1.00 in 2019, \$1.00 in 2022 and \$1.00 in 2025 to be used for specific transportation projects.

The June 2018 primary election will also be the first election where San Mateo County will implement the *Voters Choice Act* (VCA). The VCA will give residents more ways and more days to vote. All registered voters will receive a postage paid, mail-in ballot this May. You can mail it in, take it to a secure Drop-Off Box or visit any Vote Center to drop it off or vote in person. Most neighborhood polling places will no longer be used for voting.

The Observer Corps – Building Communities Together

Our League's Observer Corps has completed its review of the City of Burlingame. The review focused on access and transparency, and it assessed the following:

- How successfully the public can engage, connect with their local government
- What are the current strengths and obstacles in successfully communicating with the City to find the right department, obtain information, and solve a problem
- What are best practices achieved that can be shared with other public agencies
- How can the public help by understanding their role and becoming informed meaningful contributors

The Observer Corps Team found the City of Burlingame excellent in meeting its residents' access expectations with transparency and accountability. The City achieved a 99% rating based on the actual findings gathered from observation and documentation. The City of Burlingame was congratulated by the League of Women Voters on an excellent performance! The openness and honesty assured the team the City's approach was based on a shared governance belief with those who reside in the City. It is hoped the City of Burlingame benfitted from the corps' report, and that they shared it with their City Council and staff who demonstrated a very inclusive leadership approach and a cohesive performance in their service to residents.

The Observer Corps will be doing similar observations during the upcoming weeks of the following governmental agencies: the San Mateo County Harbor District, the South San Francisco Unified School District, and the San Mateo County Community College District.

Local Jurisdictions Consider District Elections

Many local cities, school districts and other government jurisdictions in California have received a legal threat alleging that their at-large election systems violate the California Voting Rights Act. The letters were sent by a Southern California attorney, Kevin Shenkman, representing the Southwest Voter Registration Education Project. The letters threaten legal action if the jurisdictions do not voluntarily adopt district elections. The proponents of district elections argue that this system impairs minority groups' ability to elect their preferred candidates, and campaigns for smaller areas are less expensive and encourage greater participation.

Two cities in our League's area, South San Francisco and Half Moon Bay, are the latest to receive these letters and their city councils are considering the shift to by-district elections. Establishing these elections requires that officials draw electoral maps dividing the city into districts of approximately equal populations. Council members must live in the district and would be elected by the voters in that district.


South San Francisco adopted the resolution of intent at its April 11 meeting, thus protecting the city from expensive litigation. Hearings to receive public input on the districts are scheduled for April 25 and May 9, with hearings to comment on the proposed maps on May 23 and June 20. A hearing on the ordinance will be held on June 27, with adoption of the ordinance scheduled for July 11.

The Half Moon Bay city Council has until April 20 to adopt a resolution of intent to switch to district elections and until July 19 to adopt the ordinance declaring the district maps.

Other Bay Area cities are in the process of transitioning or have switched to district elections including Menlo Park, Concord, Fremont, Martinez, Antioch, and San Rafael. Other jurisdictions that have adopted or are considering district elections are the San Mateo Community College District and the San Mateo County Harbor District and some school districts in other counties in California. The voters adopted elections by district for the San Mateo County Board of Supervisors in November 2012.

Watch for developments in your city or school district and attend public hearings. The League does not have a position on any of these changes and members cannot speak using the League's name. However, members are always encouraged to be informed, involved, and to speak as individuals about issues in their local communities.

Action Report

LWVUS

A big concern is the census. Getting an accurate count is critical, for the count determines how many representatives each state gets, how some federal funds are distributed, and many other things. Even people who are not citizens, people who are not registered to vote, people who do not vote, and all children should be included. Everyone needs services of one kind or another. We need to know each individual who exists and where they are. That is why asking whether someone is a citizen should not be included on the census form: it will affect the count and lead to an undercount. Noncitizens fear that the census answers will not remain confidential either through hacking or sharing with other agencies. The League is asking that we let our federal representatives know that we want an accurate count of all the people who live here, regardless of their citizenship status. The Constitution does not specify that citizens should be counted in the census; only persons.

LWVC

The Legislature has put five propositions on the ballot. The League supports four and opposes one. You can find information on the propositions and the pros and cons at <u>lwvc.org</u>. The website has been redesigned and is very user friendly.

Schools and Communities First Initiative

The League and coalition members' proposition, Schools and Communities First, is out to the public for signature gathering. However, the target for the initiative is the November 2020 ballot. The proponents of the initiative feel that they will benefit from a larger voter turnout in a presidential election year and this also provides more time to raise money. The opposition has about \$100 million to spend defeating this initiative. The deadline for returning initiative forms is extended to July or August.

How many signatures are needed to qualify? This year, the answer is 585,407 for an initiative constitution amendment. But some signatures will be invalid, so campaigns usually try to collect up to 30% more than this number. At this date, more than 300,000 signatures have been collected. So keep talking to people and getting signatures!

Get Us Moving is a collaborative effort between community organizations, SamTrans, the San Mateo County Board of Supervisors, and partner agencies and groups to develop a San Mateo County Transportation Funding Plan. Although the League has taken no position on this effort, Jackie Jacobberger (North & Central SM County) and Barbara Wallis (South SM County) attend the meetings to represent the League.

Early this year, San Mateo County residents received a survey asking about transportation needs and over 14,000 people responded either by mail or online.

Now it is time to move forward, based on the survey results, and develop the funding priority plan. You can help again.
