## Board Report - August 20, 2019

The 2019-2020 Board at its first meeting discussed the following matters:

1. Voted to accept the Marcomm plan, a marketing strategy that unifies all our activities to ensure consistency and focus on key issues. Voter Service is the first year's target.

2. Reviewed the Directions to the Board given by members at the 6/22/19 Annual Meeting. As a result, it will be working on developing measurable ways of reporting progress on the Issues for Emphasis each year to the membership. It will be discussing the formation Committee at its September Board meeting to provide useful background information and recommendations to the Board.

The Board will continue to encourage diversity amongst our new members. The Board will work to encourage welcoming new members by seasoned members through friendly conversations and offer rides to League events; encourage members to explore the website; continue to ask for contributions of articles for the newsletter and website from members; and urge computer-literate members to mentor those who need help with their computers.

3. Agreed to join with LWVSD's 100<sup>th</sup> LWV Anniversary Committee as they have already developed a comprehensive calendar of celebratory events.

4. Planned for the 9/7/19 Kick-off meeting about Census 2020.

5. Received an update from Social Policy Director Bill Loftus regarding the current status of the statewide Homelessness Task Force, which we advocated for at the June League of Women Voters of California Convention. Also learned a plan is being developed to allow members to donate new items for the new apartment building for homeless families being opened by Interfaith Community Services at our 9/7 meeting.

6. Began research on how to protect member privacy related to membership lists.

7. Authorized the purchase of VotersEdge bookmarks in Spanish and English.

# Revisiting LWV Regional Transportation and Housing Positions

The San Diego League's Public Policy Committee continued work at their monthly session on August 12 to frame consensus questions which could lead to revising the League's city and regional positions. The Committee is planning for consensus sessions in the fall. North County League members Alec Jolly (observer for SANDAG and NCTD), Liz Kruidnier, and Mary Thompson attended.

Transportation - This session focused on ensuring language from the existing REGIONAL position on transportation was included in the consensus questions both Leagues will consider in the fall. Specifically, discussion was on environmental qualities such as Climate Action Plan goals and open space considerations and transportation "availability" for all income levels and schedules.

Housing - The San Diego League will also be considering consensus questions on housing such as development of underutilized land, increased density, inclusionary housing, in-lieu fees and tenant protections. These issues would NOT affect LWV North County San Diego, unless the North County League chooses to reexamine its Housing positions at this time.

Work to finalize the questions will continue at the next Public Policy Committee meeting on Monday, September 9, at 9:30 am at the <u>SD League Office</u>.

### Social Services Network of Support for Homeless Residents and others

It could be helpful to our membership to have some knowledge of the various governmental agencies and nonprofits that provide Social Services to San Diego County residents. The challenge for everyone is to maintain the currency of the information because of funding changes as well as personnel.

In terms of "Big Picture" for policy makers in our County, there are several "layers" of governmental and nonprofit assistance. They include the Regional Task Force on the Homeless, the Alliance for Regional Solutions (North County), SD County Health & Human Services and 2-1-1 which is a free 24/7 phone service that connects callers to more than 6,000 community, health, and disaster services. In future VOTER issues or on our website we will be able to define more clearly how these agencies collaborate and where they are located to better serve those in need in our County.

## How League Members Take Action

First, you need to know who represents you in Washington, Sacramento, San Diego County and in your own City, School District, Water District, etc.

Go to the Registrar of Voters website: www2.sdcounty.ca.gov/rov/Eng/Voters.asp and fill out the form "Your Voter Information."

Then you can print/save a list of the districts you are in. Several cities and school districts have changed from having district-wide elections to having created several voting districts. You can only vote for the candidates running in your district.

Knowing who represents you is essential if you want to lobby/write the correct official. Generally, elected officials pay more attention to their own constituents. You may of course write to your representatives about anything you want.

The State and National LWVs as well as your Local League—LWV North County San Diego—will from time to time ask you to "take action." This usually means they are asking you to contact your elected official on an issue important to League. In addition to requesting your help, the LWV will explain why the issues are important and what you should do.

The Leagues as organizations, lobby on many governmental levels, however, it it is also crucial for officials to hear from as many of their constituents as possible. Your voice is essential.

If you go to the LWV of the United States (LWVUS) website <u>www.lwv.org</u> or if you go to the LWVC website: <u>www.lwvc.org</u> you will find many other opportunities to be an influence for good government.

On our website <u>www.lwvncsd.org</u> there is list of all issues—local, state and national that you can lobby on. It just takes a few clicks on your computer or tablet. It's that easy!

# LWVC Convention 2019 May 31 - June 2

Eight delegates from our League attend the LWV of California's (LWVC) biennial convention in Pasadena. Our delegates were: Suzanne Carneiro, Bill Loftus, Anne Omsted, Norelynn Pion-Goureau, Roni Seay, Rita Soza, Nancy Telford and Jennifer White. It proved to be a learning experience for both seasoned and brand new League members.

The highlight of our delegates' experience was working very hard on getting the other delegates and State Board Members to support our effort to create a task force on Homelessness in California. We attracted a standing-room-only crowd to our 7:30 AM Caucus on Homelessness led by Bill That Caucus yielded a list of League Loftus. members willing to serve on a Homelessness State Task Force. Our president, Anne Omsted, then approached the microphone at the next General Session and, on behalf of both San Diego Leagues, made a formal request of the LWVC Board of Directors to establish a State Task Force to study all the issues related to homelessness. We hope that the task force's recommendations will yield a vote for a position on Homelessness at the 2021 Convention

We divided up the 15 caucuses and 16 workshops so that all sessions were attended by at least one of our delegates. Many attended a pre-convention workshop entitled "Lets Talk about Power: Exploring Race, Identity Formation and Organizing" which gave us new ways to think about diversity. Diversity in League was a recurring theme at this Convention—whether by race, sex, ethnicity, sexual orientation, socioeconomic position, or age.

At the plenary sessions we voted for the 2019-21 LWVC Officers and Directors, Budget, Positions and Issues for Education and Advocacy. There were outstanding speakers as well. It is accurate to say we worked tirelessly to make a difference.


> going on to the LWV National Convention in 2020. Hope to see you there!
