Governor Gavin Newsom's Budget Puts a Focus on Early Childhood

The governor's January 2019 budget proposal includes many provisions that advocate for early childhood education and well-being. The emphasis is on mitigating many ill-effects of poverty. The statistics indicate that 1 in 8 children living in California do so in poverty. Combined with the facts that the cost of living in California is so high, housing costs are excessive as well as the cost of childcare, it is encouraging that the new Governor has established his focus on the well-being of young children and families which might be characterized as a down-payment on "a robust childcare and development system". Some of the provisions in the Governor's 1.8-billion-dollar budget proposal include:

- 1. Full day kindergarten
- 2. Universal pre-school
- 3. Work-force development
- 4. Home visits
- 5. Early screening to determine needs for early intervention
- 6. Paid Family Leave.

It has been a busy two months since my last message! Here is some news of what we have done and will be doing.

<u>The 34th Annual Great American Write-In</u>: By the time you read this, on March 23rd several Coast volunteers will have staffed our now-traditional table at the entrance to the Write-In, where we offer any Orange County participant in the Write-In an individualized list of her/his electeds, with their contact information. This year we provided more than 150 Write-In attendees with these individualized lists.

2020 California Citizens Redistricting Commission Public Information Events, April 7 & 28, 2019: The League has long worked to improve redistricting practices, and the LWV of California was instrumental in the major effort leading to the establishment of California's Citizen Redistricting Commission. The first Commission "drew the lines" after the 2010 Census and a new Commission is being formed to redistrict state assembly, state senate. Congressional and Board of Equalization districts after the 2020 Census. For more information, go to the Citizen's Redistricting Commission page of the State Auditor's website: http://shapecaliforniasfuture.auditor.ca.gov/ The LWV of Orange County – our Inter-League Organization (ILO) – is working with a group of other OC organizations to host two presentations designed to inform under-represented communities about the opportunity to apply to serve on the Commission. Our Voter Service Chair Michele Musacchio is on the planning committee and Coast will be partially staffing the April 7 event. League members are not really the "target audience," as we are well aware of the existence of the Commission and our demographics don't generally match the description "under-represented." However, we anticipate that we will continue to work on outreach efforts and certainly on informing our own members and other groups about how to apply.

63rd Meeting of the UN Commission on the Status of Women, March 9-22, 2019: In the last *Voter* our member Kathleen Montgomery wrote of League work with the Commission. As I write, the meeting is underway in New York and Kathleen, who serves as a member of the LWVUS Observer Team, will be on her way home soon. She emailed me this morning and I want to share part of her message with you: "I'm winding up my week in New York and wanted to let you know how extraordinary this experience has been. I can't wait to tell you all about it. Being surrounded by women devoted to human rights around the world has been truly inspiring. The LWV delegates are wonderful and remind me of our great members in Orange Coast."

We can be proud of the work of our League of Women Voters, from Orange County to Sacramento and Washington DC and even with the United Nations!

On Wednesday, March 6, 2019 Coast member Mary Ann Gaido was a member of a panel presentation at Golden West College's International Women's Day Breakfast. The League was invited to participate and Mary Ann spoke about how her work for the League as an observer of the Irvine City Council in the early days of the city led to her becoming a member of the planning commission and then a member of the City Council and continuing advocacy and leadership in public life.

Legislative Interview Reports - Update

As we highlighted in the February-March issue of <u>The Voter</u>, every year, the LWVC encourages local League members to interview their state legislators. This is an opportunity for legislators to share their priorities with League members and develop an understanding of League positions and priorities. Local League members can discover how state legislative actions are going to impact their communities.

This year there are three questions dealing with specific legislative arenas in which the League of Women Voters of California is interested and active:

- State and Local Redistricting;
- Public Education Closing the Achievement Gap; and
- Water Resources

In the last couple of weeks our Team has interviewed one of our Senators and the staff of an Assemblymember, to obtain responses to the questions on these topics. The resultant reports from these interviews are sent to LWVC for analysis and compilation.



LWVUS Making News

Membership Update: Thanks to everyone who worked with your Leagues and our office to complete roster updates by the January 31 deadline. We are proud to report that membership grew by 10% last year, which is consistent with recent years. One big standout in our membership numbers was in the student category, where membership increased by more than 150%! We attribute this huge influx to the waived PMP for student members, which continues through 2020, as well as the increased outreach Leagues are doing to young members in their communities.

H.R. 4: Voting Rights Advancement Act Introduced!

LWV is proud to support the Voting Rights Advancement Act (VRAA), which would restore the VRA by updating the coverage formula to determine which states and localities must pre-clear election changes with the Department of Justice. The bill would essentially restore section 4 of the VRA, which was gutted in the Shelby County v. Holder decision. Read our statement on the VRAA.

HR1 Passes in the U.S. House

HR1, the For the People Act, <u>passed in the U.S. House</u> on Friday, March 8, and LWVUS staff was there to see it! This landmark legislation is the biggest improvement to our democracy since the Voting Rights Act. The League is now focused on advocacy efforts in the <u>U.S. Senate</u>.

League Urges Support for HR1 Companion in U.S. Senate

The League recently sent a memo to the U.S. Senate urging members to support and co-sponsor a companion bill to HR1, the For the People Act. Complementary democracy reform proposals in both the House and Senate will show a unified approach in Congress and are an important step forward in repairing our broken political system and our destructive campaign finance system. The League supports legislation led by Senator Udall that mirrors provisions of this historic bill.

LWVUS Includes Climate Change Position in Impact on Issues

The LWVUS Board approved the following position on climate change:

The League believes that climate change is a serious threat facing our nation and planet. The League believes that an interrelated approach to combating climate change—including through energy conservation, air pollution controls, building resilience, and promotion of renewable resources—is necessary to protect public health and defend the overall integrity of the global ecosystem. The League supports climate goals and policies that are consistent with the best available climate science and that will ensure a stable climate system for future generations. Individuals, communities, and governments must continue to address this issue, while considering the ramifications of their decision, at all levels—local, state, regional, national, and global.

This position will be included in the next version of Impact on Issues when it is published later this Spring.

LWV Supports Passage of HR8, the Bipartisan Background Check Act

The League of Women Voters joined the Brady Campaign and other groups to support HR8 in the U.S. House. HR8 will require Brady background checks for all firearms, which is a provision supported by 97% of Americans.

How the Daughters and Granddaughters of Former Slaves Secured Voting Rights for All Historian Martha S. Jones tells the stories of the suffragists who were often overshadowed by the big names often associated with the movement because of their race. Activists like Frances Ellen Watkins Harper, Eliza Gardner, and Julia Foote are figures who stand out, in Jones's words, as "unparalleled advocates of universal suffrage in its truest sense. LWVUS Welcomes New Female Members of Congress

On March 11, LWVUS hosted a reception for new and seasoned members of 116th Congress. We had 5 members who attended and spoke during the reception and local League leaders, including our Lobby Corps volunteers, attended to salute the legislators for their work in the first 60 days of this historic session. LWVUS Climate Change action: League Submits Amicus Brief in Juliana v. U.S.

LWVUS and LWVOR submitted an <u>amicus brief</u> to the 9th Circuit in the case of *Juliana v. U.S.* The brief was submitted in favor of the young plaintiffs arguing that it is the job of the federal government to protect them from the damaging effects of climate change. The brief also argues that it is the job of the courts to address claims that are asserted by the politically powerless and the courts should act to fulfill that vital function by allowing the merits of this case to proceed to the trial process.
