Voter Service Report on the November 6, 2018, Election

What an historic midterm election turnout in Orange County! At 71%, it was the highest midterm turnout in nearly half a century. LWV of Orange Coast is proud to have been part of the drive to get all voters out, regardless of party preference. How did we do it? Step by step.

Voter registration is just the first step on the path to the polls. Next comes learning about who's running and what's on the ballot, and making a plan to cast a vote: vote-by-mail, early voting in person, or voting at a polling place. Our League knows that after they sign that registration form, voter education is key to making a new voter into a regular voter, who in turn engages others. We couldn't fit all our Voter Service activities in one article, so here's a sampling:

Our members were out in force, presenting ballot Pros & Cons, drumming up candidate participation in the state League's Voter's Edge ballot lookup tool, distributing the Easy Voter guide to community centers (in four languages), running voter registration drives, even getting interviewed on the radio (go Becky!). We forged and strengthened community partnerships, including at Google, the OC Alliance for Just Good, Temple Beth-El, San Joachim parish, Junior League, UCI, and the Registrar of Voters (ROV) office itself. All that work paves the way for new and ongoing LWV projects in voter education and civics.

The Voter's Edge web tool was packed, with 462 active candidates in Orange County. Chair Petti Van Rekom heroically trained and led her ten League volunteers through questions and candidate-cajoling to get candidate participation up to 49%. Petti deserves a big share of the credit for informing OC voters. Many of us engaged candidates personally at candidate forums throughout South County, shaking one hand while putting a Voter's Edge bookmark in the other!

Voter Service co-chair Vickie Chenevey conducted our League's annual voter registration training with the OC ROV in April, and our Pros & Cons training in September. That kicked off a run of over 30 Pros & Cons presentations right up until Election Day. Attendance was always high, and for some groups with monthly program events, our presentation generated their highest turnout of the year! Our president, Becky Newman, gave a rapid-fire interview on the Ask A Leader KUCI radio show covering the ballot initiatives. People across the nation tuned in.

Special thanks go to our speakers and assistants: Alice Schreiner, Anne Stone, Becky, Riley Newman, Christine Collins, Christine Moore, Diane Nied, Gail Benda, Laurie Jacobs, Mary Leigh Blek, Michele Musacchio, Nancy Kriz, Pat Heilig, Patty Santry, Phyllis Maywhort, and Steph Campbell. They spoke to a range of groups from a High School Special Ed class to the UCI Black Faculty and Staff, along with senior centers, women's clubs, community action groups, churches, temples, business groups and political party clubs. Every one of them wants to see us in the next election cycle. Carolyn Martin and Steph set up and scheduled our missions.

Voter Service Got to Go to Google! Michele presented Voter Registration training, and with Nathan Gold registered over 20 Google employees and collected donations for the LWVC Ed Fund. Michele's afternoon presentation to an audience of Google engineers covered Voting

Myths, how to use Voter's Edge, and ways for STEM professionals to become involved in civics and registering voters.

National Voter Registration Day was spent at the Blackmarket Bakery voter registration drive with volunteers Kris Kerrigan, Jan Dye, Al Abalos, and Michele. We handed out delicious cupcakes to all who stopped by, most of whom were surprised to learn they could vote early all over the County.

Teamwork with the AAUW via LWV member Marge Sosa had us very active on the Saddleback Community College campus, sharing a voter registration table almost every week from September through October, with Trudy Josephson, Marilyn O'Brien, Al, Jan, Diane, Becky, Michele, Anne, and Laurie. The Voter's Forum with AAUW at Saddleback Community College brought over 200 students by our voter registration table. Becky and Laurie also gave Pros & Cons presentations to the pre-law students on Saddleback College's "Don't Ghost the Vote!" Early Voting pop-up day on Halloween.

How did we help student voters who are already registered? We created a new tool to help them plan: "reminder" postcards at Saddleback, UCI, and at three high schools. Each postcard edition featured a calendar timeline, with the nearest Early Voting center and pop-up Early Voting dates. We personalized the cards with their polling place address and the Voter's Edge website. A week later they had all their options arrive on one card!

More colleges, more voters! Voter Service worked many hours behind the scenes and on the ground at UCI with the Associated Students at their Civic Engagement Fair. We led the drive at UCI Law, too. Coastline Community College held a Voter Registration Drive with a student engagement session by Michele on California Government and Voter's Edge. Nathan was such a hit setting students up at computers to register that Coastline offered him a job with Student Outreach! Thanks also to volunteers Jan, Al, Christine Collins, and Elaine Cheslow. Judy Standerford posted our photos on Instagram and Facebook, our major social media outlets.

High-schoolers are voters, too. Trudy, Michele, and Julie Tapp put together our high school voter registration program at Laguna Beach HS and the Sage Hill School, from administration outreach to student drive. We learned that students registering other students and showing them Voter's Edge is our best bet to get them to register reliably and have voter information. We registered over 30 voters at each school during an outdoor lunch. Not bad for an hour!

Voter Service is tooling up for more civics programs for these future voters, connecting Coast high schools to the OC ROV's MyBallot Program and to statewide programs that reward and recognize student civics engagement. One such program, Project Soapbox, had our own Steph Campbell and Linda Moon representing our League as judges. Other programs we're looking at are the Voter Girl project pioneered by the LWV of Kent in Ohio in collaboration with the Girl Scouts; and the Harvard Case Method Project. Please reach out to Trudy Josephson if you want to get involved in adopting high school civics programs. The path to the polls continues to 2020!

LWV participation in the 63rd United Nations Commission on the Status of Women, March 9-22, 2019! By Kathleen Montgomery

In 1945, at the UN Charter Conference, the League of Women Voters was invited by President Harry Truman to serve as a consultant to the U.S. delegation. Since that time, the League has continued its presence at the United Nations through its UN Observer Corps. Our role further developed in 1997 when the United Nations Economic and Social Council (ECOSOC) granted special consultative status to the League. The UN Commission on the Status of Women is part of the UN ECOSOC.

The UN Observers carry on the League's finest traditions and pursue an ever widening agenda that solves problems by partnering with others to engage in civil discourse to clarify the issues, identify best practices, implement strategies and measure the results of the League's initiatives. The UN Observers foster cooperation with UN Member States, UN Agencies and other UN accredited Non-Governmental Organizations (NGO), academia and the private sector.

LWV has been an annual participant in the UN CSW gatherings, sending a delegation of up to 20 LWV members as UN Observers. *Kathleen Montgomery* of LWV Orange Coast has been selected as one of the 20 delegates to this year's UN CSW. She will have the opportunity to interact with LWV delegates and delegates from other NGOs and member states, and to attend many events during the course of the CSW. A major set of relevant events are those organized by the NGO CSW/NY, which will sponsor sessions that inform, engage and most of all inspire grassroots efforts and advocacy needed to empower women and girls. Kathleen is especially looking forward to participating in the LWVUS-sponsored event entitled, "Critical Mass to Gender Parity—Women in Decision-Making Do Make a Difference!" Making Democracy Work: An Equity Lens

The League of Women Voters of California is working to apply an "equity lens" by analyzing our processes and foundational assumptions from the perspective of how they impact marginalized and underrepresented individuals and communities. To that end, this kit weaves in explanations of ways the legislative interview questions touch on issues of diversity, equity and inclusion.

In that spirit, we encourage you to proactively and mindfully form interview teams that include young members, people of color, and other individuals from underrepresented groups. With legislative interviews you have the opportunity to help develop League leadership that is truly representative of California's democracy, and to add the richness of diverse perspectives to your advocacy work.

Every year, the LWVC encourages local League members to interview their state legislators. This is an opportunity for legislators to share their priorities with League members and develop an understanding of League positions and priorities. Local League members can discover how state legislative actions are going to impact their communities.

Use the interview to become better acquainted with your legislator and to emphasize that the League never supports or opposes candidates or parties, but that it is political and takes positions on issues after thorough study and consensus.

Each Local League interviews only state legislators serving its members. There are members of the League of Women Voters of Orange Coast (a.k.a. Coast) living in the following state Senate and Assembly and Senate districts:

- CA State Senate: 34, 36 and 37
- CA State Assembly: 68, 72, 73 and 74.

We share some of those districts with our sister Leagues in Orange County and San Diego County – and work out who interviews which legislators among the various Leagues.

This year there are three questions dealing with specific legislative arenas in which the League of Women Voters of California is interested and active:

- State and Local Redistricting;
- Public Education Closing the Achievement Gap; and
 - Water Resources
- A fourth question asks about the legislator's own priorities and Local Leagues such a Coast may also ask one question of their own our League has yet to determine if we would like to ask a local question.

League of Women Voters of California: Update

Diversity, Equity & Inclusion (DEI): The LWVC board is committed to expanding the representation in League leadership in California. As part of this, we <u>spend</u> part of each board meeting discussing an article or book about diversity, equity, and inclusion. At this past meeting, our meeting was based on <u>White Fragility</u> by Robin DiAngelo. You'll find some other suggestions for reading material <u>here.</u>

Diversity and equity can be difficult discussions. It's difficult to hear that, despite best intentions, our actions have caused hurt or harm to others. Keeping ourselves open to hearing what others have to say, listening to a wide variety of voices, and, most of all, being willing to admit our own fallibility and need to change, is essential to making the changes we need to make.

A reminder of why we're talking about this – what our ultimate goal is – from a social media post from Rabbi Danya Ruttenberg: "We need diverse representation not only so every kid can see themselves as the hero of the story, but so that every kid can understand that **other** kinds of kids are **also** the heroes of the story."

LWVC Convention: Mark your calendars now for the <u>LWVC convention</u>, May 31-June 2 in Pasadena, registration begins March 1, 2019. A few quick reminders:

- Leagues are all encouraged to <u>send</u> a full delegation, and especially to try to send a delegation that is more representative of your community
- make sure your League's voice is heard in the Program Planning process
- think about applying for one of the <u>convention awards</u>

U.S. Census 2020: The 2020 census is getting a lot of attention. It's critical to get an accurate count of everyone for a variety of reasons – redistricting and apportionment of seats in the House of Representatives, the allocation of money from a wide variety of federal programs. Every county in California should have a <u>"complete count" committee</u>. Local Leagues are encouraged to participate in these to help ensure that every Californian is counted in 2020.

The 1990 Census undercounted California's population by 2.74 percent (about 835,000 people), which was disproportionately worse than the national undercount of 1.59 percent. The Legislative Analyst's Office has issued a report that evaluates how the state may be impacted by an undercount in 2020, and is available using the following link:
